Fiscal Year (FY) 2023-2024 August 2023 Monthly Summary

Detention

- August 2023 statewide monthly detention Average Daily Population (ADP) was 183.5, a 2.1% increase compared to July (179.7). Year-to-date (YTD), detention ADP was 181.1, an 11.1% increase from August 2022 (163.0).
 - o August's ADP of 183.5 represents 85.3% of the statutory detention bed capacity limit of 215.
 - The maximum count for August 2023 was 197, or 91.6% of the 215-bed capacity limit. YTD, the statewide maximum daily count was 198 which is an 11.2% increase compared to August 2022 (n = 178; 82.8%).
- When examined by maximum daily count data, five of the eight (62.5%) youth centers have operated at or above 100% capacity during Fiscal Year (FY) 2023-24.
- There were 270 youth admitted to detention in August, which is a 13.9% increase compared to July (237). YTD, there were 507 youth admitted to detention, which is a 2.2% increase compared to August 2022 (496).
 - o YTD, four (18.2%) of 22 Judicial Districts (JDs) have operated over capacity, when examined by ADP:
 - Southern Region: 4th JD (118.9%; Cap: 27), 10th JD (129.6%; Cap: 10), 12th JD (103.4%; Cap: 2)
 - Western Region: 21st JD (133.9%; Cap: 8)
- On average, youth released this FY have experienced a Detention Length of Stay of 19.4 days, which is 1.5 days shorter compared to August 2022 (20.9 days).

Commitment


- August 2023 statewide monthly commitment ADP was 257.8, a 1.8% decrease compared to July (262.7). YTD, commitment ADP was 261.5, a 2.8% decrease from August 2022 (269.0).
- State Secure YSCs have operated at 83.6% of capacity through August, a 2.3% decrease compared to August 2022 (85.9%). YTD, two out of nine youth centers (22.2%) operated over capacity: Golden Peak (109.8%, Cap: 20) and Grand Mesa (144.1%, Cap: 23).
- YTD, Staff Supervised ADP was 13.2, which is a 4.8% increase compared to August 2022 (12.6).
- YTD, Community Residential ADP was 11.6, which is a 25.2% decrease compared to August 2022 (15.5).
- There were 18 new commitments in August, a 5.9% increase compared to July (17). YTD, there were 35 new commitments, a 6.1% increase compared to August 2022 (33).
- On average, youth discharged this FY have experienced a Residential Length of Service (LOS) of 17.9 months, or roughly 9 days longer than August 2022 (17.6 months).
 - o YTD, State Secure LOS was 16.1 months, 1.3 months longer compared to August 2022 (14.8 months).
 - Of the 25 youth discharged YTD, 16 had a state secure LOS over the 10-month mark (9 of 16 youth > 20-month mark). Additionally, of the 25 discharges, 7 had special sentences: 4 AJOs, 1 VJO, and 2 repeat offenders.

Parole

- August 2023 statewide monthly parole ADP was 110.1, a 5.9% increase from July (104.0). YTD, parole ADP was 106.8, 2.2% decrease from August 2022 (109.2).
- There were 17 parole intakes in August, which is a 21.4% increase from July (14). YTD, there were 32 parole intakes, which is an 8.6% decrease from August 2022 (35).
- There were 10 youth discharged in August, which is a 9.1% decrease from July (11). YTD, there were 25 discharged, which remained unchanged from August 2022 (25).
- On average, youth discharged this FY have experienced a Parole LOS of 6.7 months, which is roughly 18 days longer compared to August 2022 (6.1 months).¹

¹ Length of Stay/Service figures should be cautiously interpreted during the first few months of a new fiscal year due to the small number of total releases/discharges. LOS figures become more reliable as the number of released/discharged youth accumulates over the course of the fiscal year.




