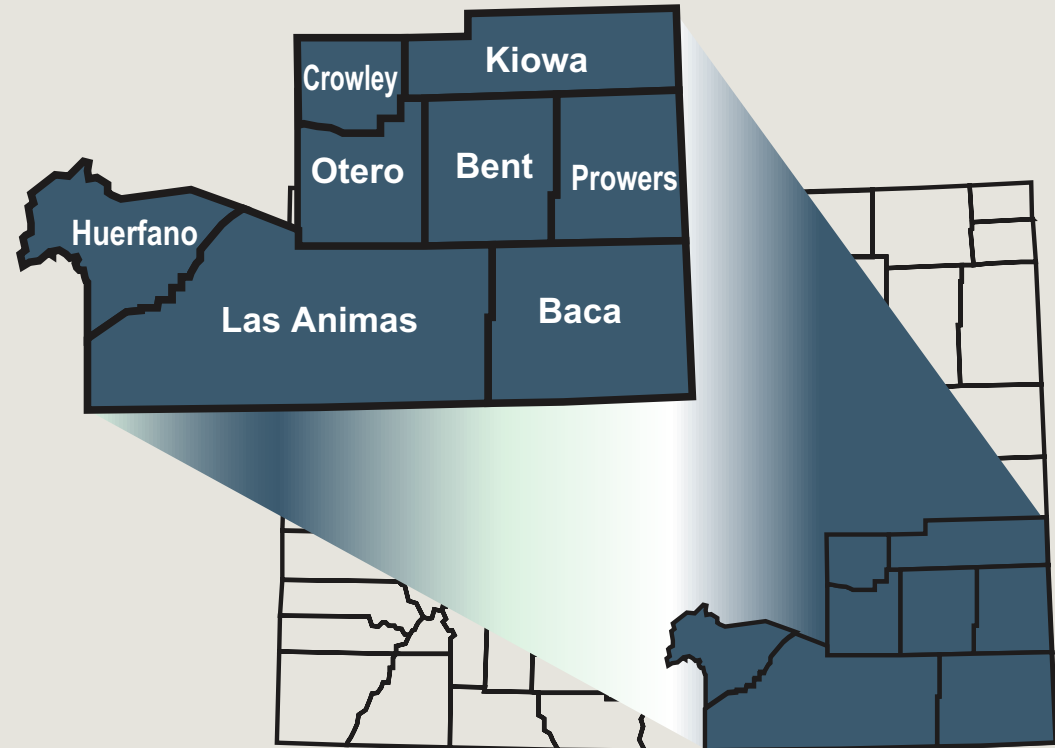

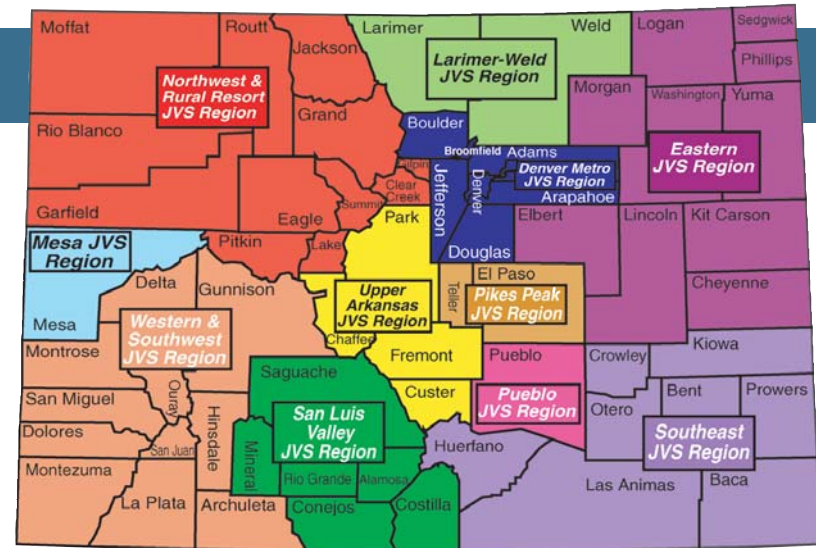

The Southeast Region Survey

The Spring 2006 Southeast Region Job Vacancy Survey (JVS) was conducted from March 14th through the 24th, 2006. The goal of the survey is to provide current information on the demand for workers. This information can serve as input into the decision making process for employers, job seekers, economic developers, educators, and workforce centers in the region.

Over the survey period, all large and government employers as well as a random sample of private employers with five or more employees were contacted. Employers were asked if they were actively hiring, and the number of positions they were seeking to fill. The Southeast Region Job Vacancy Survey is conducted twice a year to provide frequent and useful analysis of the demand for labor. This is the first time the Southeast Region survey has been done in spring.

A total of 638 employers, representing 56 percent of the region's total employment responded to the survey. Of these, 121 are government agencies, 24 are large employers and 493 are small to mid-size employers. The survey has a response rate of 82 percent. The margin of sampling error for the overall vacancy estimate is plus or minus 0.2 percent.

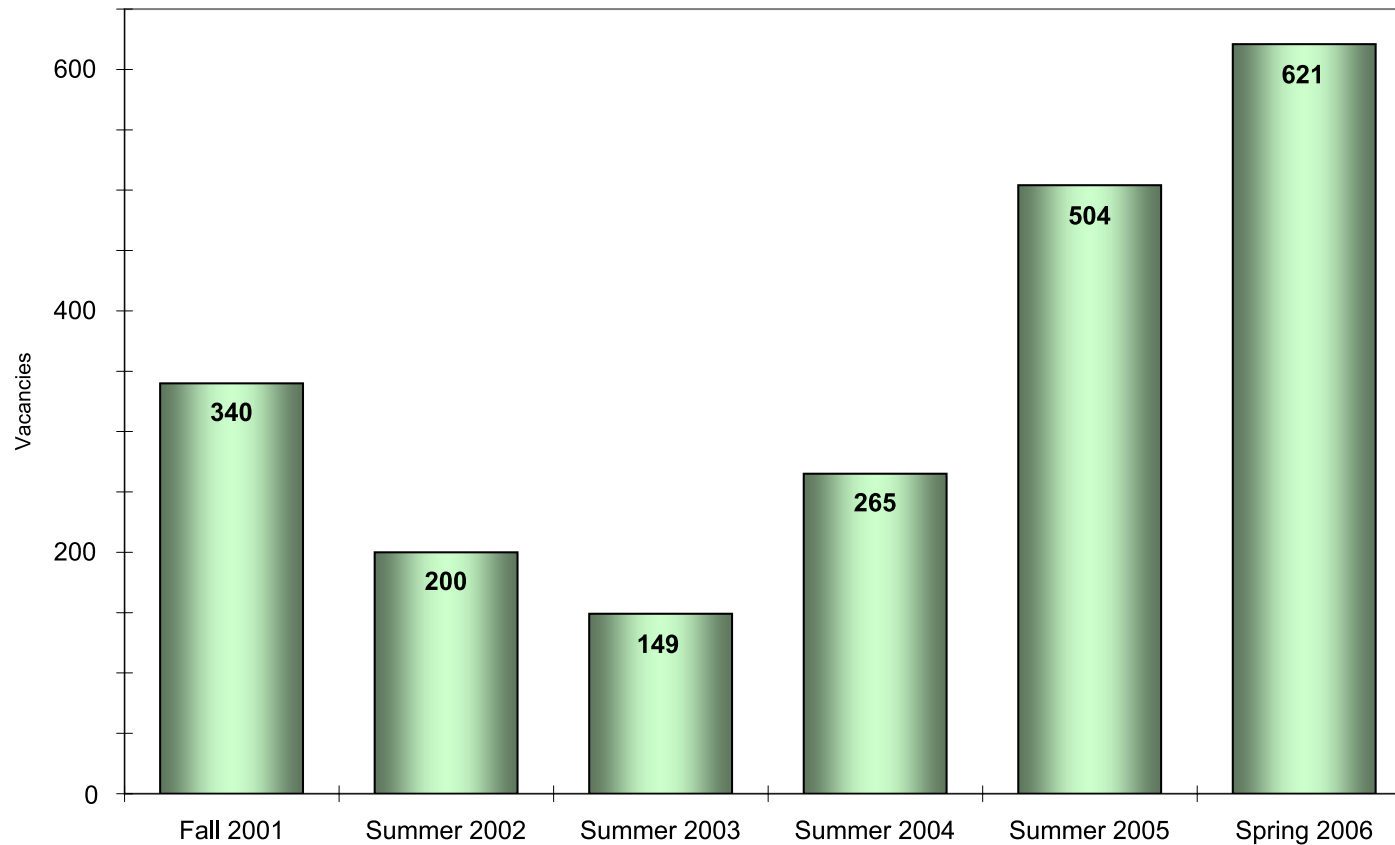


Job Vacancy Survey Regions

Findings of the Survey:

- ◆ An estimated 621 jobs were available for hire during the survey period, the most openings this region has had since the survey began in fall 2001.
- ◆ Leisure and hospitality has the highest number of estimated vacancies (152), followed by trade, transportation, utilities and other services (148) and construction, manufacturing, natural resources and mining (128).
- ◆ Small to mid-size companies provide the most vacancies with 420. However, since there are more small to mid-size firms, there are actually fewer vacancies per employer compared to large employers. There are more than 5 vacancies per large private company compared to an average of fewer than one vacancy per employer for small to mid-size firms.
- ◆ Sixteen percent of surveyed employers reported at least one job vacancy.

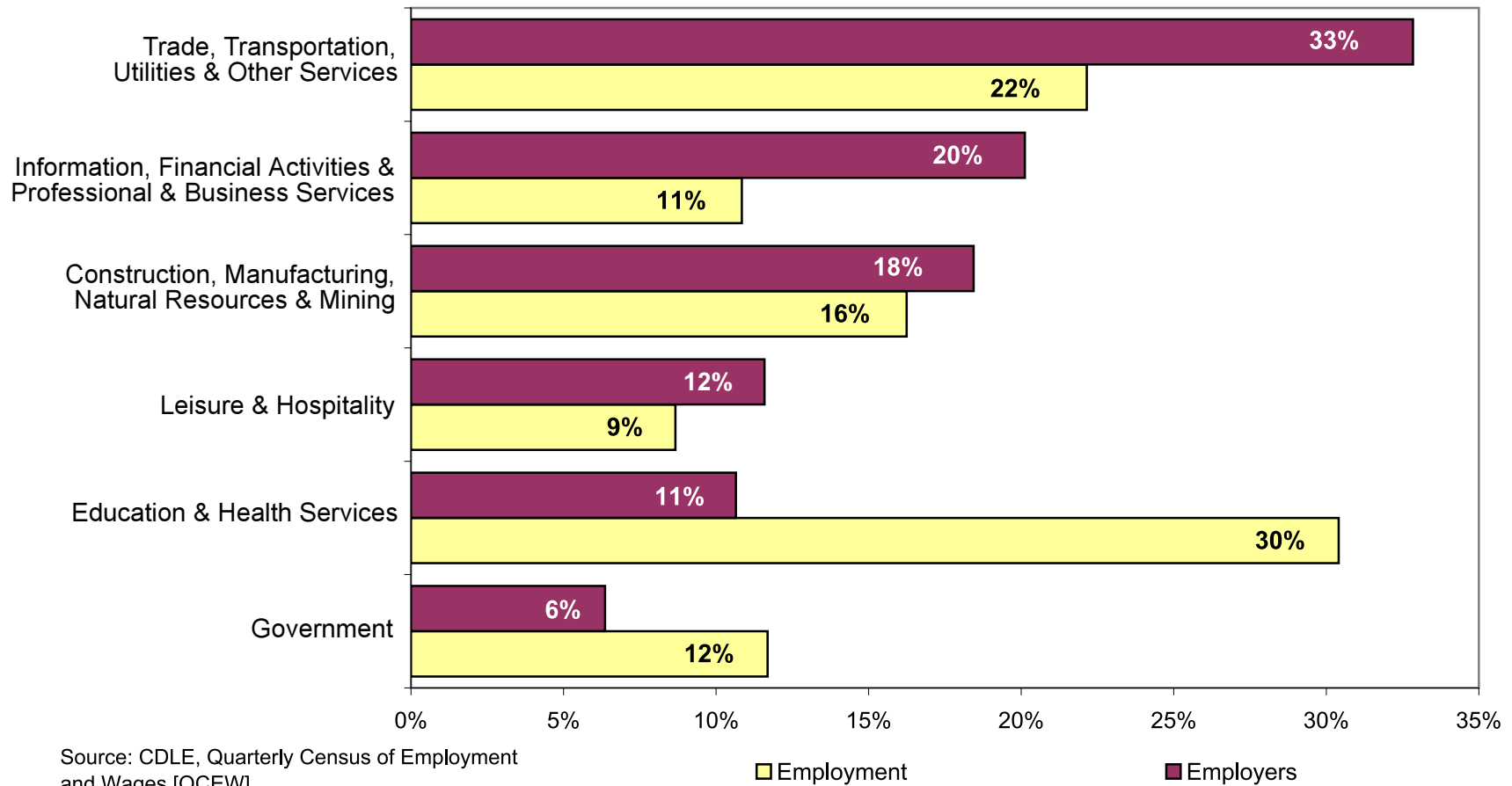

Southeast Region Employers and Employees, 1st Quarter 2005



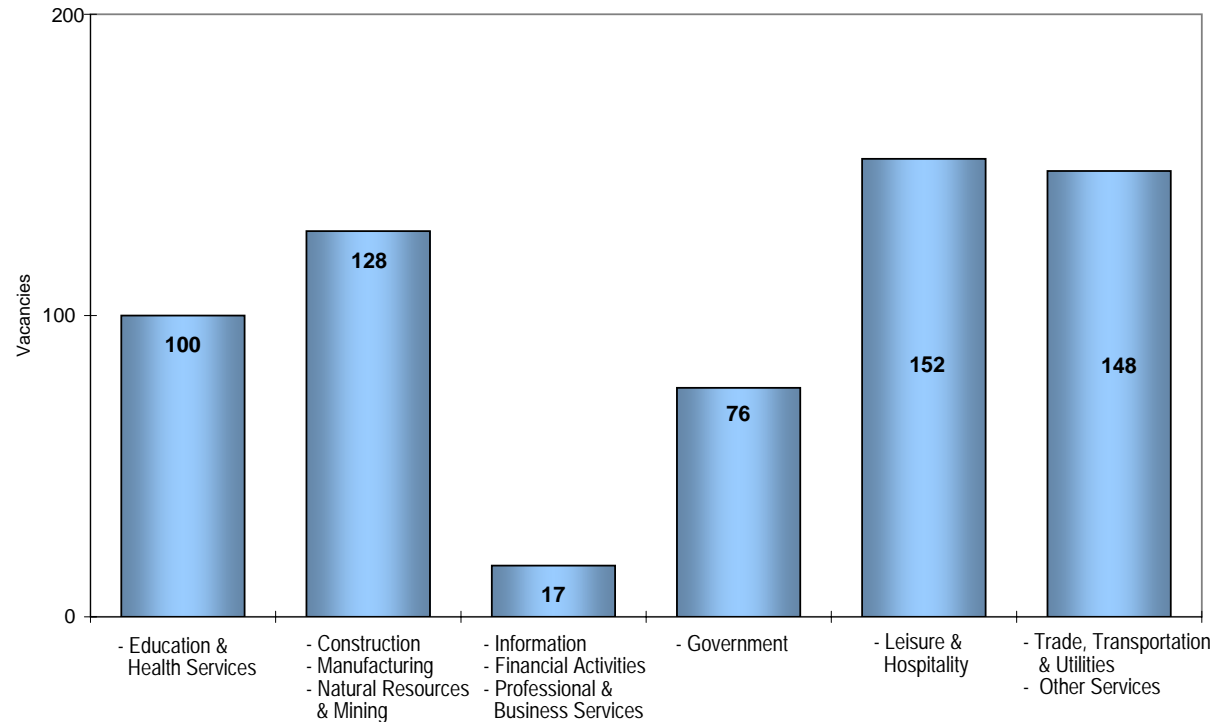
Estimated Vacancies by NAICS Supersectors

The North American Industry Classification System (NAICS) classifies organizations into different industries based upon how the organization produces goods and services. The 20 NAICS sectors have been combined into six groups of supersectors for this survey as shown in the chart on this page.

Note:

Construction, manufacturing, natural resources and mining in this survey is the same as the goods-producing JVS sector in the previous surveys.

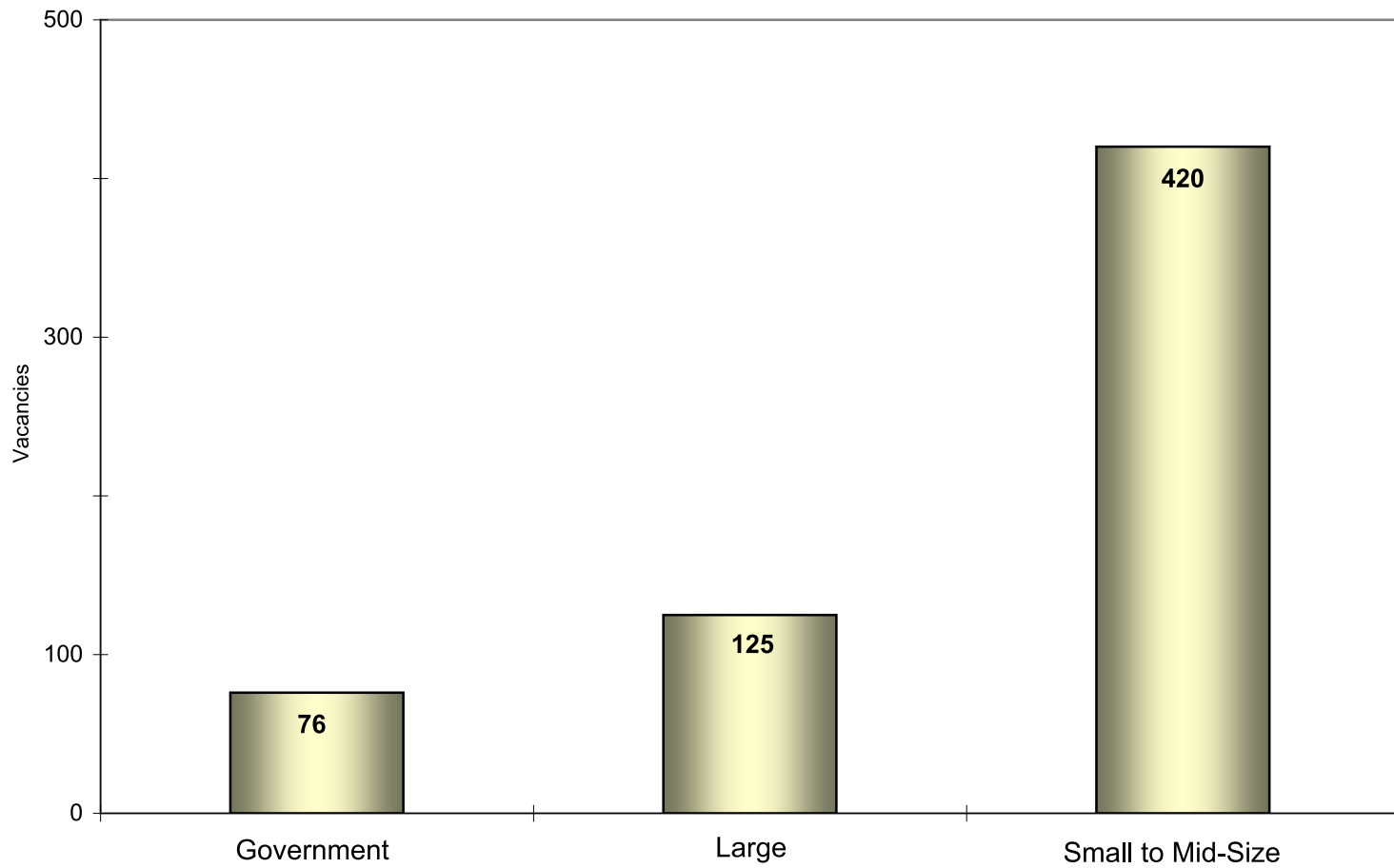
The top three supersectors in terms of estimated vacancies—leisure & hospitality, trade, transportation, utilities & other services, and construction, manufacturing, natural resources & mining—make up 69% of the Southeast Region’s job openings.
