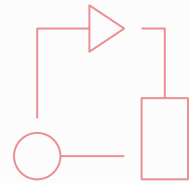
Are you searching for a new career path or looking for that perfect job?

Further education and training may be a great benefit to your career. Typically, more education results in higher weekly earnings and lower unemployment rates.

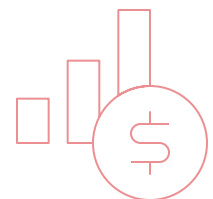
