Acknowledgements

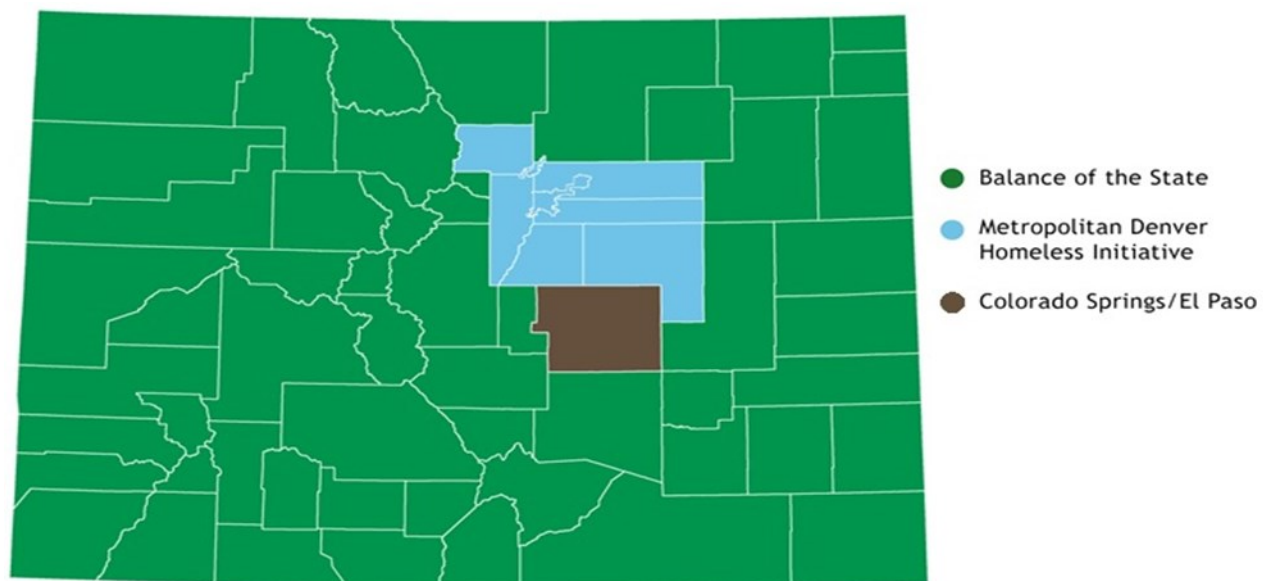
The collection of this data using the Youth Supplemental Survey (YSS) was no small task, OHYS acknowledges and appreciates the individuals, groups, and communities that made this report possible. In particular:

1. The Colorado Continuum of Care regions (CoCs) who supported the additional youth survey to be added to their existing Point in Time Count effort. Having the foundation in place to conduct the Point in Time Count is an invaluable tool for collecting this data.

PURPOSE

Opening Doors, the Federal Strategic Plan to Prevent and End Homelessness, set a goal of ending youth homelessness by 2020, a goal Colorado has adopted. The Point in Time (PIT) data is one measure that helps gauge progress towards the ambitious goal. This report is a summary and analysis of a Supplemental Youth Count conducted throughout Colorado in conjunction with the annual PIT. The PIT is a required survey by the United States Department of Housing and Urban Development (HUD). It is a point-in-time survey to create an estimated count of every person experiencing homelessness on one date each year. Nationally, HUD identifies communities through CoCs. Colorado is comprised of three CoCs: Balance of State (56 counties), El Paso County (1 county), and Metropolitan Denver Homeless Initiative (7 counties). The following map provides a visual of Colorado broken up into CoCs.



PIT is a valuable tool that provides nationwide data on the number of people experiencing homelessness on an annual basis. However, like many tools used to collect data, PIT does not provide a complete picture of housing insecurity in the United States. Specifically, PIT is a count of individuals experiencing homelessness per HUD's definition of literal homelessness, and therefore does not include people living in overcrowded situations or other forms of housing insecurity¹. In addition, as the name implies, the count is conducted at a single point in time compared to other methods of estimating need over a longer period of time. Many factors impact each community's count results, including incentives for taking surveys, having individuals experiencing homelessness assist with planning, preparation, data reporting methods, and weather. Nevertheless, this practice has been conducted since 2005 and provides comparable annual data. At the end of each year, HUD publishes the Annual Homeless Assessment Report to Congress (AHAR) using PIT data from across the country. This reporting combines count data from every CoC to analyze and share homelessness trends and data.

¹ Individual or family who lacks a fixed, regular, and adequate nighttime residence, (i) Has a primary nighttime residence that is a public or private place not meant for human habitation; (ii) Is living in a publicly or privately operated shelter. (i.e. this would not include anyone doubled up, couch surfing or currently in an institution).

This report, created by OHYS, is not intended to match the data presented within the AHAR, as this report includes youth beyond the HUD's PIT homeless definition. Therefore, this report should be seen as a compliment to the AHAR to provide more information regarding youth experiencing homelessness in Colorado.

METHODOLOGY

As previously mentioned, CoCs are required to conduct a PIT Count every year; however, the type of count differs based on 'Even Years' and 'Odd Years'. 'Even Years,' such as 2018 (as reflected in this report), are only required to be a count of every person experiencing homelessness staying in a shelter or other eligible housing program, this is often referred to as a Sheltered Count. 'Odd Years,' such as 2017 (as reflected in the inaugural report), are counts often referred to as an Unsheltered Count and include all persons experiencing literal homelessness. Some communities conduct an unsheltered count every year and some communities follow the sheltered and unsheltered count guidance. Conducting an unsheltered count takes extensive resources, planning, and volunteer base, and therefore is often not feasible for many communities to complete every year. As a result, it is important to note that this may have an impact on data variation between reports.

A key step to conducting the YSS is coordinating with each CoC to incorporate the additional survey into the CoC's broader PIT process. As previously noted, it would not have been possible to capture the additional data without leveraging the existing CoC PIT infrastructure. The additional youth questions were developed among OHYS, ACHY, the CoCs, and youth with lived experience. The proposed questions were reviewed by youth regarding length, clarity, edits, additions, and recommendations on survey administration details. Once the feedback was provided and edits were made, the final YSS form was given to the CoCs to add into their training material. Participating communities completed both the PIT and YSS surveys and submitted them to their CoC lead. The CoCs and OHYS coordinated data entry and sharing. Although all sites were trained on how to complete both surveys, some sites did not complete the YSS. There are many factors that contribute to not completing the YSS including: technological considerations, some sites were thought to be only composed of adult residents/respondents and therefore were not prepared to survey a youth (someone under 25), and some sites are simply too large for the added survey. The below chart shows the data that corresponds with the types of data received.

DATA TYPES

In total, OHSY received 586 surveys.

For the following report, the number of responses per question varied. Below is a description of each survey and the type of data collected within each:

HUD-Required Survey:

The HUD-Required Survey focuses primarily on demographic information in addition to housing status. The information collected includes: location slept, gender, age, race/ethnicity, and presence of a disability. This survey also asks about life experience related to veteran status and domestic violence. The majority of youth respondents completed at least this survey. 317 respondents completed this survey only.

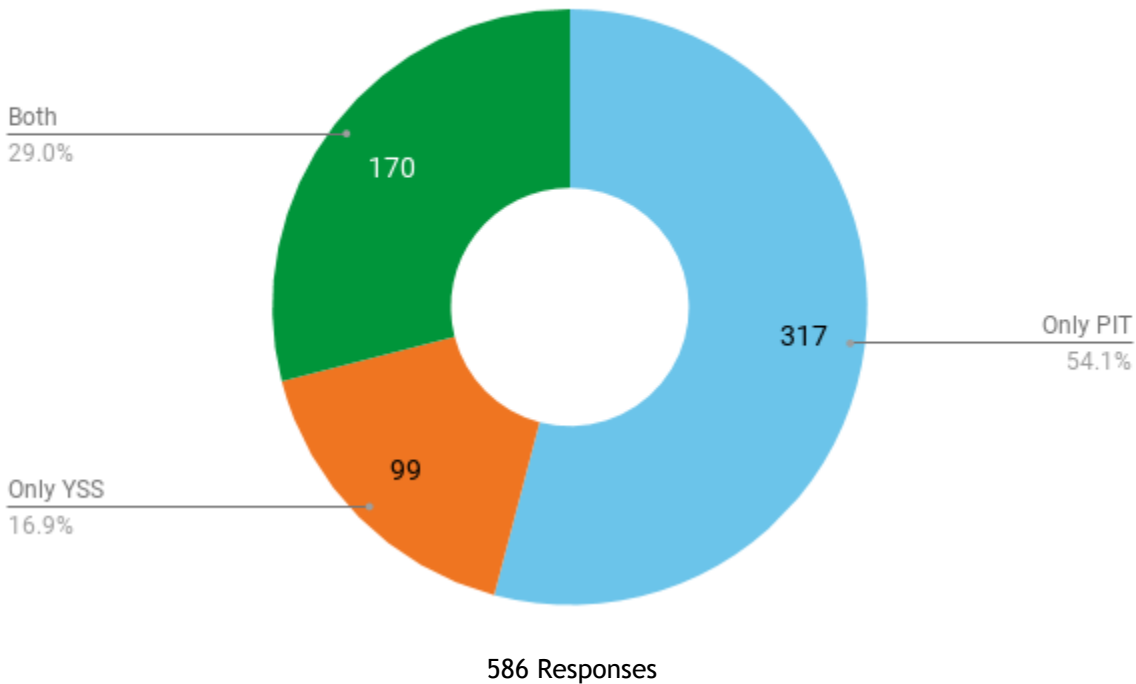
Youth Supplemental Survey:

The YSS was not required, but was encouraged to be administered to anyone under the age of 25. The information collected by this survey includes: systems involvement, age at first homelessness episode, if the respondent is responsible for minors, education and highest educational level, barriers, and if the respondent is currently earning money. 99 respondents completed this survey only.

Both Surveys:

KEY SUMMARY OF IDEAS

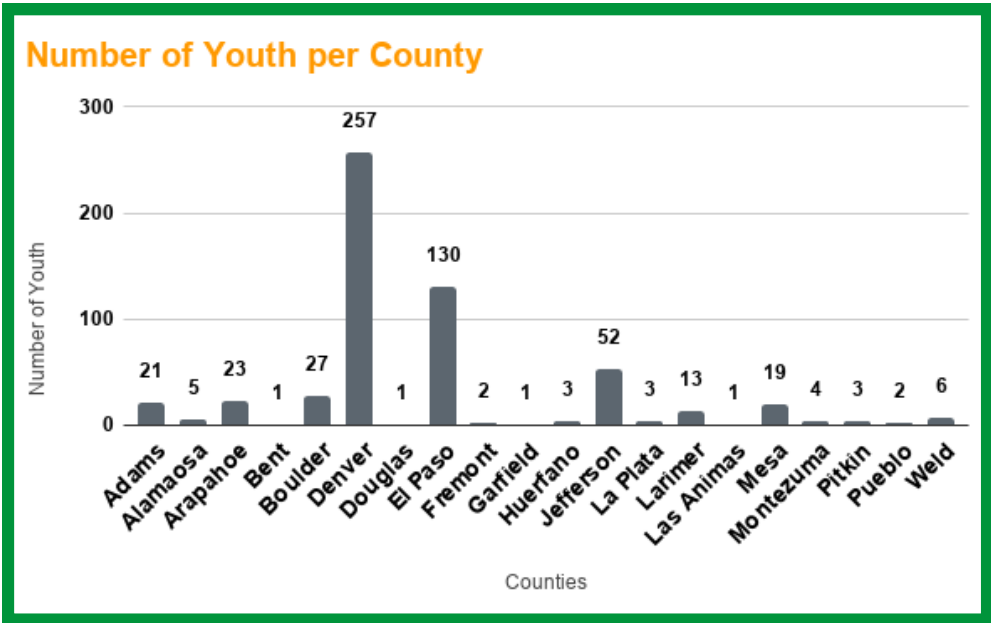
- Access to affordable housing continues to be the main barrier for youth experiencing homelessness. When asked what issues youth had faced in trying to access housing, the number one response was affordable housing (54.3% of youth responded with this barrier). Furthermore, of the 74 youth that only reported one barrier to accessing services, 31% (22 youth) said the lack of affordable housing was the only barrier they faced. This barrier is statewide, the 22 youth who responded that affordable housing was their only issue were living in eight counties across Colorado.
 - OHYS recommends exploring the potential to increase housing affordability by increasing the availability of shared housing opportunities and other innovative best practices for creating affordability.
- Similar to last year, youth of color, namely American Indian, Black, and Multiple Races, continue to be overrepresented in the homeless youth population.
 - OHYS recommends expanding the number of youth, especially those of diverse races and cultures to serve on committees, boards, or other decision making groups to help reduce the overrepresentation by guiding program implementation to be more inclusive and effective for all.
- United States Interagency Council on Homelessness (USICH) states a major factor to ending youth homelessness is the presence of a permanent connection, such as ongoing attachments to families, communities, schools, and other positive social networks. On the YSS, youth were asked “If you had a serious problem, do you know a trusted adult that you could go to for help?” The majority of youth that responded indicated they did have a trusted adult. However, the majority stated that person was a paid professional. While it is a positive that youth do feel that staff is available to help them, the role of that person is not considered to be a “permanent connection” by USICH.
 - OHYS recommends developing or increasing programs dedicated to teaching youth how to identify and build social capital and supporting the creation of those connections.
- The majority of youth respondents to this survey are not only from Colorado, but are also in the same community as their last stable housing. In other words, youth experiencing homelessness are less mobile than previously perceived. In addition, a minimum of 28 youth who were counted in 2018 were also counted in 2017 and listed they slept outside. Of the youth for whom we had multiple years of data to identify mobility, 50% are experiencing homelessness in the same community in which they were last in stable housing.
 - OHYS recommends identifying peers and other local supports for youth to regain or create community connections.

GET INVOLVED

Please join the statewide effort to identify every youth experiencing homelessness by participating in the annual HUD PIT Count and Youth Supplemental Count. Each survey gives a youth a voice and helps improve the community for other youth struggling to secure housing. This is especially important for service providers outside of housing specifically, because youth often disclose housing instability to a trusted adult rather than seek services. 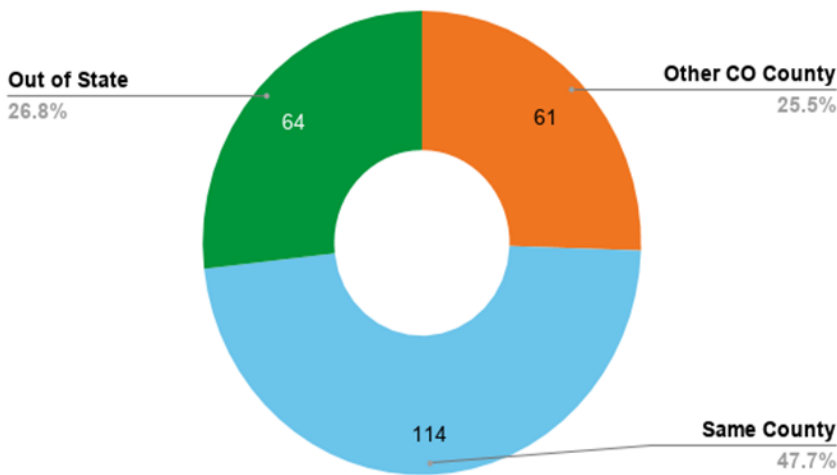

Youth are often described as highly mobile or transient. This chart demonstrates movement during homelessness.

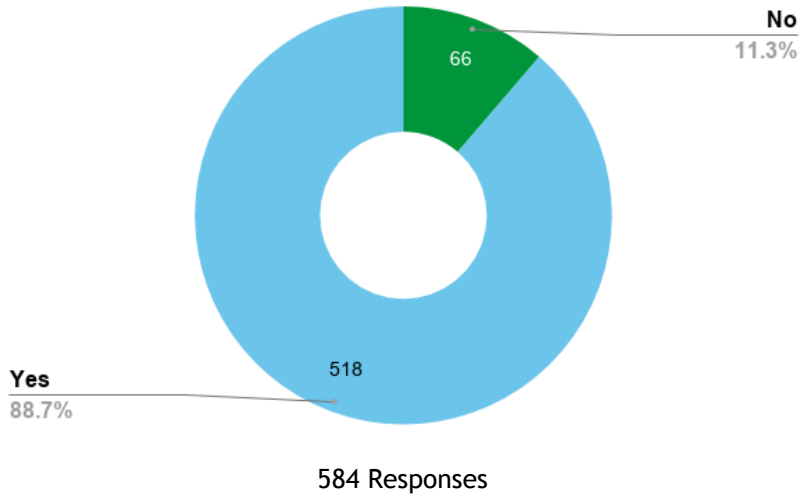
74% of youth reported last stable housing within Colorado.

DEFINITION

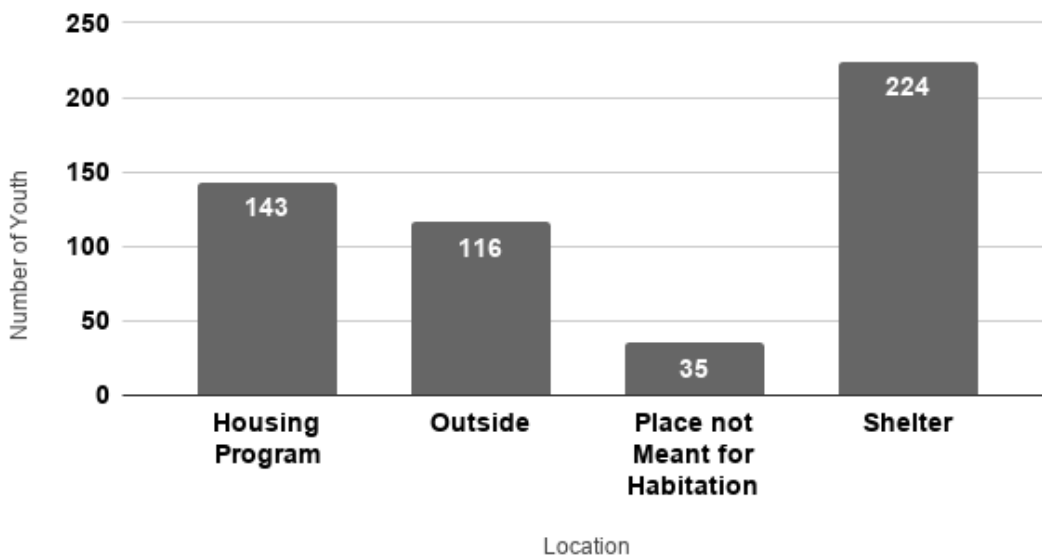
HUD uses a narrow definition of homelessness (see page 3). For the purposes of the YSS, the definition was broadened to capture data about individuals that are couch surfing.

These youth will not be reported to HUD for the youth homelessness baseline, but this data still tells an important story about youth homelessness in Colorado. As a result of these two definitions, along with other reasons described in the methodology section, these numbers will differ from the report generated by HUD.

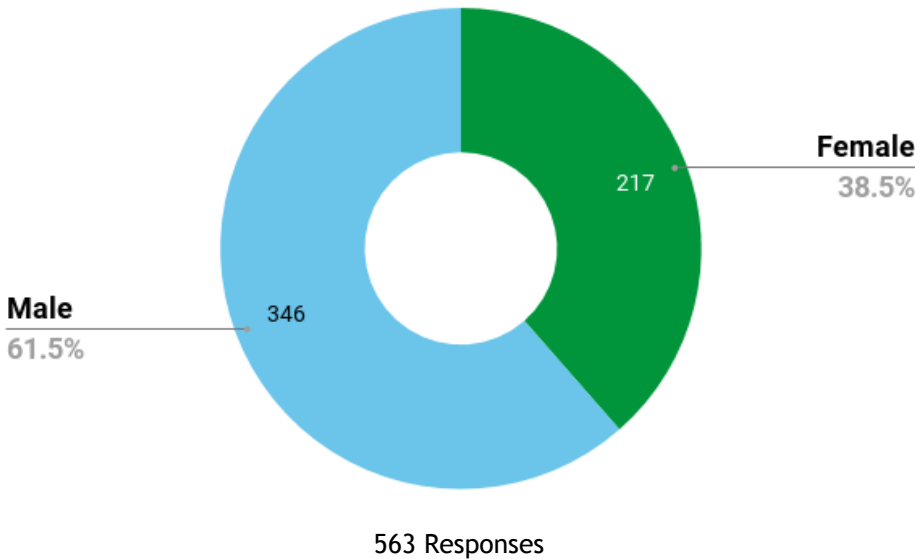

Majority Gender Identities

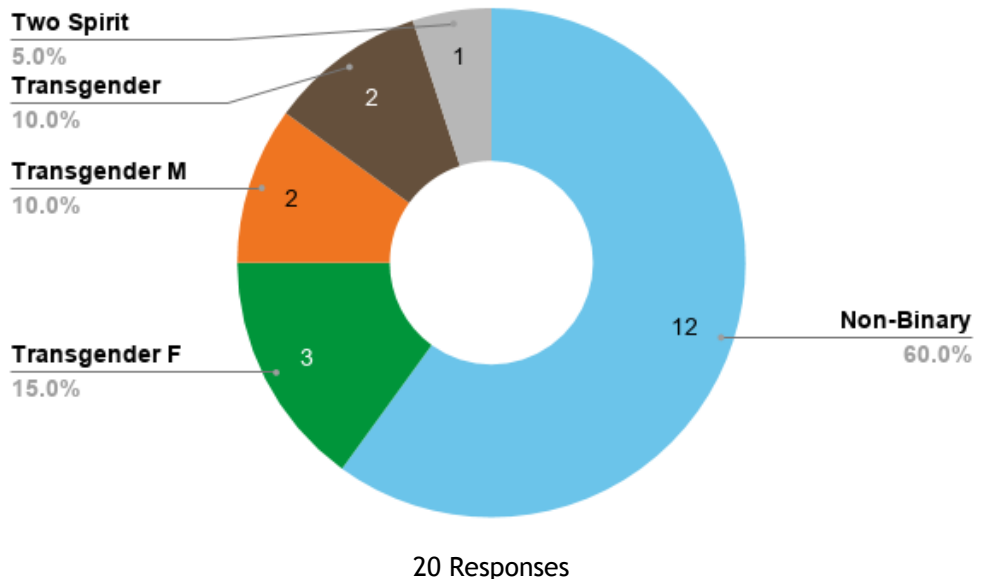


Gender identity is a factor that is gaining notoriety as a contributing factor to the experience of homelessness.

Minority Gender Identities

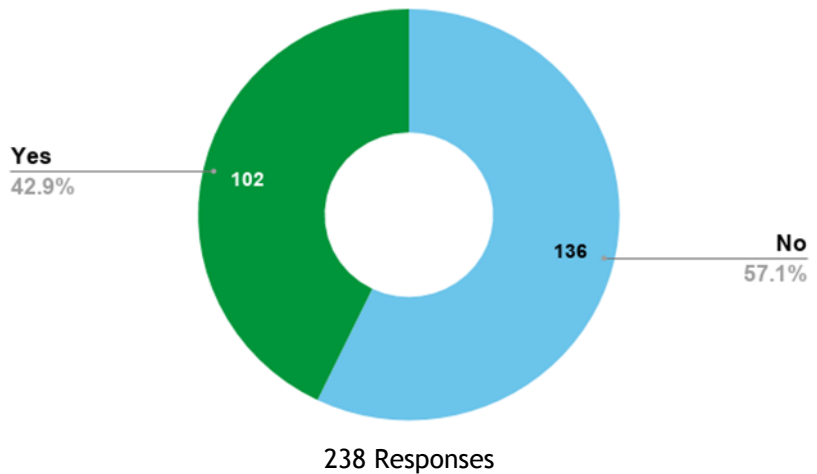


LIFE EXPERIENCES

Foster Care Involvement

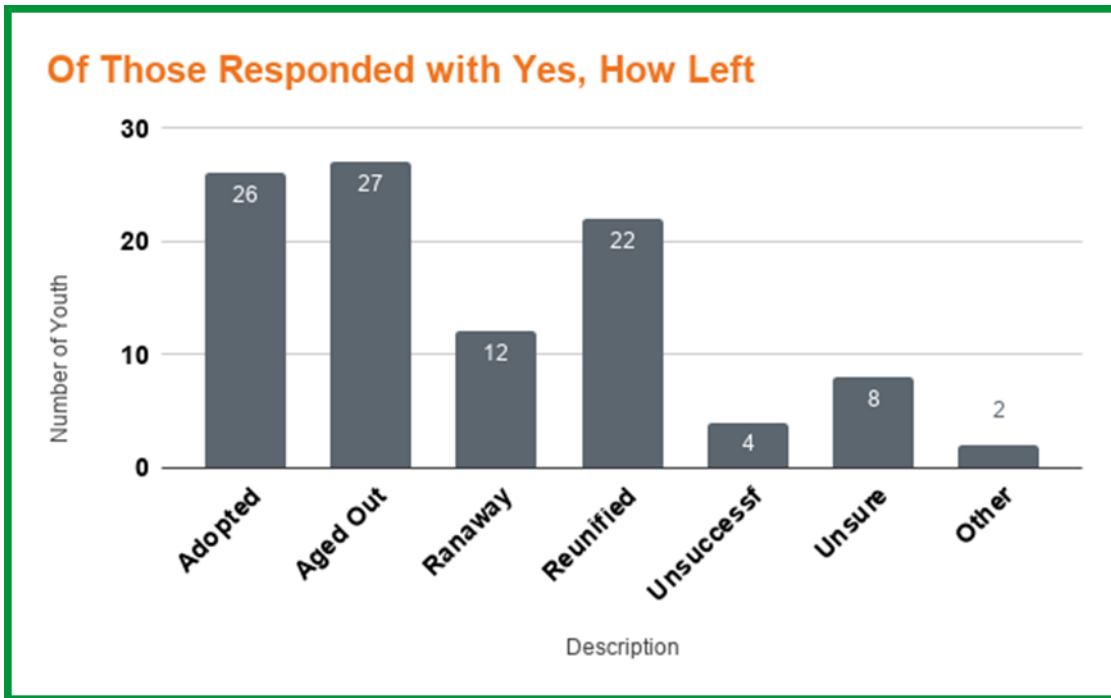
In the 2017 report, it was identified that youth with previous foster care experience were significantly over represented in the homeless population. This fact has remained true in 2018.

An unfavorable exit is categorized as “aged out”, “ranaway”, and “unsuccessful”. Unfavorable exits represent 47% of all exits.

This may mean that exit type may not have as much of an impact or predictability of homelessness as overall involvement with foster care.

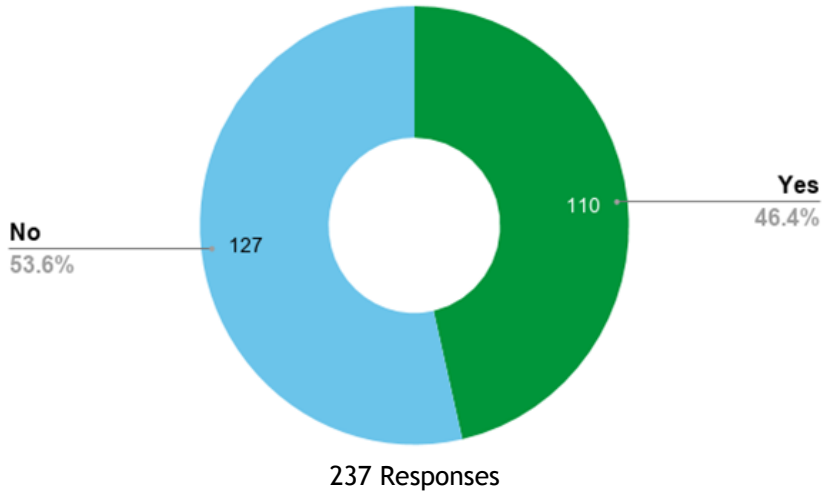

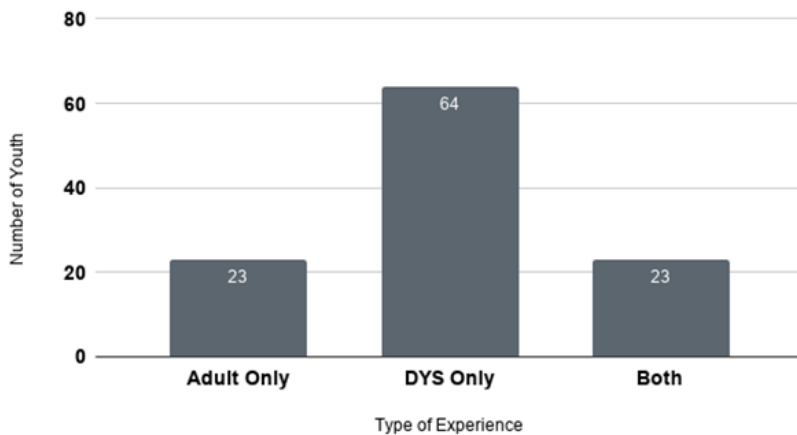
Corrections Experience

Corrections Experience



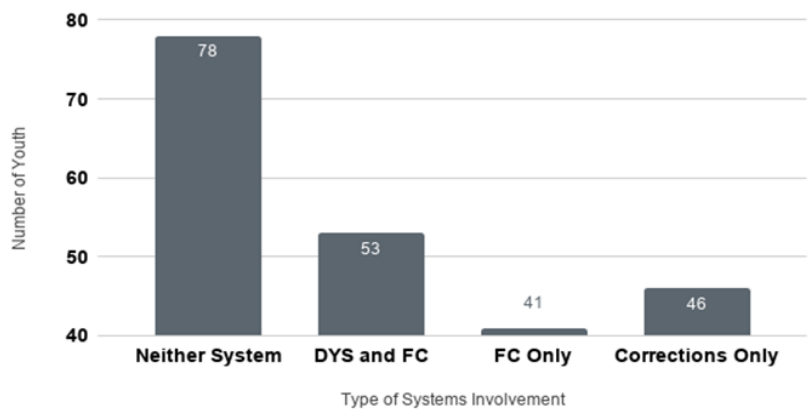
If Yes, Type of Experience

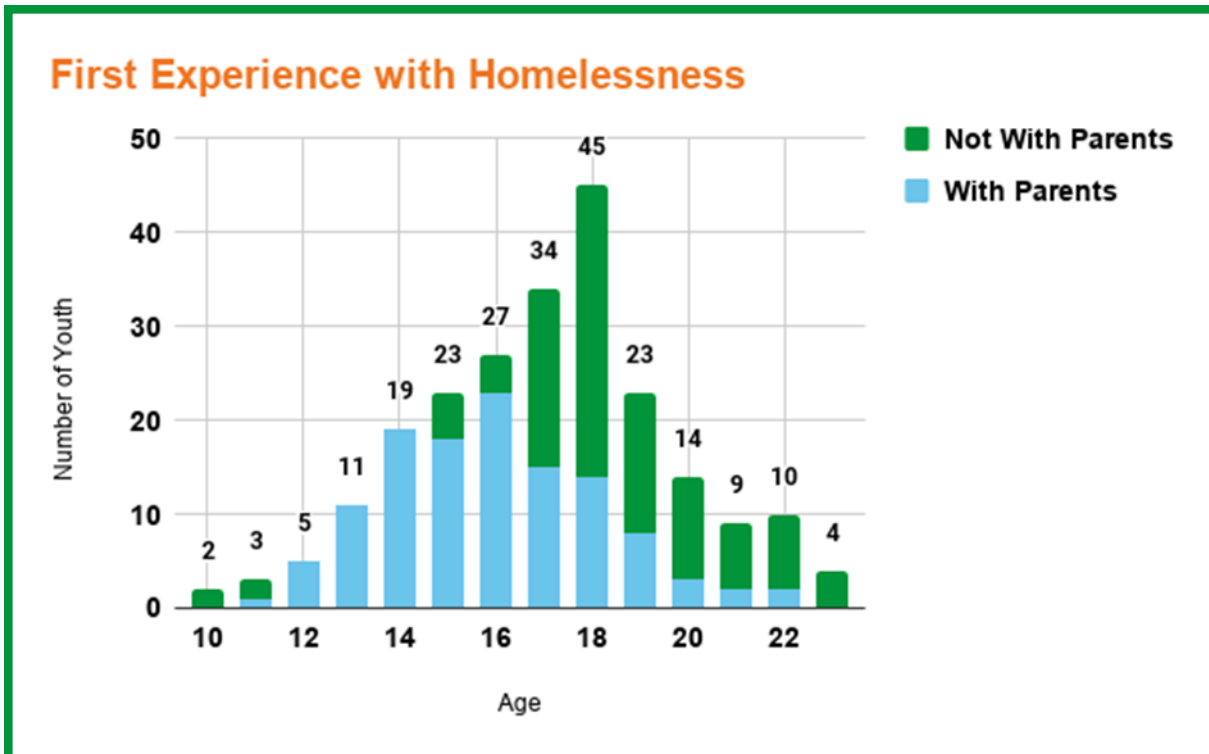
First Experience with Homelessness

The youngest respondent whose first experience with homelessness without a parent or guardian was 10 years old. This chart demonstrates the older a youth is when they first experience homelessness, the less likely they are to have been with a parent or guardian.

83% of respondents were older at time of survey than what they reported their age to be at their first experience of homelessness, indicating either a long length of homelessness or multiple episodes. Furthermore, at least 40 youth were identified in both 2017 and 2018, and of those 40:

- 24 were outside
- 7 were in shelters
- 5 were in a housing program
- 4 were in a place not meant for human habitation

Of the 19 youth that responded to the question about barriers, 15 stated having three or more barriers.

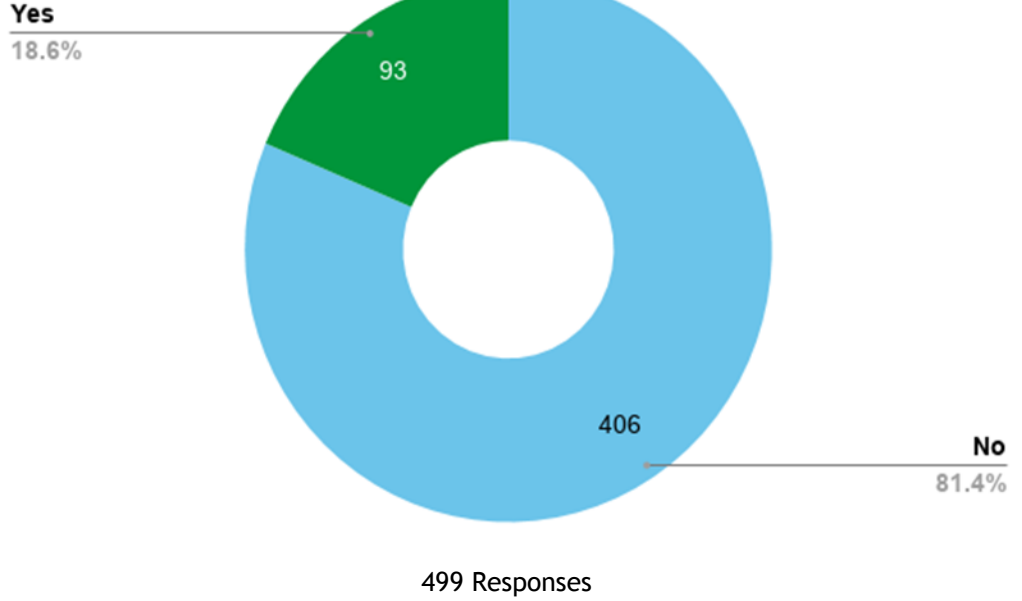

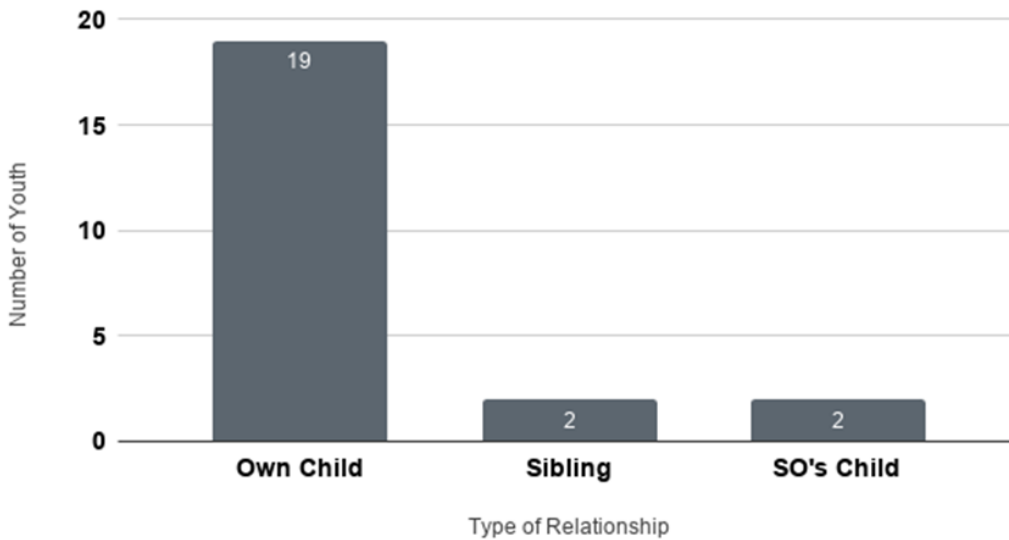

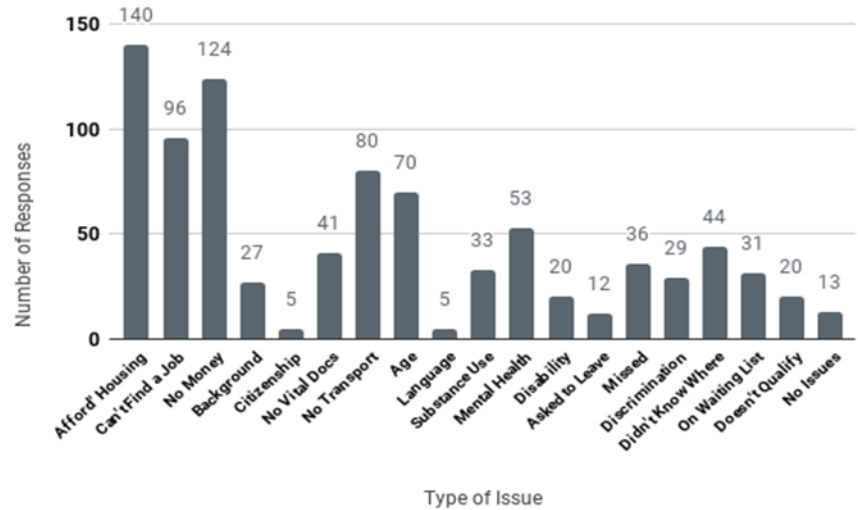


Barriers Faced

When asked about barriers to accessing services, the top five barriers were:

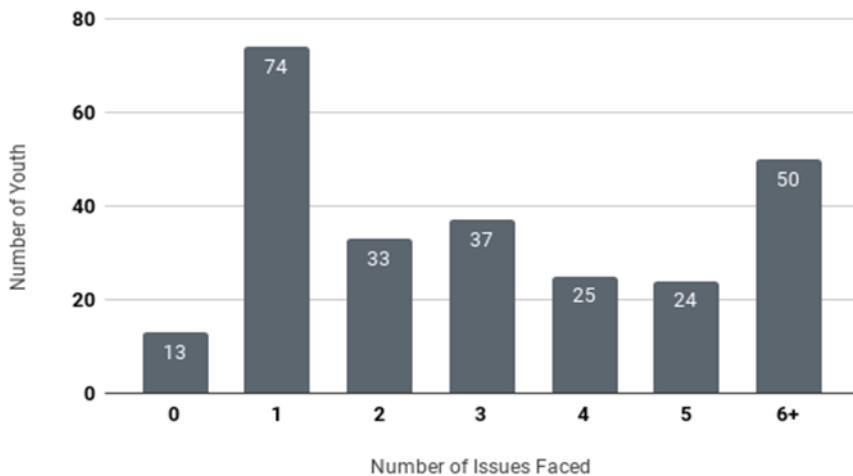

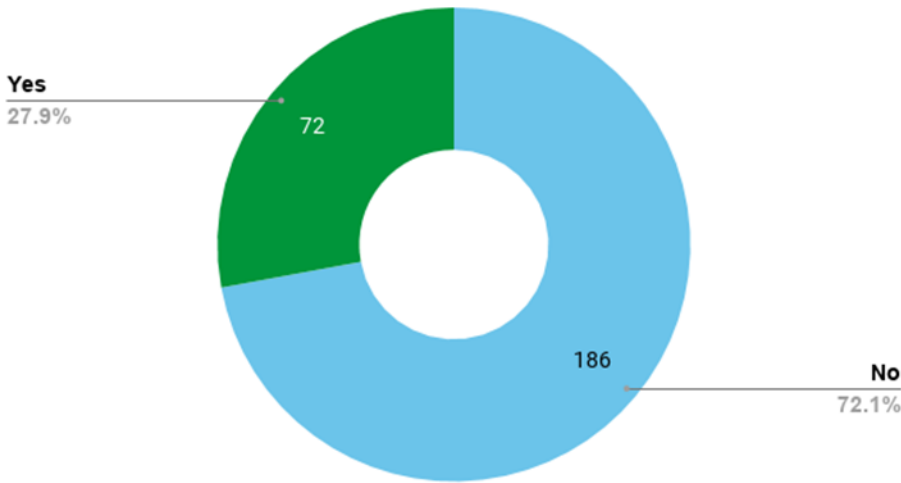

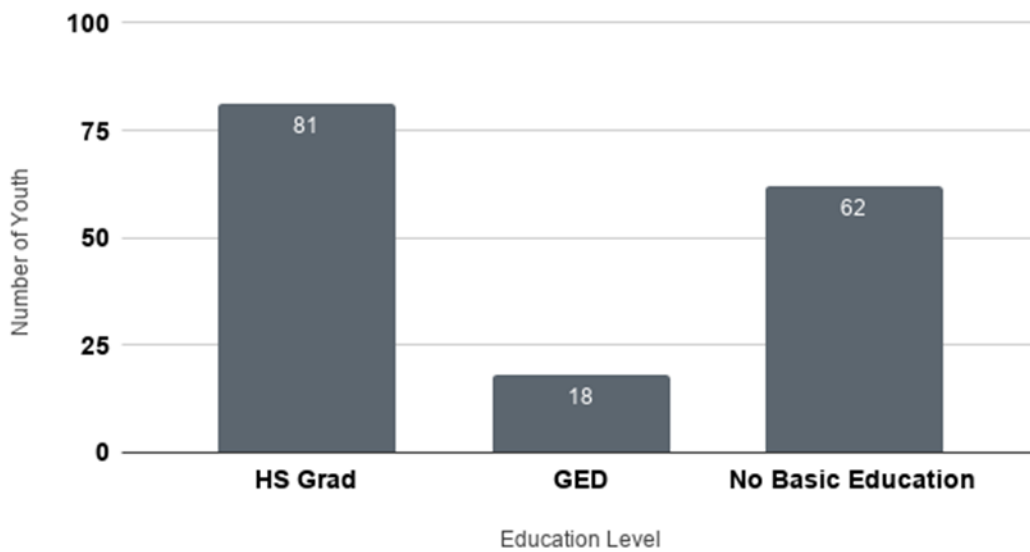
Youth Currently in School

Of Those Not Currently In School

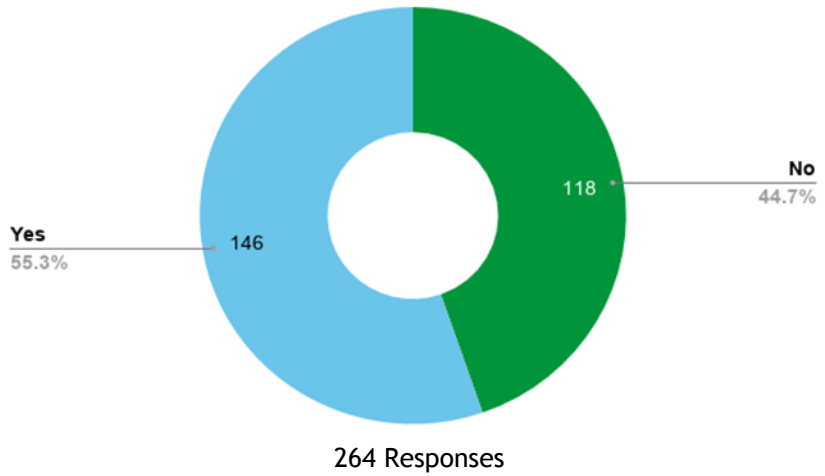

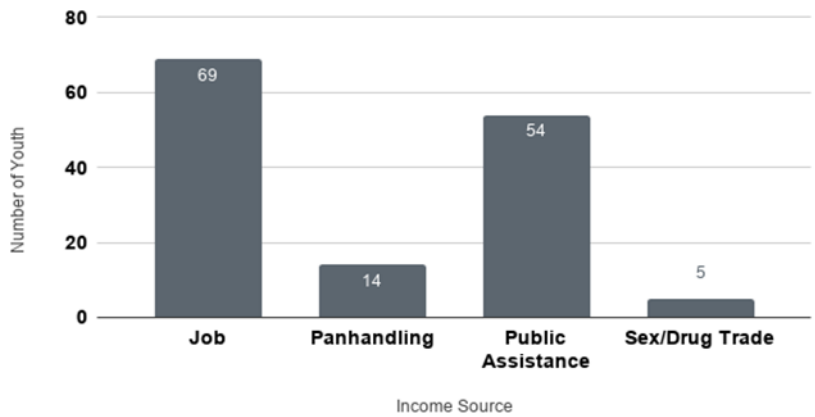

Youth With Income



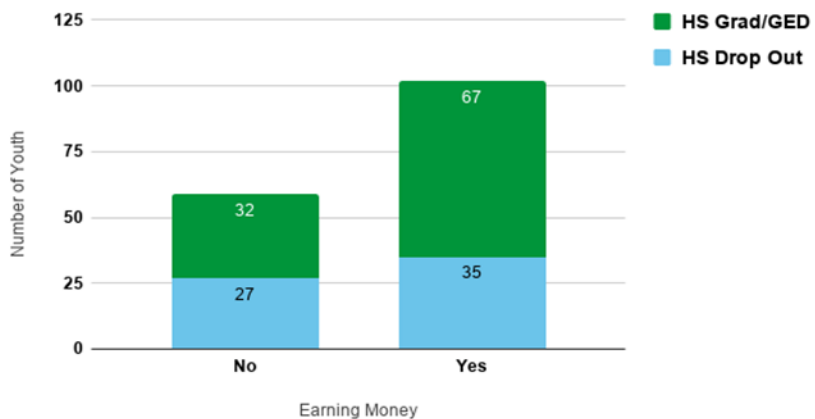
Type of Income
