Compliance Report Pursuant to C.R.S. 24-76.5-101 et seq.

The Department of Local Affairs (DOLA) administered various grants for the year ending June 30, 2007, which may provide certain public benefits to end users. However, the majority of state and federal grants administered by DOLA are issued to units of government or corporations and not directly to individuals.

Division of Emergency Management (DEM)

The Division of Emergency Management (DEM) administered 185 grants for the year ended June 30, 2007. These grants included some of the following programs: Buffer Zone Protection Program, Citizen Corp Program, Chemical Stockpile Emergency Preparedness Program, Flood Mitigation Assistance Program, Law Enforcement Terrorism Preparedness Program, Homeland Security, Transit Security Grant Program, Urban Area Security Initiative, certain Emergency Declarations and other programs. Often times, various grant programs were accessed for a particular project. All 185 grants administered were with units of government. There were no grants administered to individuals.

Division of Housing (DOH)

The Division of Housing (DOH) administers various state and federal grant programs. The following programs were administered for the year ended June 30, 2007:

● Community Development Block Grant (CDBG)

DOH administered 18 CDBG grants for the year ended June 30, 2007 and all grants were to units of government.

● Emergency Shelter Grants (ESG)

DOH administered 53 ESG grants for the year ended June 30, 2007 and five (5) grants were to units of government and the other 49 grants were to faith-based, non-profit and corporate entities.

● Governor's Energy Office (GEO)

DOH administered one (1) GEO grant for the year ended June 30, 2007 with a state agency (Governor's Energy Office).

● Housing Development Grant (HDG)

DOH administered five (5) HDG grants for the year ended June 30, 2007; one grant was with a unit of government and the other four (4) grants were with faith-based, non-profit and corporate entities.

● HOME

DOH administered 39 HOME grants for the year ended June 30, 2007 and nine (9) grants were with units of government and the other 30 grants were with faith-based, non-profit and corporate entities.

- Revolving Loan Fund (RLF)

DOH administered two (2) RLF programs for the year ended June 30, 2007 and one (1) was with a unit of government and the other one (1) was with a corporate entity.

Division of Local Government (DLG)

The Division of Local Government (DLG) administers various state and federal grant programs. The following programs were administered for the year ended June 30, 2007:

- Community Development Block Grant (CDBG)

DLG administered nine (9) CDBG grants for the year ended June 30, 2007 and all grants were to units of government.

- Colorado Heritage Planning Grants (CHPG)

DLG administered seven (7) CHPG grants for the year ended June 30, 2007 and all grants were to units of government.

- Community Services Block Grants (CSBG)

DLG administered 45 CSBG grants for the year ended June 30, 2007 and all grants were to units of government.

- Energy Impact Assistance Funds (EIAF)

DLG administered 330 EIAF grants for the year ended June 30, 2007 and all grants were to units of government.

- State Local Government Limited Gaming Impact Fund

DLG administered 51 Local Government Limited Gaming Impact Fund grants for the year ended June 30, 2007 and all grants were to units of government.

- State Waste Tire Disposal and Recycling Program

DLG administered 32 Waste Tire Disposal and Recycling Program grants for the year ended June 30, 2007 and all grants were to units of government.

DLG also provided funds to seven (7) companies for the End Users/Processors portion of the State Waste Tire Program for the year ended June 30, 2007. All seven (7) companies were corporations.

None of the state or federal grants and/or funding programs administered by the Department of Local Affairs was issued to individuals.
