Compliance Report Pursuant to C.R.S. 24-76.5-101 et seq.

The Department of Local Affairs (DOLA) administered various grants for the year ending June 30, 2010; some of which may provide certain public benefits to end users. However, the majority of state and federal grants administered by DOLA are issued to units of government or corporations and not directly to individuals to whom these regulations apply.

Division of Local Government (DLG)

The Division of Local Government (DLG) administers various state and federal grant programs. The following programs were administered for the year ended June 30, 2010.

- Community Development Block Grant (CDBG)
DLG administered sixteen (16) CDBG grants for the year ended June 30, 2010 and all grants were units of local government.
- Community Services Block Grant (CSBG)
DLG administered forty-four (44) CSBG contracts for the year ended June 30, 2010 and all grants were units of local government or non-profit agencies.
- Colorado Heritage Planning Grants (CHPG)
DLG administered four (4) CHPG contracts for the year ended June 30, 2010 and all grants were to units of local government.
- Energy Impact Assistance Funds (EIAF)
DLG administered 116 (116) EIAF contracts for the year ended June 30, 2010 and all grants were to units of local government.
- State Local Government Limited Gaming Impact Fund
DLG administered 38 (38) Local Government Limited Gaming Impact Fund contracts for the year ended June 30, 2010 and all grants were to units of local government.

The state or federal grants and/or funding programs administered by the Division of Local Government are not issued to individuals.

Division of Housing (DOH)

The Division of Housing (DOH) administers various state and federal grant programs. The following programs were administered for the year ended June 30, 2010:

- Community Development Block Grant (CDBG)

DOH administered twenty-five (25) CDBG grants during the year ending June 30, 2010, all made to units of local government.

- Emergency Shelter Grants (ESG)

DOH Administered forty-seven (47) ESG grants during the year ending June 30, 2010. Five (5) grants were made to units of local government, and 42 were to non-profit organizations, of which eight were faith based.

- Housing Development Grant (HDG)

DOH administered ten (10) HDG grants during the year ending June 30, 2010, three (3) of which were to local governments and seven (7) to non-profit organizations.

- HOME

DOH administered twenty-six (26) HOME grants or loans during the year ending June 30, 2010. Nine (9) of these were made to local governments and seventeen (17) to faith-based, non-profit and corporate entities.

- Housing Opportunities for Persons with AIDS (HOPWA)

DOH administered one HOPWA grant during the year ending June 30, 2010, which was made to a non-profit corporation.

- Foreclosure Prevention Grants (FPG)

DOH administered three (3) FPG grants during the year ending June 30, 2010, all to non-profit organizations.

- Homelessness Prevention and Rapid Re-Housing Program

DOH administered three (3) HPRP grants during the year ending June 30, 2010, one (1) of which was made to a unit of local government and two a non-profit organization.

- Neighborhood Stabilization Program (NSP)

DOH administered twenty-one (21) NSP grants during the year ending June 30, 2010. Sixteen (16) of these were made to local governments and five (5) to faith-based, non-profit and corporate entities.

Division of Emergency Management (DEM)

During the period for fiscal year ending June 30, 2010, the Division again administered over 70 grants within the same programs. These grants included some of the following programs: Emergency Management Performance Grant, Pre-Disaster Mitigation Grant, Hazardous Materials Emergency Preparedness, Chemical Stockpile Emergency Preparedness Program and the Flood Mitigation Assistance Program. Often times, various grant programs were accessed for a particular project. These grants were made only to local governments, faith based organizations, and/or non-profit agencies active in disaster emergencies. There were no grants administered to individuals.

The state and federal grants administered by the Department have been done in compliance with C.R.S. 24-76.5-103.
