Compliance Report Pursuant to C.R.S. 24-76.5-101 et seq.

The Department of Local Affairs (DOLA) administered various grants for the year ending June 30, 2014; some of which may provide certain public benefits to end users. However, the majority of state and federal grants administered by DOLA are issued to units of government or corporations and not directly to individuals to whom these regulations apply.

*Division of Local Government (DLG)*

The Division of Local Government (DLG) administers various state and federal grant programs. The following programs were administered for the year ended June 30, 2014.

**Community Development Block Grant (CDBG)**

DLG administered six (6) CDBG grants for the year ended June 30, 2014 and all grants were units of local government.

**Community Services Block Grant (CSBG)**

DLG administered forty-seven (47) CSBG contracts for the year ended June 30, 2014 and all grants were units of local government or non-profit agencies.

**Colorado Heritage Planning Grants (CHPG)**

DLG did not administer any CHPG contracts for the year ended June 30, 2014.

**Energy Impact Assistance Funds (EIAF)**

DLG administered two hundred eighteen (218) EIAF contracts for the year ended June 30, 2014 and all grants were to units of local government.

**State Local Government Limited Gaming Impact Fund**

DLG administered thirty-nine (39) Local Government Limited Gaming Impact Fund contracts for the year ended June 30, 2014 and all grants were to units of local government.

The state or federal grants and/or funding programs administered by the Division of Local Government are not issued to individuals.

*Division of Housing (DOH)*

The Division of Housing (DOH) administers various state and federal grant programs. Federal housing programs are subject to federal statutes on lawful presence (the Welfare Reform Act and the Immigration and Nationality Act), and lawful presence of recipients of public benefits must be verified pursuant to the applicable law, unless specifically exempted, in which case it is not required under C.R.S. 24-76.5-103(3)(a).

The State programs listed below are subject to 24-76.5-103. DOH entered into the following contracts under each program in the year ended June 30, 2014:

Housing Development Grant (HDG). DOH executed fourteen (14) HDG grant agreements during the year ending June 30, 2014. Thirteen (13) grants were made to non-profit organizations and one (1) to a local housing authority.

Housing Development Loan Fund (HDLF). DOH executed one (1) HDLF loan agreement with a limited liability company associated with a non-profit organization during the year ending June 30, 2014.

Colorado Housing Investment Fund (CHIF). DOH executed four (4) CHIF loan agreements during the year ending June 30, 2014. Two (2) loans were made to limited liability companies, one (1) to a non-profit organization, and one (1) to a local housing authority.

The state and federal grants administered by the Department have been done in compliance with C.R.S. 24-76.5-103.
