# Severance Tax 2018 Distributions Report Per Colorado Revised Statute 39-29-110 (3)

February 1, 2019

## Summary

---

Colorado Revised Statute Title 39, Taxation, Specific Taxes, Severance Tax 39-29-110 (3) states,

“The executive director of the department of local affairs shall deliver to the state auditor and file with the general assembly annually before February 1 a detailed report accounting for the distribution of all funds for the previous year.”

In response to this statutory requirement, below are the 2018 calendar year distributions from severance dollars through discretionary grants and formulaic direct distributions. In summary, \$57,728,743.62 was distributed between January 1 and December 1, 2018.

In addition, with the passing of House Bill 16-1141 beginning State Fiscal Year 2016-2017, the Uranium Mill Tailings Remedial Action Oversight Committee was repealed. As a result, distributions from severance grant dollars that may have been reported through this Committee to the General Assembly has ceased. The Department of Local Affairs annual report will now include distribution of those funds to the Colorado Department of Public Health and Environment (CDPHE) from the Local Government Mineral and Energy Impact Grants and Disbursements line.

Between January 1 and December 1, 2018, \$599,486.39 of severance funds was distributed to CDPHE.
