EIAF Summary - Federal Mineral Lease Fund Distribution

Colorado Revised Statute Title 34, Mineral Resources, Oil and Natural Gas, Article 63 Royalties 34-63-102 (5)(c) states,

“The executive director of the department of local affairs shall deliver to the state auditor and file with the general assembly annually before February 1 a detailed report accounting for the distribution of all funds for the previous year.”

In response to this statutory requirement, below are the 2019 calendar year distributions from federal mineral lease dollars through discretionary grants and formulaic direct distributions. In summary, **\$38,430,274.00** was distributed between January 1 and December 31, 2019.
