## 2023 Annual Report - Federal Mineral Lease Fund Distribution

In accordance with Colorado Revised Statute Title 34, Mineral Resources, Oil and Natural Gas, Article 63 Royalties Under Federal Leasing 34-63-102 (5)(c) which states in part,

“The executive director of the department of local affairs shall deliver to the state auditor and file with the general assembly annually before February 1 a detailed report accounting for the distribution of all funds for the previous year. The energy impact assistance advisory committee shall review the report prior to it being delivered and filed.”

The Colorado Department of Local Affairs (DOLA) hereby submits the aforementioned report for calendar year 2023 in response to this statutory requirement. Below are the 2023 calendar year distributions from federal mineral lease dollars through discretionary grants and formulaic direct distributions. In summary, **\$62,845,713.35** was distributed between January 1 and December 31, 2023.
