In this, my second Biennial Report as The Adjutant General of Colorado, there appears to be little need for me to mention many of the activities of the Military Department or the troops of the Colorado National Guard now in Active Military Service of the United States. However, it is deemed pertinent and proper to invite attention to certain items believed to be of more than passing interest to every citizen of the State.

To begin with, I wish to state that the "Pay-As-You-Go" basis established in my first administration has been consistently followed through to this time, and I am happy to report that the Military Department is not in debt, and we have some money laid away for the proberbial "Rainy Day" as will be seen by the tabulated financial statement herewith.

As is well known, under Presidential Order, the remainder of our National Guard Troops were called to Active Military Service of the United States for one year's training, and, on account of the declaration of war, December 8, 1941, all National Guardsmen are still in the field doing their duty for our State and Country in an honest and earnest endeavor to maintain for us all, "life, liberty, and the pursuit of happiness".

In order that a clear and definite picture may be had by all, relative to the induction of the entire Colorado National Guard into Active Military Service of the United States, even though a portion was ordered in prior to November 30, 1940, and accounted for in my Report of that date, the following data have been compiled, showing dates of Federal activation under Presidential order:

At the time of the Presdential Order for induction of the first contingent, the authorized strength of the Colorado National Guard was 196 Officers, 2 Warrant Officers, and 2292 enlisted men, a total of 2490. Of this authorized strength, 174 Officers and 2250 enlisted men, a total of 2424, were inducted, as indicated in the following table:

Each warrant officer and enlisted man of the National Guard, assigned to a unit ordered to active duty under this Order, who shall have been examined and found qualified for this appointment as an officer in the National Guard of the United States, under the provisions of Section III, National Defense Act, as amended, and who shall not have been appointed in the National Guard of the United States in the grade for which examined and found qualified prior to the effective date of induction of his unit, is hereby tendered appointment in the National Guard of the United States and commissioned in the Army of the United States, in the same grade and arm or service for which he shall have been so examined and found qualified.

Each warrant officer and enlisted man of the National Guard who holds appointment as an officer in the National Guard of the United States and a commission in the Army of the United States, or who is tendered such appointment and commissioned by the terms of this Order, and who is assigned to a unit ordered to active duty under this Order prior to the offective date of induction of such unit, is hereby ordered to active military service as a commissioned officer of the Army of the United States under that appointment and commission.

Dear Governor Carr:

In order to strengthen the common defense, the President has thought it proper to exercise, in part, the authority vested in him by Public Resolution No. 96, 76th Cohgress, approved August 27, 1940, to order from time to time any or all members and units of all reserve components of the Army of the United States into Active Pederal Service.

He has, accordingly, given his signature to Executive Order No. 8633, January 14, 1941, a copy of which is enclosed. In accordance therewith, all federally recognized elements of the following units of the National Guard of the United States of the State of Colorado, and all persentel of both the active and inactive National Guard assigned to such units, will be ordered into active service of the United States on dates to be hereafter announced in War Department orders:

168th Field Artillery (155 gun), 75th FA Brigade.

It is expected that the above units will be inducted as rapidly as progress of the Construction program permits. Telegraphic notice of War Department orders announcing the induction dates will be sent you at least 15 days in advance of the date prescribed for each unit.

"Each warrant officer and enlisted man of the National Guard assigned to a unit ordered to active duty under this Order, who shall have been examined adm found qualified for appointment as an officer in the National Guard of the United States, under the provisions of Section 111, National Defense Act, as amended, and who shall not have been appointed in the National Guard of the United States in the grade for which

INDUCTION ROSTER.

As a means of ready reference and to establish the record in permanent form, this Office has recently published a booklet entitled, "Induction Roster, Colorado National Guard, World War II", covering the personnel of Federally recognized Colorado National Guard Troops ordered into active military service of the United States for One Year's Training as indicated on the preceding pages. Even though, at the time of this induction, the tragedy of Pearl Harbor had not yet occurred nor had War been declared, the troops thus ordered to active duty will remain in service for the duration of the war and six months thereafter.

Sufficient copies of this roster were printed and are now available to each and every officer and enlisted man whose name appears therein.

RELEASE FROM ACTIVE DUTY

Under Government action to release from active military service of the United States enlisted men over 28 years of age and those upon whose families a hardship would devolve should they be retained for more that the original one year's training, the State Detachment (Without personnel) was released to Colorado State control, without numerical restriction on a grades and ratings, in order that such men might be assigned thereto and accounted for to higher authority. Men, who, after initial induction dates, had been enlisted for one year and discharged on expiration of service and reenlisted, were likewise taken into this thic. In all, there were 176 released and 32 resulisted and attacked the State Detachment and held therein until family and other conditions rendered them available for recall to active duty or discharge. At this date, all but 35 have been recalled or discharged and instruction have been received that those remaining on December 31, 1942 shall be discharged.

ARMORIES

Upon the departure of troops to active military debyishom their respective stations over the State, immediate steps were taken to care for and maintain the 39 armories in a manner that they would in no way deteriorate during the absence of the units from their in was takensal. Accordingly, endeavor was made to have the respective cities take over the buildings, make periodical inspections, and report to this office needed repairs or installations required in their upkeep. In this we have been quite successful and at such time as the personnel of the National Guard returns to the State, it is believed they will find the armories in better condition than when they left. In fact, new roofs had been put on most of the buildings, and no occupancy or use is being allowed which will place undue wear and tear on the floors or other structural parts.

It should be added in this connection, that the National Guard Hangar, at Municipal Airport, Denver, has been completely turned over to the U.S. Army Air Copps, for the futherance of emergency facilities. It is now, as would be suspected, being cared for and conditioned by the United States Army without expense to the State of Colorado, and will revert to the State when no longer needed by the United States for war purposes.

At Camp George West, near Golden, Colorado, a similar condition exists, though only a portion of the facilities there have been turned over to the Federal Government. The Military Department still maintains a caretaker and other employees there in order to keep the premises in proper order, and care for much Federal and State property of the Colorado Defense Force.

Owing to the continued absence of National Guard troops from the State, little or no new construction work has been undertaken or done at the various stations over the State. In view of the importance of storage facilities for military equipment and vital records of the Colorado National Guard, a strong and substantial fence has been placed around the entire premises at the State Armory, 300 Logan Street, Denver This will make for smaller expense of guard and care of the property and is considered a needed improvement more than worthy of the expense accessitated,

RESIGNATIONS AND SEPARATIONS OF Officers of the Colorado National Guard.

In view of the fact that my Biennial Report of November 30, 1940, did not contain the names of Federally recognized officers whose resignations were accepted or those who were otherwise separated from the service of the Colorado National Guard during that period, it is believed that the following list with dates of separation during the full four years will prove interesting. It should be noted that this list does not embody the resignations and separations of officers of the Colorado Defense Forze which is not Federally recognized, but I do wish to say that most of the resignations of that State Organization have been for the purpose of entering the active military service of the United States against our common enemies.

SELECTIVE SERVICE.

As I issue this report, I desire to state that the Selective Service System in Colorado has been smoothly functioning for two years along lines previously worked out by State Staff Officers of the Colorado National Guard and others, and decided upon under instructions from the General Headquarters in "ashington, D.C. Since beginning its induction duties at 300 Logan St., Denver, Colorado, the headquarters have been so expanded that no question of operation or induction goes uncared for for any undue period. Its operation, however, is no longer a part of the Adjutant General's Office, proper, other than the coordination of papers pertinent to both offices.

I feel it my duty, in this connection, to make it plain to all concerned, that the Selective Service System of Colorado functions without cost to the State Military Department or the State of Colorado. The eperating expenses and payrolls are all met by the Federal Government from funds appropriated for that purpose by Congress. The employees at State Headquarters are all under Civil Service and are conscientiously and efficiently performing their duties. The State of Colorado stands will up in its rating of efficiency a mong other states of our nation.

THE COLORADO DEFENSE FORCE.

In order to furnish the State of Colorado a flexible medium of protection during the absence of Netional Guard troops in active military service, the General Assembly of Colorado enacted into law, House Bill No. 1, quoted below, which was approved by the Governor on April 17, 1941:

ANACT

HOUSE BILL NO. 1.

By REPRESENTATIVES THOMAS, CHEEVER, GRIMES, HALLEY and SENATORS WHITAKER, CROWLEY, and DAVIES

RELATING TO ADDITIONAL MILITARY FORCES TO DEFEND THE STATE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF COLORADO:

SECTION 1. The Governor of the State of Colorado may establish, enlist, train, maintain, and reg late an organized Military Defense Force within and for the State of Colorado, constituting a part of the military establishment for the defense of the United States and the State of Colorado, in addition to and supplemental to the existing organizations of the Ustional Guard, and with the same powers and duties of the National Guard when not in federal service, to the full extent authorized by the laws of the United States and the Constitution of the State of Colorado.

SECTION 2. Whenever any part of the National Guard of this State is in active federal service, the Governor is hereby authorized to organize and maintain within the State during said period, under such regulations as the Secretary of War of the United States may prescribe for discipline in training, such military forces as the Governor may deem necessary to defend this State. Such forces shall be composed of officers commissioned or assigned, and such able-bodied male citizens of the state as shall volunteer for service therein. Such forces shall be additional to and distinct from the National Guard and shall be known as, "The Colorado Defense Force of the State of Colorado". Such forces shall be uniformed.

SECTION 3. ORGANIZATION; RULES AND REGULATIONS. The Governor is hereby authorized to prescribe rules and regulations not inconsistent with the provisions of this Act governing the enlistment organization, administration, equipment, maintenance, training, and discipline of such forces: Provided such rules and regulations, insofar as he deems practicable and desireable, shall conform to existing law governing and pertaining to the National Guard and the rules and regulations promulgated thereunder and shall prohibit the acceptance of gifts, denations, gratuities, or anything of value by such forces or by any member of such forces from any individual, firm, association, or corporation by reason of such membership; any person, firm, corporation, or association, or any public officer or official of this State, or any political sub-division thereof, or any officer, member or agent of the National Guard who shall wilfully violate any of the provisions of this Act or who shall aid or incite the wilful violation of any of said provisions shall for each such offense be deemed guilty of a misdementar and upon conviction therefor, shall be fined not less than two hundred and fifty dollars (\$250.00) nor more than one thousand dollars (\$1000.00), or shall be imprisoned for a period of not less than sixty days, nor more than one gent or both. Provided, further, it shall be permissible for common carriers, such as railroads and bus lines to carry members of these forces wilthout charge or at a reduced rate. Provided, further, the Adjutant General shall be required to maintain a public record of all of the activities of the Colorado Defense Force wheniin service.

SECTION 4. PAY AND ALLOWANCES. All officers and enlisted men, when serving under orders of the Governor to prevent violation of the laws of the State or the United States, or to prevent or suppress a riot, insurrection, or to repel or prevent invasion, shall, unless or until other provision shall be made, receive pay out of the general fund of the State at a rate to be fixed by the Adjutant General of the State of Colorado, with the approval of the Governor of the State of Colorado, not in excess, however, of the pay and allowances as are paid to officers and enlisted mentof the United States Army of like grade; Provided, however, that no officer or enlisted man of the Colorado Defense Force of the State of Colorado shall receive . longevity pay. The officers and enlisted men of the Colorado Defense Force of the State of Colorado, when serving under orders of the Governor of Colorado shall be construed to be employees of the State of Colorado, and in the event that any such officer or enlisted man shall incur injuries sustained in the performance of his duties while acting under such orders of the Governor of the State of Colorado, he shall be entitled to all of the benefits of the Workman's Compensation Act of the State of Colorado now or hereafter accruing to employees of the State of Colorado.

SECTION 5. REQUISITIONS: ARMORIES: OTHER BUILDINGS. For the use of such forces, the governor is hereby authorized to requisition from the Secretary of War such arms and equipment as may be in possession of and can be spared by the War Department; and to make available to such forces the facilities of state armories and their equipment and such other state premises and property as may be available.

SECTION 6. USE WITHOUT THIS STATE. Such forces shall not be required to serve outside the boundaries of this state, except

- (a) Upon the request of the governor of another state, the governor of this state may, in his discretion, order any portion or all of such forces to assist the military or police forces of such other state who are actually engaged in defending such other state. Such forces may be recalled by the governor at his discretion.
- (b) Any organization, unit or detachment of such forces, upon order of the officer in immediate command thereof, may continue in fresh pursuit of insurrectionists, saboteurs, enemies or enemy forces beyond the border of this state into another state or until they are apprehended or captured by such organization, unit or detachment or until the military or police forces of the other state or the forces of the United States has had a reasonable opportunity to take up the pursuit or to apprehend or capture such persons; Provided, such other state shall have given authority by law for such pursuit by such forces of this state. Any person who shall be apprehended or captured in such other state by an organization, unit or detachment of the forces of this State shall without unnecessary delay be surrendered to the military or police forces of the state in which he is taken or to the United States, but such surrender shall not constitute a waiver by this state of its rights to extradite or prosecute such person for any crime committed in this state.

SECTION 7. PERMISSION TO FORCES OF OTHER STATES. Any military forces or organization, unit or detachment thereof, of another state who are in fresh pursuit of insurrectionists, saboteurs, enemies or enemy forces may continue such pursuit into this state until the military or police forces of this state of the forces of the United States have had a reasonable opportunity to take up the pursuit or to apprehend or capture such persons and are hereby authorized to arrest or capture such persons ithin this state wile in fresh pursuit. Any such person who shall be captured or arrested by the military forces of such other state while in this state shall without unnecessary delay be surrendered to the military or police forces of this state to be dealt with according to law. This section shall not be construed so as to make unlawful any arrest in this state which would otherwise be lawful. Provided, further to make arrests anywhere within the confines of the State of any and all persons charged with the violation of any law of this State or of the United States, and when a witness to the perpetuation of englosfenss or crime or of the violation of any law of this State or of the United States may arrest without warrant; to arrest and detain any and all persons suspected of the commission of any felony or misdemeanor whenever complaint is made and a warrant is issued thereon for such arrest, and any and all persons so arrested shall be forthwith brought before the proper tribunal for examination and trial in the county where the offense for which any such arrest has been made was committed.

SECTION 8. FEDERAL SERVICE. Nothing in this Act shall be construed as authorizing such forces, or any part thereof to be called, ordered, or in any manner drafted, as such into the military service of the United States, but no person shall by reason of his enlistment or commission in any such forces be exempted from military service under any law of the United States.

SECTION 9. CIVIL GROUPS. No civil organization, society, club, Post, order, fraternity, association, brotherhood, body, union, league, or other combination of persons or civil group shall be enlisted in such forces as an organization or unit.

SECTION 10. DISQUALIFICATIONS. No person shall be commissioned or enlisted in such forces who is not a citizen of the United States, and who has not been a bona fide resident of the State of Colorado for at least one year immediately preceding his entry into The Colorado Defense Force or who has been expelled or dishonorably discharged from any military or naval organization of this state, or of another state, or of the United States, or has been convicted of a felony.

SECTION 11. OATH OF OFFICERS. The oath to be taken by officers commissioned in such forces shall be substantially in the form prescribed for officers in the National Guard, substituting the words "The Colorado Defense Force of the State of Colorado" where necessary.

SECTION 12. ENLISTED MEN No person shall be enlisted for more than one year, but such enlistment may be renewed. The oath to be taken upon enlistment in such forces shall be substantially in the form prescribed for enlisted men of the National Guard, substituting the words, "The Colorado Defense Force of the State of Colorado" where necessary.

SECTION 13. ARTICLES OF WAR: FREEDOM FROM ARR ST: JURY DUTY. (a)
Whenever such forces or any part thereof shall be ordered out for active service the Articles of War of the United States applicable to members of the

National Guard of this state in relation to court martial, their jurisdiction and the limits of punishment and the rules and regulations prescribed thereunder shall be in full force and effect with respect to The Colorado Defense Force of the State of Colorado.

(b) No officer or enlisted man of such forces shall be arrested on any warrant, except for treason or felony, while going to, remaining at, or returning from a place where he is ordered to attend for military duty. Every officer and enlisted man of such forces shall, during his active service therein, be exempt from service from any posse comitatus and from jury duty.

SECTION 14. The Colorado Defense Force as created by this Act shall expire by limitation on June 15, 1943, or immediately upon the permanent return to the State of Colorado of the regularly constituted National Guard.

SECTION 15. SEVERABILITY. If any provision of this Act or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of the Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are declared to be severable.

SECTION 16. REPEAL. That part of Section numbered 58 of Chapter numbered 111 of the Colorado Statutes Annotated, 1935, and all acts and parts of acts in conflict with or inconsistent with the provisions of this act are hereby repealed.

SECTION 17. SHORT TITLE. This act may be cited as the Colorado Defense Force Act.

SECTION 18. The General Assembly hereby finds, determines and declares this Act necessary for the immediate preservation of the public peace, health and safety.

SECTION 19. In the opinion of the General Assembly an emergency exists; therefore, this Act shall take effect and be in force from and after its passage.

Defense Force.

- 1. In conformity with House Bill No. 1, 33rd General Assembly of the itate of Colorado, approved April 17, 1941, authorizing and directing the Governor to establish, enlist, train, maintain and regulate a military organization to be known as The Colorado Defense Force, the following instructions and orders are hereby promulgated to govern such organization.
- 2. The organization and service of the Colorado Defense Force shall be as follows:

a. Organization:

1. The Colorado Defense Force shall be organized and governed as prescribed by this order and such rules and regulations as may be promulgated from time to time, pursuant to the provisions of the military laws of Color do and instructions from the Secretary of War. Except as otherwise provided by orders of the Governor, all the provisions of military laws and regulations in respect to the National Guard shall apply to the Colorado

2. Upon release of the National Grand from the service of the United States, the officers and enlisted men of the National Gu. rd shall again constitute the National Guard of the State of Golorado and the Colorado Defense Force shall be disbanded upon orders of the Governor. The commissioned officers of the National Guard shall thereupon resume their commissions in the National Guard in the grades held by them when ordered or called into service of the United States, or in any higher grade which they may have attained in such service; the enlisted men of the National Guard shall continue to serve in the National Guard until the dates of expiration of their enlistments entered into prior to the induction of the National Guard into such federal service, in the grades held by them when ordered or called into the service of the United States, or in any higher grades which they may have attained while in such service.

3. When the National Guard shall have been returned to its former status as herein provided, the Governor shall designate by orders a date upon which the Colorado Defense Force shall be discintinued. Upon such discontinuance, officers and enlisted mad of the Colorado Defense Force who are eligoble for commission or enlistment in the National Guard, may, with their consent, be commissioned or enlisted therein; and those rendered surplus may, in the discretion of the Governor, be discharged.

b. Commissioned Officers:

All officers of the Colorado Defense Force shall be appointed and commissioned by the Governor in his discretion, subject to the requirements and conditions prescribed by the military law in respect to officers of the National Guard, except the Governor shall have the right to grant such waivers

as he may deem necessary for the good of the Defense Force of the State of Colorado. The form of Oath to be taken by commissioned officers of the Colorado Defense Force shall be as prescribed in regulations. All of the provisions of the military laws and National Guard Regulations in respect to commissioned officers shall apply to officers of the Defense Force, except as waived by the Governor the State.

c. Inlisted Men;

The qualifications for, and the form of Oath to be taken upon enlistment shall be as prescribed by The Adjutant General's Office. All of the provisions of the military laws and regulations in respect to enlisted men of the National Guard of the State shall apply to enlisted men of the Colorado Defense Force, except as waived by the Governor of Colorado.

The term of enlistment shall be for one year.

- d. Duties:

 All duties imposed by military law or other statutes of the State, or by military regulations, upon organizations, officers and enlisted men of the Mational Guard, are hereby imposed upon the organizations, officers and enlisted men of the Colorado Defense Force.
- The Colorado Defense Force shall consist of such infantry units, and detachments, as are deemed necessary by the Governor of the State of Colorado for the protection of life and property and the uninterrupted progress of industry. In so far as possible, units of the Golorado Defense Force shall be located in armories now used by the Colorado National Guard.
- The Colorado Defense Force, when organized for duty, shall be commanded by the senior officer holding a State commission in the Colorado Defense Force. He shall be so designated by the Governor as the Commanding Officer, Golorado Defense Force.
- The Colorado Defense Force shall be organized under the provisions of Federal and State Military Laws, and shall be administered through the office of the Adjutant General; it shall be subject at all times to the call of the Governor, and the officers and men shall cooperate with the State Brector of Civil Defense at all times. All orders issued to officers or enlisted man of the Colorado Defense Force shall, however, come from the Governor, or the officer appointed in compliance with the military law of the State of Colorado.
- h. Pay and Allowances:

 The Colorado Defense Force shall be organized on an entirely voluntary basis and there shall be no pay or allowances for officers or enlisted men except when called by the Governor for active duty, at which time officers and enlisted man shall receive pay at a rate to be fixed by the djutant General of the State of Golorado with the approval of the Governor of the State, not in excess, however, of the pay and allowances as are paid to officers and enlisted men of the U.S.Army of a like grade.
 - Use of Armories:

 Armories of the State of Colorado shall be used by the Colorado

Defense Force as needed, depending upon the emergency, and shall be operated der rules and regul tions for the management of armories which shall be published by the Adjutant General's Office, State of Colorado.

j. Empenditure of State Funds:

No expenditure of State funds shall be made or contracted for before first receiving authority from The Adjutant General, State of Colorado.

k. Arms and Equipment:

In accordance with Public No. 874, 76th Congress, Chapter 902, 3rd Session, the Secretary of War is authorized, at his discretion and under regulations determined by him, to issue for the use of the Colorado Defense Force, upon requisition by the Governor, such arms and equipment as may be in possession of and can be spared by the War Department.

1. Limitation of Service:

The Colorado Pefense Force shall not be called, ordered, or in any manner drafted, as such, into the military service of the United States; however, no person, by reason of his membership in the Golorado Befense Force, shall be exempted from military service under any Federal law.

m. Qualification for Enlistment:

(1) General.

Applicants for enlistment in the Golorado Defense Force shall be between the ages of twenty-five (25) and fifty-five (55) years and shall be subject to such medical examination as may be prescribed by the State Defense Force Medical Officer. Applicants shall be American citizens and shall be required to take the Gaih of enlistment as prescribed.

(2) The enlistment period of the Colorado Defense Force shall be for one year, unless somer discharged by proper authority. The discharge of members before the expiration of their term of enlistment shall be at the listretion of the Governor of the State of Colorado.

p Disqualifications:

No person shall be commissioned or enlisted in the Colorado Defense Force who is not a citizen of the United States and who has not been a bona fide resident of the State of Golorado for at least one year immediately proceding his entry into the Colorado Defense Force, or who has been expelled or dishonorably discharged from any military or naval organization of this State or of the United States, or who has been conveicted of a felony.

THE FEDERAL GOVERNMENT.

Inasmuch as the Federal Government is concerned in the training, supply of clothing, Arms and ammunition, etc., for the use of the State Guard (Colorado Defense Forze), it is a logical conclusion that regulations governing such organization should be published by the War Department specifying the purpose, statutory authority, status, employment, This was done in Army Regulations No.850-250 dated April 21, From this regulation it is desired to call attention to the following pertinent facts relating to the State Guard (Colorado Defense Force) which are accepted by the State of Golorado, and which are not generally known: The Colorado Defense Force is not subject to call, order, draft (as such a force), into the Military Service of the United States, nor is it subject to Federal recognition or control other than as provided expressly by reasonable implication, by statute. solely a State military organization, as its name implies, and, as such, and in accordance with above numbered regulation, Federal recognition has not been requested. The authority of the State to maintain its State Guard ceases upon the relief from the Active Federal service of all elements of its Mational Guard.

At the present date, the authorized strength of the Colorado De-Fense Force is 80 Officers and 1065 Enlisted Men, divided as follows:

The actual strength as organized at the present time is 46 Officers and 323 Enlisted Men.

As will be noted by the following Roster, no unit of the Colorado Defense Force has been organized outside of Benver. It is believed that in Denver the maintenance and training of the initial units can be accomplished more economically, and, in case of industrial unrest, flood, fire or general distress, transportation would be more readily available. In several other cities, arrangements have been made for immediate organization of units when and if found necessary.

SERVICE RECORDS

For the purpose of establishing their ages, or dates of birth in connection with application for Old Age Pensions, or to verify eligibility for employment on Government projects, the records of military service maintained in this Office have been a source of valuable information and assistance, during the biennium, to hundreds of persons unable to secure Certificates of Birth in this or other states. Also, statements of service have been prepared and forwarded to the majority of officers and enlisted men inducted into Active Military Service of the United States from the Colorado National Guard for use in claims for longevity pay under new legislation. This work has required much research and unending care in order that no one should be underpaid for the full time authorized by law.

THE COLORADO VETERANS' GRAVES REGISTRATION.

This Division of My Department pertains to the Registration of Graves of Veterans buried within the borders of the State of Colorado, and had its inception in the American Legion National Grave Registration Plan in 1938, when Project Proposal was written to make this Registration in Colorado a Statewide Project of the Work Projects Administration, under the sponsorship of the State of Colorado Military Dept., with the cooperation of the American Legion and the Veterans of Foreign Wars Organizations.

Purpose and description of this Veterans' Graves Registration Project was clearly defined in the Presidential Letter from President Roosevelt accompanying his approval of this Project, transcription of which follows: "Prepare a comprehensive record as of January 1st, 1938, of the graves of the State of Colorado deceased, Honorably discharged veterans of the Army, Navy, and other military establishments of the United States, including the Confederate States of America. Work includes inspecting burial grounds; preparing or duplicating cemetary plat maps, in uniform style; checking deth and burial records; and preparing a card record showing name, service connection, place, date, and cause of death, and place and date of burial".

In conjunction with preparing or duplicating cemetary plat maps of organized cemeteries, where grave records of individual burials were maintained, this Colorado Veterans' Graves Registration Project provided for the Platting of ALL Burial Places, Isolated Graves, or Group of Graves, with accurate designation of each veteran's Grave on respective Plat, located by actual measurement from two or more fixed permanent objects, to ensure for all time a record of the definite location of each veteran's grave as it obtained at the time this Graves Registration Project was operating in that specific area.

The early months of the year 1941 found this Project progressing most satfactorily toward the 100% completion so devoutly strived for through intelligent planning and specialized training of workers; but about the middle of April 1941, hopew for the successful consummation of these plans were blasted by
the nature of Administrative Orders from the Worl Projects Administration at
Lashington, D. C. to reduce the W. P. A. Program in Colorado, by eliminating
Projects not actually engaged in work of what was termed "of a Defense Nature".
Obviously, The Veterans' Graves Registration Project was hereby destined to
be terminated, and on the date of June 30th, 1941, the Federal Government
wrote "Finis" to this very worthy Project as a Federally Financed activity.

However, on July 1st, 1941, the undersigned, prompted by a genuine appreciation and an astute valuation of the character and quality of all that had been accomplished by this Veterans' Graves Registration Project; the large investment of Public Funds it represented; and the legal and sentimental value of these historical records to prosperity; conceived the plan to perpetuate the Registration of Veterans' Graves in Colorado, within existing fixed limitations, and to complete and refine the tast amount of unfinished work material remaining at the time of the closing of the Project.

Services of C. W. Bixby, former Technical Director and State Supervisor of this Veterans' Graves Registration Program in Colorado were engaged to direct and carry out these plans.

On the date of this report, most of the unfinished work material, previously produced by Project orkers, has been converted into the finished product, and the entire accomplishment to date has been checked, rechecked, authanticated, refined for the permanent Registration Library, card indexed, and cross indexed, thereby ensuring easy authoritative reference.

Over eight hundred and fifty (850) Registrations have been added to the Library through intensive research and the salvaging of many previously rejected "Possible Veterans" whose veteran status had not been established due to curtailment of Project Operations.

Others have been acquired and are still being acquired through continued Newspaper Research and the valued cooperation of Veterans' Organizations and Government Holpitals.

Recapitulation of Accomplishment, achieved by the Veterans' Grave Registration Project, to date of termination of same as a Work Projects Administration Program, June 30th, 1941:

A total of fifteen thousand (15,000) authenticated Registrations, certfied for entry in the permanent registration records, were obtained after processing thousands of "Possible Veteran Forms" through intensive Research and Investigation to determine eligibility of decedents veteran status for this registration.

Fifty counties (50) throught the statewere completed in all Field Activities. The remaining thirteen counties in which Project Operations were never started, or if started, soon terminated with negligible accomplishment, due to W. P. A. Regulations or inability to obtain qualified workers, were: Clear Creek, Dolores, Elbert, Grand, Hinsdale, Jackson, Lincoln, Logan, Mineral, Park, San Juan, San Niguel, and Sedgwick.

Approximately one million (1,000,000) newspapers throughout the State of Colorado were researched, yielding record of Names, Service Connection, and Burial Place of over three thousand (3,000) Veterans buried within the borders of the state; and in many instances this information was absolutely unobtainable from any other source.

Over three quarter million (775,000) graves in Colorado were investigated to ensure positive information regarding status of occupant—whether "Possible Veteran" or not.

Approximately two thousand (2,000) Government Headstones were erected on the unmarked graves of Veterans buried within the state, through the assistance and required authentication the Veterans' Graves Registration: Project was able to provide.

Field Sketches, Drawings, etc., of cemeteries and other Burial Places, prepared by the Project Fieldworkers totalled over one thousand (1,000). Invariably, these were crude pencil Sketches denoting chiefly the outline and overall measurements of Burial Grounds and the location of Veterans' graves within respective Burial Grounds. These Sketches required complete reproduction, involving, first, a redrawing to uniform scale in Pencil on Detail Paper, then tracing in Ink on Linen for permanent record. All of which had to be done by skilled Draftsmen and Tracing Clerks at State

Headquarters of the Project. Unfortuanately, this Drafting Division of Operations was never staffed with sufficient number of workers to keep pace with the Field production of Sketches, etc. and at various times it was seriously thought this Division would have to be abandoned.

Federal Funds provided for the Veterans' Graves Registration Project approximately totalled \$150,000.00, which amount was supplemented by special appropriation of \$2,950.00 made by the Colorado State Legislature in assembly in 1939.

Sponsors' contributions, made by respective counties wherein the Project operated and consisting of Gasoline Grant for Project Workers' cars while engaged in Project Operations, and the estimated rental value, light, heat, etc. provided for Project Headquarters in prespective counties, amounted to approximately \$40,000.00.

Today, The Colorado Veterans' Graves Registration Library contains the Names and the Grave Registration of over fifteen thousand, eight hundred and fifty, (15,850) deceased, honorably discharged Veterans, and five hundred and twenty nine (529) finished plats of Cemeteries, Burial Places, etc., containing the gaves of Colorado's soldier dead.

This accomplishment, of which I am very proud, is housed securely within locked Binders, for which a specially designed Cabinet has been constructed, and this Historical Library of The Colorado Veterans' Graves Registrations is accessible to all interested, either for inspection or reference, at the State of Colorado Military Headquarters, National Guard Armory, Denver, Colorado.

RECOMMENDATION.

It is recommended that during the absence of our National Guard Officers in active military service of the United States that no change be made in the State Statutes affecting the Colorado National Guard. These Officers are all members of the National Guard Association, and, through this organization it has been possible to enact certain legislation in keeping with the National level which affected every state. They will, under the National Defense Act, after the emergency, be returned home in the rank and grade they held prior to their induction, and any now legislation should be based on their views for the future welfare of the Colorado National Guard.

CONCLUSION.

In closing this Report, I would feel that I had been guilty of an overight and done you an injustice, Governor Carr, did I not express my keenest
appreciation for your sympathetic and generous assistance in all my endeavors
to maintain the Military Department of the State at its highest possible state
of efficiency during my administration. The errors that have been made, I am
quite willing to have charged against my account, but at the same time I concede that the successes must be placed to your credit as Commander-in-Chief.
