THE INFORMANT HAS OBSERVED A RESIDENT OF THE UPPER GARFIELD CREEK AREA WHO DRIVES A WATER TRUCK FOR TLT TRUCKING. THE DRIVER WAS SUSPECTED OF HAULING PRODUCED WATER FROM A MARALEX WELL AND NOT GOING TO THE DISPOSAL FACILITY BUT DUMPING THE FLUID IN A FIELD OR AREA NEAR HIS HOUSE. J RADA CONTACTED THE TRUCK CO. OWNER AND ASKED FOR TRIP TICKETS AND TOLD THE COGCC ABOUT THIS.

I WENT TO THE TRUCK DRIVER'S HOUSE 11/29 AND TALKED WITH AJ WELLER. I MENTION11/29/07ED THAT I WAS INVESTIGATING A RUMOR THAT "SOMEONE" MIGHT HAVE BEEN DUMPING GAS-WELL PRODUCED WATER IN AN UNAPPROVED MANNER AND AREA. MR. WELLER SAID THAT HE "HAD NOTHING TO HIDE" -- THAT HE HAD BEEN DOING EVERYTHING BY CORRECT PROCEDURE, ETC. HE MENTIONED THAT IT MAY HAVE LOOKED SUSPICIOUS THAT HE LEFT THE TRUCK AT HIS HOUSE FOR A WHILE. THE MARALEX WELL IS SHUT IN FOR THE WINTER AND NEXT SPRING (WHEN PRODUCTION RE-COMMENCES) WE SHOULD BE WATCHING TO SEE IF SUCH ALLEGATIONS MIGHT BE HAPPENING. I WAS ABLE TO SCAN THE VALLEY TO THE SOUTH/SOUTHEAST (GENERAL LOCATION OF ALLEGED DUMPING) -- DID NOT NOTE ANYTHING "AMISS" NOR LOOKING LIKE A SPILL. ALSO OBSERVED A SMALL POND NEXT TO PROPERTY GATE, THE ICE OF WHICH WAS CLEAR (AND NOT DISCOLORED).

J K WILL CONTACT MARALEX (12/13) TO OBTAIN TRUCK TICKETS. A CALL TO (AN OBSOLETE?) GJ MARALEX NUMBER HAS NOT BEEN RETURNED (12/13).

THE COMPLAINTANT PROVIDED SOME SPECIFIC OBSERVATIONS IN A 12/05/07 EMAIL: THE FOLLOWING TIMES ARE APPROXIMATE AND ARE WITHIN AROUND 10 MINUTES OF THE ACTUAL TIMES. AT AROUND 1:30 PM ON MONDAY, NOVEMBER 19TH, 2007, I OBSERVED THE TLT TRUCK IN QUESTION GO UP THE BALDY CREEK ROAD (THE ROAD WHERE THE MARALAX SITE IS). AT AROUND 2:35 PM I OBSERVED THIS TRUCK COME UP THE SMALL LANE (OFF OF GARFIELD CREEK ROAD) AND THEN PROCEED UP TO THE AREA THAT I POINTED OUT TO YOU ON YOUR VISIT.

I THEN SAW THE TRUCK ABOUT 30 MINUTES LATER LEAVE THIS AREA AND GO BACK UP THE BALDY CREEK ROAD, ABOUT 3:05 PM. I THEN SAW THE TRUCK COME BACK UP THE SAME ROAD AND TO THE AREA IN QUESTION AT A LITTLE AFTER 4:00 PM. AT 4:30 PM THE TRUCK CAME OUT OF THAT AREA AND WENT TO THE HOUSE YOU VISITED, AND WAS THERE FOR THE NIGHT.

AT 7:45 AM THE FOLLOWING MORNING, NOV. 20TH, 2007, I OBSERVED THE TRUCK GO UP THE BALDY CREEK ROAD. BETWEEN 8:45 AND 9:00 AM, MY WIFE OBSERVED THE TRUCK GO BACK UP TO THE AREA IN QUESTION. THAT IS THE LAST TIME I SAW THIS VEHICLE. I THEN REPORTED THIS TO JAKE MAUL AND JIM RADA WHO WORK FOR GARFIELD COUNTY.

I ALSO OBSERVED A SIMILAR TRUCK A FEW WEEKS BEFORE GO TO THE SAME AREA BUT I HAVE NO SPECIFICS ON THE DATE AND TIME.

NATURAL GAS EMISSIONS & EXPLOSION AT KANNAH CREEK FACILITIES

DEAR MR. MILLER:

IN THE EARLY MORNING HOURS OF DECEMBER 7TH, 2007 FOLLOWING EXTREMELY LOUD NATURAL GAS VENTING EMISSION A TREMENDOUS EXPLOSION ROCKED THE UPPER KANNAH CREEK ROAD VICINITY, SOUTH EAST OF PURDY MESA, MESA COUNTY, COLORADO. THIS BLAST OCCURRED AT APPROXIMATELY 0005 HRS MST AND IS PRESUMED TO BE DIRECTLY RELATED TO ASPEN WELL OPERATING COMPANY'S GAS WELL DRILLING OPERATIONS. THIS BLAST WAS EXTREMELY DISTURBING TO NEARBY PROPERTY OWNERS AND WAS FOLLOWED BY CONTINUED GAS VENTING AND ANNOYING ALARM SOUNDS. IT HAS BEEN REPORTED BY NEARBY RESIDENTS THAT PETROLEUM AND HYDROGEN SULFIDE ODORS HAVE ACCOMPANIED SHRILL WHISTLING NOISES DURING THE WEEKS PRECEDING THE MIDNIGHT BLAST.

THIS DEPARTMENT WOULD APPRECIATE AN EXPLANATION FROM ASPEN WELL OPERATING, LLC REGARDING THE CAUSE OF THE ABOVE REPORTED BLAST, EXCESSIVELY LOUD WELLHEAD EMISSIONS, AND RELATED ODORS. IT IS NECESSARY FOR THIS DEPARTMENT TO UNDERSTAND THE NATURE OF SUCH EVENTS, AND THE POTENTIAL FOR CONTINUATION OF SUCH DISTURBING NEIGHBORHOOD IMPACT ACTIVITY, IN ORDER TO RESPOND TO CITIZEN COMPLAINTS REGARDING SUCH ACTIVITY AND CONCERNS OF THE IMPACT TO THEIR HEALTH AND SAFETY.

DUE TO NO STORM-WATER BEST-MANAGEMENT PRACTICES; HISSING/VENTING FROM A WELL "NEAR THE CHURCH". I DROVE TO THE AREA LATER A.M. 12/11. I VISITED BOTH WELLS EITHER SIDE OF THE "COWBOY CHAPEL". THEY ARE BOTH SHUT-IN, AWAITING HOOKING-UP TO THE PIPELINE. BOTH SEEMED QUIET, NO HISSING, TANKS EMPTY OF FLUID, ETC. THERE WERE A FEW INCHES OF SNOW AND MORE WAS FALLING. THIS PRECLUDED ANY ASSESSMENT OF STORM-WATER BMPS. THE ASPEN RIG #10 WAS AT THE SHIPP LOCATION -- ABOUT A MILE SOUTH OF KANNAH CREEK UP ON THE MESA. NOBODY WAS THERE. THERE WAS NO EVIDENCE OF ANY BLOW-OUT NOR EXPLOSION (SNOW MAY HAVE PRECLUDED THIS) AND ACCORDING TO THE TOWER LOGS, IT SEEMED EVERYONE LEFT AT 6 A.M. FRIDAY 12/7. I LEFT A CARD AT EACH OF TWO TRAILERS WITH A NOTE TO CALL ME. TOWER LOGS NOTED SEEMINGLY MINOR PROBLEMS -- E.G., THEY PERIODICALLY HAD TO "BLOW OUT" THE HOLE (DUE TO, I THINK, AIR DRILLING SO THEY COULD BLOW OUT THE WATER?), "BOOSTER DIED 6 TIMES" RIG READ-OUT NOT WORKING, LOST CIRCULATION, OIL LEAK AT RIG, BUT ALSO "KELLY BLEW UP" -- WAIT ON NEW ONE.

STEVE DEFEYTER WROTE AN EMAIL 12/11: I DISCUSSED THE ORIGINAL COMPLAINT RECEIVED BY PERRY BUDA, AIR POLLUTION CONTROL SPECIALIST, MCHD, WHO REPORTED THAT THE COMPLAINANT AS PURDY MESA RESIDENT TOM STEINER (257-9160), WHO REPORTED THE LOUD HISSING AND OBJECTIONABLE ODORS, REPORTEDLY FROM THE JENSEN/COWBOY CHAPEL WELLSITE. I ADVISED TOM TO CONTACT JAY TO DISCUSS HIS CONCERNS. JON GARTZ (243-4454) LIVES CLOSER TO THE INDIAN CREEK MESA (SHIPP?) WELLSITE WHICH WE FEEL IS THE SOURCE OF THE MORE RECENT NOISE, AND WHERE THE ASPEN DRILL RIG IS CURRENTLY SITUATED. HE WAS VERY DISTURBED BY THE BLAST. I ADVISED HIM TO CONTACT JAY AS WELL. THE MIDNIGHT EXPLOSION WAS REPORTED BY ANOTHER INDIVIDUAL WHO I CONTACTED WHO LIVES SEVERAL MILES DOWN KANNAH CREEK FROM THE WELL SITE. SHE WAS WOKEN UP BY THE BLAST AND THOUGHT THAT IT WAS A SONIC BOOM. I ALSO LIVE IN THE GENERAL AREA. ALTHOUGH FURTHER DOWN PURDY MESA ROAD. AND CAN REPORT THAT I TOO WAS STARTLED AFTER MIDNIGHT BY THE BLAST. REGARDING MUD AND DIRT CARRYOUT. GARTZ REPORTED THAT A LARGE MUDBALL/CLOD WITH A LARGE ROCK WAS CARRIED FROM THE ASPEN COMPRESSOR STATION ROAD ONTO KANNAH CREEK ROAD NEAR WHITING ROAD. HE DODGED THE OBSTRUCTION, BUT OBSERVED ANOTHER VEHICLE HIT IT, POSSIBLY CAUSING DAMAGE. MUD AND DIRT CARRYOUT IS A BIG PROBLEM AT THIS LOCATION.

12/13: J K SPOKE BY PHONE WITH BEN MILLER (ASPEN REGULATORY COMPLAINCE MGR) WHO SAID THAT AT THE TIME OF THE `EXPLOSION` THE COMPRESSOR LINE CRACKED. IT WAS RATED THREE TIMES ABOVE WHAT THE PRESSURE WAS. THIS CAUSED THE INCIDENT. LINES WERE TIED-DOWN, NO-ONE WAS HURT. THEY HAD BEEN DRILLING WITH AIR, AND HAD TO FLUSH OUT WATER FREQUENTLY. J K SAW THIS LINE DURING HIS INSPECTION TWO DAYS EARLIER -- A SECTION OF PIPE WITH FRAYED END. THEY (OPR) DECIDED THAT THE WELL WAS AT TD AND STOPPED DRILLING. ALSO RECOMMENDED WE (COGCC AND MESA COUNTY) CONTACT LOCAL ASPEN REP IN GRAND JUNCTION, CLAYTON BROWN.

DEAR SIRS,

YOUR WELL SITE HILL 33-9-12 #4 NOT ONLY HAS A REGULAR 67 DB ON THE C SCALE AT MY HOUSE, BUT YOUR MAINTENANCE AND WATER TRUCKS FORCE US TO SUBSERVIENCE ON OUR OWN PRIVATE ROAD. I HAVE MAINTAINED AND PLOWED OUR ROAD AND NOW IT APPEARS AS THOUGH I NEED TO DO THE MAINTENANCE FOR YOUR TRUCKS AS WELL AS OUR OWN USE.

DO YOU THINK IT IS FARE FOR YOU TO TAKE ADVANTAGE OF ME AND MY NEIGHBORS IN THIS WAY? CAN YOU NOT AFFORD A SNOW PLOW? IF YOU CAN`T WHY ARE YOU USING ME AND MY NEIGHBORS FOR YOUR CORPORATE PROFIT?

SE FIELD INSPECTOR CONTACTED CONTACTED COMPLAINANT AND ARRANGED TO POSTPONE SCHEDULED NOISE MEASUREMENTS DUE TO INCLEMENT WEATHER CONDITIONS. COMPLANAINT AGREED THAT ROADS WERE TREACHEROUS AND IT WAS AGREED TO MEET AFTER THE WEATHER BROKE.

COMPLAINANT CALLED AND INFORMED LANDOWNER THAT OPERATOR HAD RESPONDED TO HIS EMAIL AND THAT THEY WERE SENDING SOMEONE OUT TO CHECK ON THE NOISY COMPRESSOR.

SW FIELD INSPECTOR SPOKE WITH FIELD SUPERVISOR WHO INFORMED THAT SAMSON HAD INSPECTED THE COMPRESSOR, DETERMINED THAT THERE WAS A MECHANICAL PROBLEM CAUSING IT TO BE EXCESSIVELY NOISY. SAMSON HAD ORDERED PART TO REPAIR COMPRESSOR AND WAS FIXING IT ON MONDAY 1/28/08. SAMSON SHUT DOWN THE COMPRESSOR OVER THE WEEKEND TO PROVIDE COMPLAINANT SOME RELIEF AND INDICATED THAT THEY WOULD NOT TURN IT ON AGAIN UNTIL REPAIRS WERE COMPLETE.

SW Field Inspector contacted Field Supervisor to check on repairs. Operator informed COGCC that sound walls had been installed and that a hospital grade muffler had also been installed. Operator indicated that these mufflers are required as part of their contract with compressor company but that this one had fallen through the cracks. Operator plans to have sound measurements taken again in the next couple of weeks and will forward a copy of results to SW Field Inspector. Operator indicated they had had no further contact with Complainant.

SW Field Inspector called Complainant and left a voice mail relaying message that Operator had installed sound walls and a hospital grade muffler to reduce noise levels. Inspector requested that Complainant contact her if issues still remained with noise.

SW Field Inspector contacted Complainant to get an update on noise levels after sound mitigation efforts by Operator. Compainant indicated that noise levels are much lower. Complainant stepped outside and took measurements while on the phone. At approximately 25 feet from residence he indicated that levels were reading 52 dbC which is a great improvement. He also indicated that he still gets quite a bit of noise from the nearby Williams plant but realizes this is a different issue. Complainant was pleased and agreed that Complaint can be closed out. Inspector asked him to please call back with any further issues. Complaint is now resolved.

I RECEIVED A CALL FROM LISA BRACKEN TODAY REGARDING THE DIVIDE CREEK GAS SEEP. SHE INDICATED THAT BUBBLING HAS INCREASED IN SOME AREAS AND HAS EXPANDED TO OTHER AREAS SINCE DRILLING ON THE O2 (SCHWARTZ) PAD HAS RESUMED. SHE WANTED TO LET THE COGCC KNOW OF HER CONCERNS.

SAMPLE REPORT (RECEIVED FROM ECA ON 11/26/07) DETAILS SAMPLE PROCEEDURES FOR COLLECTING BOTH WATER QUALITY AND GAS COMPOSITION AND ISOTOPIC SAMPLES.

SAMPLE REPORT RECIEVED FROM ECA REGARDING SAMPLING PERFORMED AT L. BRACKEN PROPERTY IN EARLY NOVEMBER. METHANE WAS OBSERVED IN BOTH SAMPLE LOCATIONS- 0.0041 MILLIGRAMS PER LITER (MG/L) AT EDC-1 AND 0.0089 MG/L AT EDC-2.

COMPOSITION SHOWS THAT THE GAS IN SAMPLE EDC-1 IS PREDOMINATELY METHANE (76.68 PERCENT) AND NITROGEN (18.26 PERCENT) WITH MINOR AMOUNTS OF OXYGEN (3.96 PERCENT), CARBON DIOXIDE (0.77 PERCENT), ARGON (0.326 PERCENT), AND ETHANE (0.0012 PERCENT). COMPOSITION ANALYSIS SHOWS THAT THE GAS SAMPLED AT EDC-2 CONSISTS MOSTLY OF METHANE (77.85 PERCENT) AND NITROGEN (15.12 PERCENT) WITH MINOR AMOUNTS OF OXYGEN (5.93 PERCENT), CARBON DIOXIDE (0.79 PERCENT) AND ARGON (0.308 PERCENT).

ISOTOPIC ANALYSIS SHOWS THAT BOTH METHANE GAS SAMPLES ARE OF BIOGNIC ORIGIN (SAMPLE EDC-1 DEL 13C - -53.35 PART PER MIL AND DEL D - -382.1 PART PER MIL) AND (SAMPLE EDC-2 - DEL 13C - -57.33 PART PER MIL AND DEL D - -382 PART PER MIL).

REPORT CONCLUSIONS ARE THAT BUBBLING ALONG PONDED AREAS OF THE CREEK IS DUE TO BIOGENIC METHANE GAS GENERATED BY DECAYING OF ORGANIC MATERIAL.
