2010 Light Goose Conservation Action Harvest Report

The 2010 Light Goose report provides information on the estimated harvest of light geese during the Conservation Action (CA) period. The light goose harvest survey no longer includes the regular light goose season. The light goose CA season is restricted to lands east of I-25. Due to questionable county harvest estimates, which result from low levels of response and dynamic harvest rates, harvest, hunter numbers and days are reported on a statewide basis, but are also provided for South and North of I-70. Information is provided on the use of electronic calls and extended hunting hours during the conservation action period. For 2010, a question on wounding loss was added at the request of the U.S. Fish and Wildlife Service, and a question was added to evaluate additional harvest obtained from the allowance of unplugged shotguns during the Conservation Action.

A post-season harvest survey was conducted by phone and internet. A stratified random sample of 4011 potential light goose hunters was drawn from among HIP participants. Individuals within the sample that provided email addresses to HIP were sent email surveys as well. The sample was stratified as follows:

- 1 = Did not hunt light geese in 2008/09
- 2 = Hunted light geese in 08/09 but did not bag geese
- 3 = Bagged 1-30 light geese in 08/09
- 4 = Bagged more than 30 light geese in 08/09

Harvest Data Summary


1,527 (38% response rate) hunters were contacted. 161 hunters reported hunting light geese during the conservation action period. Days hunted ranged from 1 (23 hunters) to 50 (1 hunter) and individual harvest ranged from 0 (1 hunters) to 455 (1 hunter). Fifty-three hunters reported that they wounded snow geese during the 2010 Conservation Action, ranging from 1 (23 hunters) to 8 (2 hunters). Thirty-eight percent reported being satisfied with their light goose hunting experience, compared to 85% in 2009. The leading reason for hunting during the conservation action period was "Environmental concerns" (30%), followed by "hunt unlimited geese" (23%) and "none of these reasons" (21%). Nearly 28% percent of hunters surveyed said they would be very likely to participate in future conservation action periods, while 49.2% were somewhat likely to participate and 23.1% were not at all likely to participate. **Statewide harvest for the conservation action period was estimated at 11,473 ± 1,688 (9,786 – 13,160).**

Comparison with 2009 survey results:

Comparing the figures for the conservation action period for both years, the estimated harvest was down from the 2009 CA when an estimated $23,072 \pm 2,442$ (20,629 - 25,515) birds were harvested. Hunter numbers were similar in 2009 ($1,951 \pm 408$) and 2010 ($1,988 \pm 392$). Total days hunted were also similar between 2009 ($8,744 \pm 1834$) and 2010 ($8,829 \pm 2,632$).

Hunter Statistics and Harvest by Strata, County and Population

Summary tables provide estimates of hunter numbers, days in the field and light goose harvest state and regionwide. Estimates are followed by the standard error of the estimate, and 95% upper (UCI) and lower (LCI) confidence intervals around the estimate.




