

## **2004 Spring Turkey Harvest Report**

**(Unlimited/Over the Counter Licenses)**

A post-season harvest survey was conducted by phone (CORIS).

**The statewide harvest estimate is  $1719 \pm 217$  (1501 - 1938).**

This is up from last year=s estimated harvest of  $1683 \pm 170$  (1513-1853). The difference is not significant at the 95% level.

We attempted to survey 20 percent (2212) of the over-the-counter turkey license holders. A total of 11,061 licenses were sold. 1158 hunters were contacted. Of these, 86% had hunted during the 2004 spring turkey season, while 14% had not. Of those who had hunted, 15% reported harvesting a bird. Sixty-six percent of birds arrested were mature birds and hunters reported low levels of wounding loss (<1%). Thirty-one percent of respondents hunted on both weekdays and weekends, whereas 13% hunted on weekdays only and 49% hunted on the weekends only (7% did not remember). Respondents were largely satisfied with their turkey hunting experience (81%) and we found that 70% felt there was not a crowding problem.

The harvest estimate information presented below gives either the county or game management unit, number of hunters contacted during the course of the survey who hunted in a given county, total number of hunters surveyed, number of over the counter licenses sold, estimated harvest (and associated standard error) and the upper and lower limits of a 95% confidence interval. So, for example, the estimated harvest for Archuleta county is 86 birds plus or minus 1.96(27) or 53. The estimate ranges from 33 birds (LCI) to 139 birds (UCI).
