RE: FY 10 Habitat Partnership Program Annual Report

As required by statute, attached please find the FY 10 report for the Habitat Partnership Program (HPP). HPP is authorized by the State Legislature and the Colorado Wildlife Commission to "reduce wildlife conflicts, particularly those associated with forage and fence issues, and to assist the Division of Wildlife in meeting game management objectives through duties as deemed appropriate by the Director." HPP is funded by 5% of big game (deer, elk, antelope, moose) license revenues from HPP areas, which in FY 10 was \$2,317,416. This amount was \$280,728 less than in FY 09.

In FY 10, 19 local HPP committees and the State Council, made up of more than 100 volunteer members representing livestock growers, sportsmen, federal land management agencies and the DOW met throughout the year across much of Colorado to cooperatively discuss and resolve conflicts between big game wildlife and agricultural operators. HPP has strong support at the local level due to the makeup of the local committees and their ability with dedicated funding to implement projects on the ground quickly. Two key benefits of the HPP program are the strong communication and dialogue that takes place among all participants with different perspectives and the subsequent partnerships that are developed to identify and resolve local problems.

As mentioned above, HPP's FY 10 budget was impacted by the decline in big game license sales. In addition to the decline of license revenues, matching contributions from our partners also declined. Despite this, \$2.11 million dollars of HPP money was leveraged with nearly \$5.47 million dollars of partner money and in kind services and more than 29,000 hours of labor were contributed by HPP partners in our efforts to reduce conflicts.

Local HPP committees are involved in many diverse projects, including habitat improvements and fencing materials. Habitat improvement projects are a priority for most committees and are seen as the best long term solution to resolving conflicts by improving range and habitat conditions for the long term for both wildlife and livestock. Typical habitat improvement projects include weed control, prescribed burning, fertilization, seeding, water developments and shrub and tree cutting and may occur on both public and private lands.

Resolving fence damage issues was one of the original purposes of HPP and most local committees furnish fence repair materials to landowners who have incurred damages. This continues to be very well received by landowners. Providing these materials acknowledges the ongoing damages landowners sustain from wildlife and the expenses that they incur to maintain their fences.

As you can see from the enclosed reports, HPP committees are involved in many different types of projects. The flexibility of HPP makes it an ideal program to resolve these challenges. HPP and our many active partners seek out and respond to local issues which continue to make this program a success.

The figures used in this report are gathered from projects approved in FY 10. If the project has been completed, actual costs and accomplishment figures are used. If the project is incomplete, original estimates provided at the time of approval are used. As approved projects are completed, it's likely that the final figures will change as accomplishments and costs are finalized.

Example 1: 360 acres were directly irrigated by HPP projects in FY10. Additionally, 81 separate water developments such as spring developments, pond creation and pond clearings were also done in addition to the projects that directly irrigated 360 acres.

Example 2: 10,436.75 acres of weed control was done in FY10. Additionally, 221 separate weed projects were also done to treat weeds, primarily by small random spot treatments across a larger area. If the acreage of the entire area had been used for these types of projects when only parts of the area had been actually treated, the accomplishments would have been inflated.

Glossary of Terms and Abbreviations

ADM – administrative projects, ie. committee administrative assistants, State Council and local committee meeting costs and supplies, etc.

EQP – equipment purchased by committees for project work. (Prior approval needed and there are limitations on use.)

FEN – fencing projects, ie. new construction, repairs (may be labor and/or materials) to existing fences in problem areas, etc.

GBL – grant budget ledger. For HPP projects, the 9 GBL's are used to categorize the type of project being done, ie. adm, eqp, fen, etc.

GDM – game damage projects, ie. new stackyard construction, repairs to existing stackyards (may be labor and/or materials), forage purchases, hunt coordinators

INF – information and education projects, ie. brochures, web sites, seminars, workshops, etc

MAN – habitat manipulation projects, ie. prescribed burns, brush/tree treatments, fertilization, reseeding, weed control, water developments, etc.

MTC – maintenance, ie. supplies and ongoing maintenance for HPP owned equipment.

OTH – conservation easement transaction costs and archeological clearances

RES – monitoring and research projects, ie. inventory, habitat, movement studies

Match \$ - actual dollars contributed by a cooperator to a project

In-Kind \$ - goods or services provided by a cooperator to a project that has a dollar amount calculated for it.

In-Kind Hours – time contributed by a cooperator to complete a project.

HPP Cost – actual HPP dollars approved by a committee for a project

Total Cost – sum of HPP cost, match \$ and in kind \$ contributed to a project

Private Cost – HPP dollars spent on private land projects

Public Cost – HPP dollars spent on public land projects
