RE: Habitat Partnership Program Annual Report – FY 2011

As required by statute, attached please find the FY 2011 report for the Habitat Partnership Program (HPP). HPP is authorized by the State Legislature and the Colorado Parks and Wildlife Commission to "reduce wildlife conflicts, particularly those associated with forage and fence issues, and to assist the Division of Wildlife in meeting game management objectives through duties as deemed appropriate by the Director." HPP is funded by 5% of big game (deer, elk, antelope, moose) license revenues from HPP areas, which in FY 11 was \$2,061,477, an 11% reduction from the FY 10 allocation.

In FY 11, 19 local HPP committees and the State Council, made up of more than 140 volunteer members representing livestock growers, sportsmen, federal land management agencies and CPW staff met throughout the year across much of Colorado to cooperatively discuss and work towards resolving conflicts between big game wildlife and agricultural operators.

As mentioned above, for the second consecutive year, HPP's FY 11 budget was impacted by the decline in big game license sales. Despite this, \$2.11 million dollars of HPP money was leveraged with \$6.8 million dollars, in kind services valued at more than \$3.6 million and more than 28,000 hours of labor from our project partners in our efforts to reduce conflicts and meet management objectives.

HPP has strong support at the local level due to the makeup of the local committees and their ability with dedicated funding to implement projects on the ground quickly. Two key benefits of the HPP program are the strong communication and dialogue that takes place among all participants with different perspectives and the subsequent partnerships that are developed to identify and resolve local problems. In addition to improving working partnerships, local HPP committees are involved in many diverse projects with two main ones being habitat improvements and fencing materials. Habitat improvement projects are a priority for most committees and are seen as the best long term solution to resolving conflicts by improving the quality and quantity of range and habitat resources for both wildlife and livestock. Typical habitat improvement projects include weed control, prescribed burning, fertilization, seeding, water developments and shrub and tree cutting and may occur on both public and private lands.

In the spring of 2011, the State Council awarded \$500,000 to 5 applicants for larger scale habitat improvement projects. This was the second time in three years that the State Council has offered this grant as a way to encourage larger scale projects which are more effective in distributing big game and livestock. The projects submitted and funded exemplified the strong and varied partnerships that HPP has developed as well as emphasizing habitat treatments as the preferred long term solution to many resource issues. These projects will be completed no later than June 30, 2012 with benefits to wildlife and agricultural operators alike.

One of the original purposes for HPP was to resolve fence damages caused by big game. One way that most HPP committees accomplish this is by furnishing fence materials to landowners to use to repair minor fence damages. These materials and the quick responsive processes committees have created to provide these materials continue to be very well received by landowners and remain an integral part of the program.

HPP has also been instrumental in working with affected landowners to create fences that work for both livestock and wildlife. A relatively new example of this that is receiving widespread use is the use of a colored top wire along a fence. While not affecting livestock usage, a highlighted top wire allows deer and elk to see the fence and then cross it with minimal or no damage to the fence or to the animal. This results in fewer fence repairs, fewer deer or elk getting caught in the fence and fewer cattle that are able to escape the pasture due to a damaged fence, all of which save a landowner time and money.

The figures used in this report are gathered from projects approved in FY 11. If the project has been completed, actual costs and accomplishment figures are used. If the project is incomplete, original estimates provided at the time of approval are used. As approved projects are completed, it's likely that the final figures will change as accomplishments and costs are finalized.

Glossary of Terms and Abbreviations

ADM – administrative projects, ie. committee administrative assistants, State Council and local committee meeting costs, supplies, etc.

EQP – equipment purchased by committees for project work. (Prior approval needed and there are limitations on use.)

FEN – fencing projects, ie. new construction, repairs (may be labor and/or materials) to existing fences in problem areas, etc.

GBL – for HPP projects, 9 GBL's are used to categorize the type of project being done, ie. ADM, EQP, FEN, GDM, INF, MAN, MTC, OTH, RES

GDM – game damage projects, ie. new stackyard construction, repairs to existing stackyards (may be labor and/or materials), forage purchases, hunt coordinators

INF – information and education projects, ie. brochures, web sites, seminars, workshops, etc.

MAN – habitat manipulation projects, ie. prescribed burns, brush/tree treatments, fertilization, reseeding, weed control, water developments, etc.

MTC – maintenance, ie. supplies and ongoing maintenance for HPP owned equipment.

OTH – conservation easement transaction costs and archeological clearances

RES – monitoring and research projects, ie. inventory, habitat, movement studies, project monitoring

Match \$ - actual dollars contributed by a cooperator to a project

In-Kind \$ - goods or services provided by a cooperator to a project that the cooperator has calculated a dollar value for it.

In-Kind Hours – time contributed by a cooperator to complete a project.

HPP Cost – actual HPP dollars approved and spent by a committee for a project

Total Cost – sum of HPP cost, matching funds and in kind funds contributed to a project

Private Cost – HPP dollars spent on private land projects

Public Cost – HPP dollars spent on public land projects
