# North Platte Basin Roundtable Education Action Plan

Approved: January 24, 2012

## **Background Information:**

In 2010-2011, the PEPO Workgroup assisted the basin roundtables in strengthening their education and outreach activities. By the end of 2011, each roundtable developed a functioning Education & Outreach Committee tasked with creating an Education Action Plan (EAP). The EAP details the educational goals and tasks most effective for the basin roundtable. It identifies roundtable member education activities that promote a well informed and high-functioning basin roundtable. It also defines public participation objectives and appropriate implementation methods.

In 2010-2012, the Colorado Foundation for Water Education worked with the North Platte Basin Roundtable by providing assistance in forming an Education & Outreach Committee and creating their Education Action Plan. To assist the North Platte Basin Roundtable in implementing their completed EAP, the Colorado Water Conservation Board created an application-based education fund. Having completed our EAP, the North Platte Basin has the opportunity to apply for up to \$1,800 in state funds per fiscal year for action plan implementation. The plan should be updated annually early each fiscal year.

- A) Success of 2012 educational activities will be evaluated using a speaker's bureau presentation post-evaluation survey to document knowledge gained about the North Platte River Basin by audience participants as a result of the presentation. Any community workshops will include a similar survey instrument.
- B) The North Platte Basin Roundtable will utilize the materials developed as part of this EAP as a basis for building a sustainable water education program in our Basin. Once the CFWE has developed speaker bureau materials, members will add current information to the presentation and make plans to revisit community groups to provide Basin updates. The resource materials will enhance our ability to share our Basin's story through a variety of venues i.e. newspaper articles, interpretive signage, youth programs, and during multi-basin events.
