REPORT.

TO HIS EXCELLENCY,
HON JOHN L. ROUNTT,
Governor of Colorado:

HON. SIR—It is with feelings of regret that I have no alternative, but to herewith present to you this mere subterfuge of a report, in which I am compelled to hold back, rather than set forth, important facts and figures pertaining to the progress of an industry which is one of the foremost in the category of Colorado's commonwealth, *if not King itself.*

The Eighth General Assembly enacted a law (Senate Bill No. 251) which prescribes that no reports, except those of elected State officers and State Engineer, should exceed twenty pages, and also limited the number of copies to 250. The fact is, that *anything* less than 150 pages and 2,500 copies would be insufficient, and in the near future it will be necessary for the Inspector to be allowed *200 pages* if he would do justice to himself, the State and the coal mining industry.

A bill was introduced before the Eighth General Assembly to govern the working of vertical coal veins, and to prohibit operators from mining coal under any portion of a mine, or in too close proximity to an abandoned mine where water exists, without having first pumped such water out. Such a law will apply to coal mines in Jefferson county, where there is now imminent danger from inundation of water, if the practice of mining coal is continued under flooded levels. It would be a very hard matter to define what thickness of a pillar should be left to guard against inundation. The mining law prescribes that drill holes shall be kept ahead of the working face, at least twelve feet, when in proximity to abandoned workings where water is sus-

pected to exist ; and while such a precaution may be all that is necessary in horizontal veins, yet such would be of little service in vertical ones.

From my experience, I would not consider a 100-foot pillar an absolute safeguard, for I believe it quite possible, especially where soft material lies between the coal and "foot" wall, for the coal to become freed so as to break and "run" to a sufficient degree as to cause cracks to reach through the pillar, and thus water, under heavy pressure, would quickly make its way through in great volumes ; so mining in a vertical vein, under a body of water, cannot be followed with safety, and should be prohibited by law. A bill will be presented to the coming Legislature to regulate the above, which, it is hoped, will pass and become a law.

RECAPITULATION OF STATISTICS FOR
1891-1892.

For the years ending December, 1891-1892, the returns of the coal production made to this office, with estimate made for December, 1892, is as follows:

For 1891 there was produced 3,512,632 tons (of 2,000 lbs.); of this amount about 1,005,000 tons were shipped out of the State to points in Kansas, Texas, Nebraska, Utah and Montana. The average market value of the coal is estimated at \$1.68 per ton, making the spot cash value of the production at the mines \$5,901,221.76. The average number of persons employed during the year was 6,822. Average thickness of the coal seams worked is 8 feet, the thickest is 30 feet, and the thinnest 2 feet. The average tonnage price paid to miners is 78 cts. for 2,400 lbs. "run of mine" coal; the highest tonnage price being \$1.12½ and the lowest 50 cts. The average cost of producing the coal is estimated at \$1.42, including royalty. There occurred during the year 29 fatal accidents in which 30 lives were lost; six by falls of coal, 17 by falls of rock, 2 from injuries received by pit cars, 2 by premature blasts, 2 by explosions of gas and 1 by accidental hanging.

By nationality, there were two Austrians, one Bohemian, ten Italians, one German, three Frenchmen, four Englishmen, four Irishmen, two Scotchmen, one Mexican and two whose nationality is unknown.

Average number of tons mined for each life lost, 121,126; average number of persons employed to each fatal accident, 227 2-5.

There occurred during the year 129 non-fatal accidents; 79 by falls of coal and rock, 5 by falling props, 28 by pit cars, 3 by railroad cars, 4 by premature blasts, 1 by steam pump, 3 by mules, 1 by coal pick, 3 by hoisting cage, 1 by pit-lamp exploding, 1 by falling down slope and 1 by gas explosion. Average number of tons mined to each non-fatal accident, 27,230; number of persons employed to each non-fatal accident, 53. There was 280,519 tons of coke made during the year.

For 1892 the production is 3,771,234 tons of 2,000 pounds. Of this amount there has been shipped to Kansas, Nebraska, Texas, Utah, California and Montana about 1,200,000 tons. The spot cash value of the production of coal at the mines is \$6,222,536.10. The average number of persons employed at the mines during the year is 7,578. The average tonnage price paid

to the miners for digging and loading the coal and timbering their working places is 75 cents per ton of 2,400 pounds of "run of mine" coal; the highest is \$1 per ton and the lowest 50 cents.

There were 34 lives lost during the year; 10 by falls of coal, 11 by falls of rock, 2 by premature blasts, 2 by explosion of gas, 2 by pit cars, 2 by hoisting cage, 2 by blown out shots (causing an explosion of gas and coal dust), 1 by falling off a bucket in a sinking shaft, 1 by being struck at the bottom of a sinking shaft by a falling bucket, and 1 who died from heart disease. By nationality there were 12 Italians, 4 Austrians, 1 Bohemian, 1 Mexican, 1 American, 5 English, 3 Irish and 7 Scotch. Average number of tons mined to each life lost is 110,330; average number of persons employed to each life lost 223. There occurred 125 non-fatal accidents; 40 caused by falls of coal, 38 by falls of rock, 26 by pit cars, 1 by falling pit props, 2 by explosion of gas, 3 by hoisting cage, 3 by mules, 1 by fly-wheel of engine, 1 burned by hot water, 1 by a coal pick, 1 by mule chain, 3 by falling down "manways," 1 by blown out shot, 4 by premature blasts. Average number of tons mined to each non-fatal accident, 30,170; average number of persons employed to each non-fatal accident, 61.

There was 355,095 tons of coke made during the year, being an increase of 74,576 tons over 1891.

March 23—Joseph Heck, at Crested Butte mine, Colorado Coal and Iron Co., Gunnison county; killed by a fall of rock.

March 26—George Parela, at Marshall mine No. 5, Marshall Coal Co.; killed by a fall of rock.

April 2—James Muldoon, at Simpson mine, United Coal Co., Boulder county; killed by a fall of coal.

April 3—Thomas Gallagher, at Rockvale mine No. 7, Canon City Coal Co., Fremont county; killed by a premature blast.

May 19—George Isaacs, at Acme mine, Acme Coal Co., Boulder county; killed by a fall of rock.

June 1—Domnick Bertino, at Road Canon mine, Colorado Coal and Iron Co., Las Animas county; killed by a fall of rock.

June 3—Felix Lotine, at El Moro mine, Colorado Coal and Iron Co., Las Animas county; fatally injured by a fall of slate. Died on the 5th inst.

July 21—George Simmonds, at Como mine No. 5, Union Pacific Coal Co., Park county; killed by a premature blast.

July 25—Mike Jennings, at Spring Gulch mine, Grand River Coal and Coke Co., Pitkin county; killed by a fall of slate.

August 28—John Smith, at Rouse mine, Colorado Fuel Co., Las Animas county; fatally injured by being struck by a trip of cars. Died September 5.

September 2—James Politano, at Victor mine No. 3, Victor Coal Co., Las Animas county; fatally injured by a fall of slate. Died 4th inst.

September 12—Frederick Beach (a trapper boy), found dead hanging to a rope. It is supposed he accidentally hanged himself while playing with a rope; accident occurred at Coal Creek mine No. 2, Colorado Coal and Iron Co., Fremont county.

September 25—Thomas Chido, Cameron mine, Colorado Coal and Iron Co., Huerfano Co.; fatally injured by a piece of coal from a blast. Died 25th inst.

October 8—Joseph Bezot, at Rouse mine, Colorado Fuel Co., Las Animas county, killed by a fall of rock.

October 14—Frank Desideris, at Cameron mine, Colorado Coal and Iron Co., Huerfano county; killed by a fall of rock.

October 24—Jano Bartholemew and Mike Williams, at Coal Ridge mine, Colorado Fuel Co., Garfield county; killed by an explosion of gas and coal dust. Said to be under assumed names.

November 11—Guiseppe Antonelli, at Road Canon mine, Colorado Coal and Iron Co., Las Animas county; killed by a fall of slate.

November 12—Alex. McDonald, at Marion mine, Grand River Coal and Coke Co., Garfield county; thigh bone broken by a piece of coal from a chute. It appears that Alex. McDonald was put under the influence of opiates, and never became conscious again.

November 28—John Gradisen, at Crested Butte mine, Colorado Coal and Iron Co., Gunnison county; killed by a fall of coal.

November 30—James Duggan, at Anthracite mine, Colorado Fuel Co., Gunnison county; killed by a fall of rock.

December 5—James Cox, Anthracite mine, Gunnison county; killed by a fall of rock.

December 8—Acon Vittoria, Rouse mine, Huerfano county; killed by a fall of rock.
