- On June 3, 2015, the ALJ issued a Preliminary Recommendation recommending that a hearing be granted.

Matthew Saldana v. Department of Human Services, 2016G006 – No finding of a violation of Colorado's whistleblower statute, § 24-50.5-101, et seq., C.R.S.

- On July 15, 2015, Complainant filed a petition for hearing regarding a six month pay reduction in retaliation for his disclosure of the Center's receipt of payments for a non-Medicaid approved client, a violation of the Whistleblower Act. He additionally claimed sexual harassment. On November 17, 2015, a second appeal was filed for termination due to retaliation for the same disclosure. The cases were consolidated.
