Dear Governor Ritter, Senator Hodge and Senator Schultheis:

The Annual Travel Expense Report for the fiscal year ended June 30, 2010 is now available on the State Controller's website, [www.colorado.gov/dpa/dfp/sco/travel.htm](http://www.colorado.gov/dpa/dfp/sco/travel.htm). This report is provided in accordance with Section 24-30-202(26), C.R.S. Please call our office at 303-866-6200 if you would like a copy of the report.

Exhibit A shows the total travel expenses incurred by state employees by the categories of in-state travel, out-of-state travel, and out-of-country travel. The travel expenses are allocated to general, cash and federal funding sources. The exhibit also shows the total number of vehicle miles traveled, categorized by two-wheel drive and four-wheel drive.

Exhibit B shows the travel expenses incurred by state employees for each department. Travel expenses are allocated to general, cash and federal funding sources.

**Total Employee Travel Expenses** - Total travel expenses incurred by state employees was \$66,172,147, down \$1,552,841 or 2.3% from the previous fiscal year.

**Methodology** - The travel expense report was compiled based on information submitted by each State Department. All reported expenditures have been reconciled with the travel expenditures recorded on the State's accounting system.
