Dear Governor Hickenlooper, Senator Steadman, and Representative Acree:

In accordance with CRS 24-75-204(2), attached is a report of loans and advances as of June 30, 2012. This report shows the outstanding loans and advances provided by the State Treasury to state agencies and institutions of higher education for a wide range of activities including enterprise operations and cash funded state programs.

Loans and advances outstanding at fiscal year-end totaled \$7.0 million. This is a decrease of approximately \$9.1 million from the June 30, 2011 balance of \$16.1 million, and the balance is primarily related to the cash deficits for the GOCO Distribution for the Division of Parks and Wildlife. This decrease is a result of fewer grant expenditures toward year-end related to real property acquisitions. Interest on each loan is computed based on the monthly earnings rate on the treasury pool and interest is not charged on advances.

In accordance with the filing requirements contained in the Information Coordination Act enacted in Senate Bill 12-152, we will also distribute the report to the State and Legislative Libraries.

This report is for informational purposes and no further action is required.
