Dear Sirs and Madams:

Pursuant to CRS 24-77-106.5(b), I hereby certify that the unaudited state revenues, subject to Article X, Section 20 (TABOR) of the state constitution, do not exceed the TABOR limitation. State revenues not exempt from TABOR total \$7,679,497,455, while the adjusted TABOR limit for Fiscal Year 2002-03 is \$8,299,236,821.

Revenues, not exempt from TABOR, are \$619,739,366 below the TABOR Fiscal Year Spending limitation.

Attached is a schedule of General and Program non-exempt TABOR revenues comparing the current fiscal year to last fiscal year. Total revenues not exempt from TABOR for Fiscal Year 2002-03 was less than the previous fiscal year by 0.9 percent.
