



RESOLUTION NO. 91

RESOLUTION OF THE TOWN OF IGNACIO
TO ESTABLISH THE IGNACIO COMMUNITY LIBRARY DISTRICT

WHEREAS, the Town of Ignacio is a "governmental unit" as defined in CRS 24-90-103, and

WHEREAS, the Board of Trustees of the Town of Ignacio has determined that it is in the best interests of the citizens of the Town of Ignacio and surrounding area to establish a community public library, and

WHEREAS, the Town of Ignacio desires to cooperate with La Plata County and other governmental entities to establish such a public library, and

WHEREAS, the method of establishing a library district is set forth in CRS 24-90-101 et seq. and the Town desires to utilize the provisions of such sections to establish a public library, and

WHEREAS, public hearings were held by the Town of Ignacio and by La Plata County on November 27, 1990 in Oxford; November 28, 1990 in Allison; and November 29, 1990 in Ignacio, following proper notice,

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Town of Ignacio as follows:

1. The Board of Trustees of the Town of Ignacio, in cooperation with The Board of County Commissioners of La Plata County, hereby establishes the "Ignacio Community Library District" pursuant to CRS 24-90-101 et seq.
2. The service area of the library shall be all of the area included in the Ignacio School District 11 Joint R located in La Plata County, Colorado. A complete description of the areas to be included in the service area of the library is attached hereto as Attachment A and incorporated herein by this reference.
3. A mill levy of ^{max} 1.0 mils, as provided in CRS 24-90-112(1)(A)(II) shall be imposed for the 1991 tax year to be collected in 1992, and thereafter, to fund the operations of the library.
4. The library operated by the Library District shall be dedicated to the memory of Butch McClanahan and shall be called "The Butch McClanahan Memorial Library."
5. The Town of Ignacio shall enter appropriate agreements

with La Plata County and the Library Board of Trustees, following the appointment of the Board of Trustees, for the operation of the Library pursuant to CRS 24-90-107(2)(E).

- 6. The Library has adequate funding from grants and other sources to operate for 1991 and that portion of 1992 until tax revenues are available to the Library District.
- 7. The Board of Trustees hereby appoints Gerardo Silva and Terry Gillespie to a committee to appoint the initial Board of Trustees of the Library District, as required by CRS 24-90-108(C).
