

# Department of Public Safety Line Item Descriptions

FY 2021-22 Budget Request

**NOVEMBER 2, 2020** 

## (1) EXECUTIVE DIRECTOR'S OFFICE

#### (A) Administration

#### **Personal Services**

This line item funds personnel costs for the Executive Director's Office (EDO). The EDO is responsible for essential duties that impact the department. The office provides the Colorado Department of Public Safety (CDPS) with operational management direction, policy formulation and core internal functions in the areas of financial services, human resources, communications, legislative relations, and logistics. In addition, the internal support functions of Budget, Accounting, Human Resources, the Public Information Officer and the Legislative Liaison interact with agencies statewide in many areas, including common policies, billing and Colorado Open Records Act requests.

#### Health, Life, and Dental

This line item provides funding for Health, Life, and Dental insurance for employees of CDPS, adjusted annually for common policy growth.

## **Short-Term Disability**

This line item provides funding for Short-Term Disability insurance for employees of CDPS, adjusted annually for common policy growth.

#### **Amortization Equalization Disbursement**

This line item provides funding in accordance with S.B. 04-257, which created the Amortization Equalization Disbursement. This appropriation is intended to shrink the unfunded liability within the Colorado Public Employees' Retirement Association, and adjusts annually in accordance with S.B. 04-257 and common policy growth.

## Supplemental Amortization Equalization Disbursement

This line item provides funding in accordance with S.B. 06-235, which created the Supplemental Amortization Equalization Disbursement. This appropriation is intended to shrink the unfunded liability within the Colorado Public Employees' Retirement Association, and adjusts annually in accordance with S.B. 06-235 and common policy growth.

## **PERA Direct Distribution**

Pursuant to S.B. 18-200, this line item provides funding for CDPS' portion of the annual direct distribution payment of \$225 million to the Colorado Public Employees' Retirement Association, to help eliminate the unfunded liability for the State, Judicial, School and Denver Public School divisions.

## Salary Survey

This line item provides funding for annual pay increases for CDPS employees as part of the Salary Survey process, adjusted annually for common policy growth.

## Merit Pay

This line item provides funding for annual pay increases for CDPS employees as part of the Performance-Based Pay process, adjusted annually for common policy growth.

#### Shift Differential

This line item provides funding for increased Shift Differential compensation for employees who work "swing" and "graveyard" shifts, adjusted annually for common policy growth as directed by Department of Personnel and Administration (DPA).

# Workers' Compensation

This line item funds Workers' Compensation insurance payments for all CDPS divisions. The amounts requested and appropriated are determined by statewide common policy.

#### **Operating Expenses**

This line item funds non-personnel operating expenses for the Executive Director's Office.

# **Legal Services**

This line item funds payments to the Attorney General's Office for legal services provided to CDPS. The total number of hours to be paid, along with the compensated hourly rate, is set by statewide common policy.

# Payment to Risk Management and Property Funds

This line item funds payments to DPA for risk management services and property insurance. This appropriation is set by statewide common policy.

#### Vehicle Lease Payments

This line item funds payments to DPA for vehicles employed by the EDO, the Division of Fire Prevention and Control(New Division in FY 2012-13), Division of Homeland Security and Emergency Management (New Division in FY 2012-13) and the Division of Criminal Justice. In addition, this line contains appropriations for the vehicles used in service of the Governor, the First Lady, the First Family, and the Lt. Governor. This appropriation is set by statewide common policy, and may be increased or decreased by individual decision items.

## **Leased Space**

This appropriation funds leased space payments for non-state-owned buildings occupied by CDPS. Appropriations in this line typically remain stable, but may be changed by decision item from time to time.

## Capitol Complex Leased Space

This appropriation funds leased space payments for all state-owned buildings occupied by CDPS. This appropriation is set by statewide common policy, and may be increased or decreased by individual decision items from time to time.

#### Payments to OIT

This appropriation funds payments made to Office of Information Technology (OIT) for the delivery and support of multiple services. The services included in this line are: the Statewide Digital Trucked Radio Network, Information Technology Services, back office support, the General Government Computer Center within OIT, and the Statewide Multiuse Network.

## **CORE Operations**

This appropriation funds payments made to OIT for the support of building a new Statewide financial system (CORE). This appropriation is set by statewide common policy. This appropriation was new for FY 2012-13.

## **Lease Purchase Payments**

This line item, pursuant to S.B. 15-251, provides funding for payments of lease-purchase agreements of the two Colorado Bureau of Investigation (CBI) facilities in Grand Junction and Pueblo.

#### **Utilities**

This line item provides funding for utilities payments made by CDPS for buildings it occupies. The appropriation for this line item has remained stable for several years, but changed in FY 2012-13, due to the passage of H.B. 12-1019 and in FY 2014-15 with the consolidation of utilities from DPA.

#### **Distributions to Local Government**

This line item provides spending authority for any unused monies in the Hazardous Materials Safety Fund. Section 42-20-107 C.R.S. provides that any unexpended monies in the Fund at year-end shall be transferred to the Department of Public Safety for distribution to local governments' fire protection programs.

## (B) Special Programs

(1) Witness Protection Program

#### Witness Protection Fund

This line item provides funding for General Fund payments into the Witness Protection Fund, which is created in section 24-33.5-106 C.R.S. This line item was created as part of the FY 2006-07 Long Bill to clarify the difference between appropriations *to* the fund and expenditures *from* the fund.

# Witness Protection Fund Expenditures

This line item provides spending authority for monies in the Witness Protection Fund. This line item was created as part of the FY 2006-07 Long Bill to clarify the difference between appropriations *to* the fund and expenditures *from* the fund.

(2) Colorado Integrated Criminal Justice Information System (CICJIS)

#### Personal Services

This line item funds personnel costs for the Colorado Integrated Criminal Justice Information System Program. The CICJIS develops and maintains criminal justice services that promote cost effective information sharing with timely and appropriate access, avoiding unnecessary duplication, while maintaining information security. CICJIS is a collaborative program designed to facilitate information sharing at key decision points in the criminal justice process, across the boundaries of organizations and jurisdictions among the State criminal justice agencies to enhance public safety, improve decision making, increase productivity and improve access to information.

## **Operating Expenses**

This line item funds non-personnel operating expenses for CICJIS.

## (3) School Safety Resource Center

## **Program Costs**

This program item was created by S.B. 08-001, augmented by H.B. 08-1267, and added to the Long Bill in FY 2009-10. The Colorado School Safety Resource Center is to collaboratively assist local schools and communities to create safe and positive school environments for Colorado students in all pre-k through higher education schools.

# (2) COLORADO STATE PATROL

## Colonel, Lt. Colonels, Majors, and Captains

This line item funds personnel costs for commanders (the Colonel, Lt. Colonels, Majors, and Captains) within the Colorado State Patrol (CSP).

#### Sergeants, Technicians, and Troopers

This line item funds personnel costs for most Sergeants, Technicians, and Troopers within the Colorado State Patrol.

## Civilians

This line item funds personnel costs for most Civilian support staff within the Colorado State Patrol.

#### Retirements

This line item funds sick and annual leave payouts for members of the CSP who either retire or separate from State employment.

#### <u>Overtime</u>

This line provides dedicated funding for overtime payments made to Colorado State Patrol Troopers.

#### **Operating Expenses**

This line item funds the majority of all operating expenses for CSP operations, including per-mile fleet vehicle charges.

## Information Technology Asset Maintenance

This line item has traditionally funded ongoing operating and maintenance costs for the CSP's Mobile Data Computers (MDC), including back-end hardware and software, as well as regular replacement of MDC terminals and annual upgrades for the CSP's Computer-Aided Dispatch and Records Management Systems.

## Vehicle Lease Payments

This line item funds payments to DPA for vehicles employed by the CSP and Port of Entry.

# Ports of Entry

This program transferred to the Department by H.B. 12-1019, and will be added to the Long Bill in FY 2013-14. This line item funds the personal and operating expenses for the Port of Entry Program. The CSP will be the primary entity charged with motor carrier safety services, improving roadway safety and business processes for motor carriers. This line item will provide funding for the

Colorado Port of Entry organization. The Colorado Port of Entry maintains 17 fixed port facilities and ten mobile units, used to enforce state and federal size, weight, and safety regulations.

## **Communications Program**

This line item funds the personal services and operating expenses costs for the CSP's Communications program, which provides police dispatching services to the CSP, along with several other agencies throughout the State.

## **State Patrol Training Academy**

This line item funds the personal and operating expenses for the CSP's Training Academy. The Academy provides initial, recurrent and specialized training for Troopers as well as for other law enforcement agencies and assists local community colleges with their police officer training programs.

## Safety and Law Enforcement Support

This line item includes funding for the CSP's garage operations for maintenance and outfitting of CSP vehicles. In addition, the line item includes spending authority for "special events" road and lane closures performed by the CSP, including closures for Department of Transportation maintenance operations, along with closures and security for external entities such as "Ride the Rockies", The US Pro Cycling Challenge, and the Denver Broncos.

#### Aircraft Program

This line item funds the CSP's aircraft operations, which include both traffic safety activities, and passenger carrier services for State agencies.

#### Executive and Capitol Complex Security Program

This line item funds the CSP's Executive and Capitol Complex Security Program, which provides protection to the State Capitol, Capitol Complex Buildings, the Governor, the First Family, and the Lt. Governor.

#### Hazardous Materials Safety Program

This line item funds the CSP's Hazardous Materials Safety Program, which provides scheduling, routing, permitting, and inspection of commercial vehicles carrying hazardous and nuclear materials, as well as clean-up and mitigation capabilities for hazardous materials spills.

## **Automobile Theft Prevention Authority**

This line item provides spending authority for the Colorado Automobile Theft Prevention Authority (CATPA). The CATPA board awards grants in support of auto theft prevention, enforcement, prosecution and training projects.

#### Victim Assistance

This line item provides funding for the CSP's Victim Assistance program, which provides support and services to victims of crime on Colorado's highways (such as vehicular homicide).

## **Counter-Drug Program**

This line item provides spending authority for the CSP to operate the federal 1122 program. This program allows local agencies to purchase law enforcement equipment from vendors using federal government price agreements.

## Motor Carrier Safety and Assistance Program Grants

This line item is included in the Long Bill for informational purposes only, and provides an estimate of expected federal spending authority for federal Motor Carrier Safety and Assistance Program grants. This CSP program is aimed specifically at increasing enforcement of traffic laws for commercial motor vehicle carriers in Colorado.

#### Federal Safety Grants

This line item is included in the Long Bill for informational purposes only, and provides an estimate of expected federal grants for the CSP.

## **Indirect Cost Assessment**

This line item represents the projected collection of indirect cost recoveries for CSP programs operated with non-General-Fund sources of revenue.

## (3) DIVISION OF FIRE PREVENTION AND CONTROL

#### **Personal Services**

This line item funds personnel costs for the Division of Fire Prevention and Control (DFPC), as restructured pursuant to H.B. 12-1283.

## **Operating Expenses**

This line item funds operating expenses for the DFPC, as restructured pursuant to H.B. 12-1283.

#### Appropriation to the Wildfire Preparedness Fund

This line item provides a mechanism to appropriate moneys into the Wildfire Preparedness Fund from the tax on premiums collected from insurance companies pursuant to Section 10-3-209 (4)(a)(II), C.R.S.

## Wildland Fire Management Services

This line item funds both personal services and operating expenses for the DFPC Wildland Fire Management Services.

## Appropriation to the Local Firefighter Safety and Disease Prevention Fund

This line item provides the mechanism to award grants to governing bodies to provide or reimbursement for equipment and training designed to increase firefighter safety and prevent occupation-related diseases

#### **Indirect Cost Assessment**

This line item represents the projected collection of indirect cost recoveries for the DFPC programs operated with non-General-Fund sources of revenue.

## (4) DIVISION OF CRIMINAL JUSTICE

# (A) Administration

#### DCJ Administrative Services

This line item funds personnel and operating costs for several functions within the Division of Criminal Justice (DCJ). This includes the Office of Community Corrections, the Office of Research and Statistics, the Office of Domestic Violence Offender Management, the Office for Victims Programs, and DCJ's administrative unit, and the various functions comprising the DCJ Administration appropriations.

#### **Indirect Cost Assessment**

This line item represents the projected collection of indirect cost recoveries for the DCJ programs operated with non-General-Fund sources of revenue.

#### (B) Victims Assistance

## Federal Victims Assistance and Compensation Grants

This line item is included in the Long Bill for informational purposes only, and provides an estimate of expected federal grants within DCJ for Victims Assistance and Victims Compensation grants.

## State Victims Assistance and Law Enforcement Program

This line item provides spending authority for DCJ to distribute proceeds from the State Victims Assistance and Law Enforcement (VALE) Fund. Recipients of VALE funds are required to use them in support of programs that provide services and compensation to victims of crime.

#### **Child Abuse Investigation**

This line item provides spending authority for funds from the Child Abuse Investigation Surcharge Fund, created as part of H.B. 06-1058. The Fund is intended to support training and enhanced services in programs that coordinate a multi-disciplinary team response for child sexual abuse intervention.

#### Sexual Assault Victim Emergency Payment Program

This line item provides funding for emergency payments for victims of sexual assault who need additional time to determine whether or not they wish to pursue legal action. The program is intended to be the payor of last resort for victims who require financial assistance to pay the costs of a medical forensic exam. This was implemented through the passage of H.B. 13-1163.

#### Statewide Victim Information and Notification System (VINE)

This line item is provides funding for the Statewide Victim Information Notification System (VINE). This system is operated by the County Sheriffs of Colorado. The system allows crime victims and other concerned citizens to access timely and reliable information about criminal cases and the custody status of offenders 24 hours a day via telephone, internet or electronic mail. This was implemented through the passage of H.B. 13-1241.

## (C) Juvenile Justice and Delinquency Prevention

## Juvenile Justice Disbursements

This line item is included in the Long Bill for informational purposes only, and provides an estimate of expected federal grants within DCJ for Juvenile Justice Programs.

#### Juvenile Diversion Programs

This line item funds a program within DCJ to provide grants to local District Attorneys' Offices for the administration of Juvenile Diversion programs. These programs are intended as an alternative to prosecution for low-level, nonviolent juvenile offenders.

# **(D) Community Corrections**

# **Community Corrections Placements**

This line item funds several Community Corrections Provider Programs. This line item provides funding for the following Community Corrections programs:

- Transition beds to house offenders transitioning out of Department of Corrections (DOC) facilities in halfway houses.
- Diversion beds to house offenders sentenced directly by the court to halfway houses.
- Transition Mental Health Bed Differential payments for specialized mental health services for Community Corrections Transition offenders.
- Diversion Mental Health Bed Differential payments for specialized Mental Health services for Community Corrections Diversion offenders.
- Differential payments for specialized Mental Health services for Community Corrections offenders in the 15-bed John Eachon Re-entry Program (JERP)
- Outpatient community programs for Community Corrections offenders who have "graduated" from residential therapeutic community treatment facilities

## Correctional Treatment Cash Fund Residential Placements

This line item provides funding for 48 condition-of-probation placements.

#### **Community Corrections Facility Payments**

This line item funds the per-facility fees that are a component of the two-part payment system for Community Corrections. This line provides General Funds for the 34 facilities and the associated daily fee.

## Community Corrections Boards Administration

This line item funds payments to local Community Corrections boards for the administration of Community Corrections programs. The appropriation is set by calculating 4.0 percent of qualifying Community Corrections appropriations.

#### Services for Substance Abuse and Co-occurring Disorders

Provides specialized substance abuse treatment services for offenders in intensive residential treatment programs, therapeutic communities, and Drug Abuse Residential Treatment Program (DART).

## **Specialized Offender Services**

This line item funds payments to Community Corrections providers to provide specialized services to high-risk Community Corrections offenders such as sex offenders and mentally-ill offenders.

#### Offender Assessment Training

This line item funds a 4-day series of formal classroom training in Risk/Needs assessment, Risk/Needs/Responsivity Theory, Principles of Effective Intervention for Offenders, and Evidence Based Practice Instruction.

# (E) Crime Control and System Improvement

## State and Local Crime Control and System Improvement Grants

This line item is included in the Long Bill for informational purposes only, and provides an estimate of expected federal grants within DCJ for crime control and system improvement.

## Sex Offender Surcharge Fund Program

This line item provides spending authority for dollars in the Sex Offender Surcharge Fund. This program provides staff and operating support for the Sex Offender Treatment Board.

#### **Sex Offender Supervision**

This line item funds the Sex Offender Supervision program, which develops criteria, standards, training, and assistance to local agencies concerning the lifetime supervision of sex offenders.

#### **Treatment Provider Criminal Background Checks**

This line item provides spending authority from the Domestic Violence Offender Treatment Provider Fund and the Sex Offender Treatment Provider Fund so that DCJ may perform statutorily-required background checks on sex offender and domestic violence offender treatment providers.

#### Federal Grants

This line item is included in the Long Bill for informational purposes only, and provides an estimate of expected federal grants within DCL.

#### **EPIC Resource Center**

This line funds the Evidence-Based Practices Implementation for Capacity (EPIC) Resource Center. EPIC is a collaboration of agencies that include: CDPS, the Departments of Corrections (DOC), Human Services (DHS), and the Judicial Department. EPIC offers education, skill-building, and other resources to individuals working with adult and juvenile offenders.

#### **Criminal Justice Training**

This line item provides spending authority for fees collected by the Colorado Regional And Community Policing Institute and deposited into the Criminal Justice Training Fund.

#### Methamphetamine Abuse Task Force

This line item provides spending authority for gift and grant revenue in the Methamphetamine Abuse Task Force Fund. The first permanent appropriation occurred in the FY 2009-10 Long Bill. In FY 2018-19, S.B. 18-071 extends the repealed date for the task force from July 1, 2018 to September 1, 2028.

#### (5) COLORADO BUREAU OF INVESTIGATION

## (A) Administration

#### **Personal Services**

This line item funds personnel costs for the Colorado Bureau of Investigation's (CBI) administrative office, including the CBI director, budget and support staff.

## **Operating Expenses**

This line item funds non-personnel operating expenses for the CBI administrative office.

## Vehicle Lease Payments

This line item funds payments to DPA for vehicles employed by the CBI investigations and forensic laboratory services. This appropriation is set by statewide common policy, and may be increased or decreased by individual decision items.

## Federal Grants

This line item is included in the Long Bill for informational purposes only, and provides an estimate of expected federal grants within the CBI.

#### **Indirect Cost Assessment**

This line item represents the projected collection of indirect cost recoveries for CBI programs operated with non-General-Fund sources of revenue.

## (B) Colorado Crime Information Center (CCIC)

## (1) CCIC Program Support

## Personal Services

This line item funds personnel costs for the CBI's Program Support Unit, which generally provides support to statewide law enforcement users of the CCIC.

## **Operating Expenses**

This line item funds non-personnel operating expenses for the CBI Program Support Unit.

## (2) Biometric Identification and Records Unit

#### Personal Services

This line item funds personnel costs for the CBI's Identification unit, which provides fingerprint-and name-based identification services for law enforcement and civilian employment purposes.

#### **Operating Expenses**

This line item funds non-personnel operating expenses for the CBI Identification Unit.

#### Lease/Lease Purchase Equipment

This line item funds lease and lease-purchase expenses for equipment employed by the CBI Identification Unit.

## (3) Information Technology

This line item funds operating expenses for the CBI Information Technology (IT) section. This line item was consolidated from the FY 2010-11 operating expenses line item due to the OIT consolidation. This line item provides funding for annual maintenance agreements for CBI systems such as CCIC, CommVault, and Oracle, just to name a few.

#### (C) Laboratory and Investigative Services

#### **Personal Services**

This line item funds personnel costs for the CBI's Laboratory and Investigative Services units. These units provide investigative assistance to local law enforcement agencies and district attorney's offices in the areas of major crimes, Limited Gaming, laboratory analysis, missing children, among several others.

#### **Operating Expenses**

This line item funds non-personnel operating expenses for the CBI Laboratory and Investigative Services units.

#### Overtime

This line item funds overtime costs for the CBI's Laboratory and Investigative Services units. These units provide investigative assistance to local law enforcement agencies and district attorney's offices in the areas of major crimes, Limited Gaming, laboratory analysis, missing children, among several others.

## Complex Financial Fraud Unit

This line item provides spending authority from the Colorado Identity Theft and Financial Fraud Cash Fund for the personnel and operating expenses costs for the CBI's Complex Financial Fraud Unit. This unit is charged with investigating cases of identity theft within Colorado.

## Lease/Lease Purchase Equipment

This line item funds lease and lease-purchase expenses for equipment employed by the CBI Laboratory and Investigative Services Units.

#### (D) State Point of Contact - National Instant Criminal Background Check Program

#### **Personal Services**

This line item funds personnel costs for the CBI's InstaCheck unit, which provides "instant" criminal background checks for the purpose of approving firearms purchases and concealed carry weapons permits.

## **Operating Expenses**

This line item funds non-personnel operating expenses for the CBI InstaCheck section.

## (6) DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT

# (A) Office of Emergency Management

## **Program Administration**

This line item funds personal services and operating expenses for the Division of Homeland Security and Emergency Management (HSEM), including all operating costs for the State Emergency Operations Center (SEOC).

## Disaster Response and Recovery

This line item funds disaster specific response and recovery funds to local governments or other state or federal program eligible grantees/recipients impacted by disasters; including State Disaster Fund Executive Order authorizations and federal post-disaster program funds when a Presidential Disaster or Emergency Declaration is made.

#### Appropriation to the DEF 2013 Flood Recovery Account

This is a multi-year request starting in FY 2017-18 through FY 2020-21 to pay for the ongoing costs associated with the response and recovery for the September 2013 flooding across the Front Range.

#### **Preparedness Grants and Training**

This line item provides local governments or state agencies federal grant funds for the purpose of improving emergency management programs and preparedness and training levels throughout their communities and jurisdictions. Funded activities range from annual program funding to maintain and improve emergency management programs, to project specific grants ranging from Emergency Operations or Hazard Mitigation Plans to SEOC or Hazard Mitigation construction or equipment grants.

## Access and Functional Needs Planning

Working with local governments and authorities, this line item funds the preparation and planning of emergency rescue and evacuation plans for the disabled during disasters.

## **Indirect Cost Assessment**

This line item represents the projected collection of indirect cost recoveries for the HSEM Division's programs operated with non-General-Fund sources of revenue.

# (B) Office of Prevention and Security

## **Personal Services**

This line funds Colorado Information Analysis Center (CIAC) and Terrorism Liaison Officer (TLO) program personal services.

## **Operating Expenses**

This line funds operating expenses for the CIAC and TLO programs.

## Safe2Tell Dispatch

This program funds the Safe2Tell program that provides an anonymous reporting avenue for unsafe, potentially harmful, or criminal activities.

## (C) Office of Preparedness

## **Program Administration**

This line funds personal services and operating expenses for the Office of Preparedness.

## **Grants and Training**

This line provides federal grant funds to the 9 All-Hazards Regions and the Urban Area Security Initiative (UASI) eligible recipient (Denver) in the state, to maintain and improve Homeland Security Programs throughout the state.

## State Facility Security

This line provides funding for the ongoing maintenance of statewide Alert Notification System.
