

Strategic Policy Initiatives

The Department of Public Safety has identified several strategic policy initiatives for FY 2019-20 and beyond. For this performance evaluation, the Department has updated progress on the initiatives identified in the FY2020 Performance Plan that capture the Department's strategic and operational priorities, and reflect the overall direction as identified by Department leadership. The updates reflect data as of October 1, 2019. Additional detail for these, and other, strategic policy initiatives is available in the <u>Department's Performance Plan</u>.

SPI 1 – The Colorado State Patrol will lead the statewide effort towards the reduction of the Colorado fatality rate per 100 million vehicle miles traveled (VMT) from a ratio of 1.21 in 2017 to a ratio of 1.14 by 2020 and to a ratio of 1.04 by 2022.

Traffic safety on Colorado highways is the top priority of the Colorado State Patrol (CSP). The CSP strives to improve traffic safety and protect lives by developing intelligence-led strategies, identifying local-specific challenges and developing needs-based responses, deploying high-visibility and strict enforcement strategies, and educating the community about highway safety.

SPI 2 – Increase schools' preparedness for emergencies by creating a baseline of schools with an exercised emergency operations plan and develop a plan to equip no less than 90% of schools by June 30, 2020

A safe and secure learning environment provides the cornerstone for a successful education. Schools in Colorado have worked tirelessly to continue to improve the safety of students, staff, and visitors. Many schools have well-exercised emergency plans, however, some schools may need additional support to create and drill plans. The Colorado School Safety Resource Center will determine the current status of emergency preparedness and develop a plan to increase the number of schools with an exercised emergency operations plan.

SPI 3 – Increase CBI's ability to support local law enforcement black market marijuana investigations by increasing the number of responses from 0 to 20 by June 30, 2019 and to 50 by June 30, 2021 for the protection of Colorado residents and legal businesses, as well as neighboring states.

According to local law enforcement and the DEA, black market marijuana continues to be a prevalent and under-addressed problem in Colorado. The CBI will establish and deploy the newly-funded Black Market Marijuana Team to combat this issue. Strategies to achieve this SPI include: developing partnerships with local law enforcement, developing systematic investigative best practices, and creating a tips line.

SPI 4 – Reduce juvenile criminal justice system involvement by expanding the availability of juvenile diversion programs from 15 to 22 by June 30, 2020

Juvenile diversion programs are an alternative to the formal court system. The goal of these programs is to reduce juvenile crime and recidivism, change juvenile offenders' behavior and attitudes, and reduce costs within the juvenile justice system. The Division of Criminal Justice will partner with Judicial Districts, the Colorado Division of Youth Services, and other community stakeholders and local partners to achieve this goal.

SPI 5 – Establish a statewide baseline and framework for implementing performance-based contracting in community corrections compliant with PACE guidelines by June 30, 2020



Performance-based contracting requires providers to demonstrate that they are achieving minimum standards and using evidence-based practices. The Division of Criminal Justice is working on a long-term plan to implement performance-based contracting for community corrections providers in Colorado. This goal is part of that long term implementation plan.

Strategies to achieve this goal include: Partner with CDHE and CDE to survey schools on gaps and establish a baseline percent of exercised emergency operations plans; perform outreach to key constituent groups on the School Response Framework; encourage local and tribal emergency management offices to incorporate schools into exercises; align training and delivery needs at the local level; encourage schools to involve first responders in exercising plans.

Strategies to achieve this goal include: deepen relationships with local law enforcement to determine how to target black market marijuana; develop a systematic best practice for investigations in cooperation with local law enforcement; develop a tip line and email for local law enforcement to pass on requests; use digital technology as a conduit for passing on information from the team to local law enforcement. For Q2, in addition to the reported number of seized plants, the black market marijuana team seized more than 200 pounds of processed marijuana and 100 vape cartridges with concentrated marijuana oil.
