

Last week the DHSEM State VAL met with the subgrantees of the FEMA Disaster Case Management (DCM) grant Catholic Charities, Archdiocese of Denver and Lutheran Family Services and Habitat for Humanity (HFH) and the Division of Housing to review eligibility aspects of programs and logistics of delivering services. Because there are seven HFH affiliates serving Boulder, Larimer, and Weld Counties, HFH has simplified its initial referral process to a standard form (Eligibility Criteria and Intake Questionnaire) to make referrals easier during the disaster case management process. **Program Update** 

The pilot program proposal was drafted and included in the Action Plan Substantial Amendment submitted to HUD September 5, 2012. It was recommended \$25 million be set aside to address watershed issues. The two components include Watershed Capacity Building and Planning and Watershed Project Implementation. The CDBG-DR Infrastructure and Watershed Resilience Program leads will closely coordinate efforts to ensure projects from both programs do not conflict with one another.

#### **Program Update**

- HMGP is open for five disasters: DRs 1762, 4067, 4133, 4134, and 4145.
- DHSEM originally received and reviewed 164 project Notices of Intent from 73 entities for the four latest disasters.
- After reviews, eligibility determinations, and cost-effectiveness analyses, 95 applications were received on or by the • due date of August 29, 2014.
- Applications will be scored by a multi-agency team of subject matter experts the end of September. Applicants . will be notified in October if their application is/isn't moving forward in the FEMA process.
- During this time the DHSEM will be conducting an informal Request For Information (RFI) process to collect missing or unclear information for applications before submitting those moving forward to FEMA.
- As part of the DHSEM strategy, applications submitted to FEMA will be over-prescribed in the event that a project • does not receive FEMA approval or withdraws from the process. This will ensure all environmental and historic preservation clearances are obtained with enough time for FEMA review allowing the next the application to move forward in a streamlined manner.
- Please be aware that invitation to submit final applications to FEMA does not guarantee final project award.
- Tip of the week: Monitor your email for official communication from the DHSEM. Once the review process is • complete you will be notified as to the final status of your application and provided further instructions.

DHSEM is currently working with subgrantees on submitting any final requested scope of work or contract changes and processing requests for reimbursement. As of August 31, 2014, the following apply:

- Twelve sub grantees were awarded \$14 million in funding
- Six sub grantees have submitted 11 requests for reimbursement for \$3 million. •
- Two subgrantees submitted final requests for reimbursement and were paid out. DHSEM staff is working with • them on project and grant closeout.
- Three requests for reimbursement submitted in August are in process.
- One sub grantee withdrew from the program. ٠

#### Program Update

- Seventeen Request for Reimbursements were submitted in the last week. Five requests for reimbursements were reviewed and recommended for payments. The total amount of RFRs is now at **360**. The total amount requested is \$59.7 million and **\$52.7 million** is considered **eligible**. The amount of completed reviews this week was less than usual because the review team participated in a three day training with new staff.
- **\$6.9 million** was paid in the last week in small projects, advances, and large project reimbursements. The total paid on federal and state share is now at \$21.1 million for large projects and \$9.6 million for small projects.
- The State received 30 requests for time extensions, responded to seven and forwarded 23 to FEMA for approval before the September 14, 2014 deadline.
- Six appeals for Public Assistance have been forwarded to FEMA. Five more appeals are being processed by the State and will be submitted within the next 60 days on behalf of the applicants.
- DHSEM received 11 requests for scope changes on PA projects in the last week bringing the total to 94 requests. Eight are being forwarded to FEMA for consideration.
- Announcements: The State will be providing a Standard Operation Procedure for PA this week, also known as a *Service Plan*. We look forward to using this SOP to clarify the State's role and how we can assist our local partners.
- **Upcoming deadlines**: The next Public Assistance conference call will be 9 a.m. on September 26, 2014. The call in number is 1-877-820-7831, the access code is 522939#.
- DHSEM continues to coordinate with Great Outdoors Colorado to ensure no duplication of benefits occurs between grant funding sources for projects funded with FEMA funds.
- **Tip of the week**: Remember to keep your grants in separate non-interest bearing accounts. It helps with accounting and is required by some grants (including PA).

#### **Program Update**

- **Fifty-eight** entities requested funding for **214 projects** in Round One. **Fifty-three** projects were selected to move forward in the process. Applications were submitted on or by August 29, 2014. Applicants are being notified of next steps.
- DOLA has hired a contractor to assist communities with meeting NEPA requirements.
- The Action Plan Substantial Amendment was submitted to HUD by September 5, 2014 for approval. Approximately \$65 million was requested for Infrastructure projects in Round Two, bringing the total to approximately \$85 million.
