Updates: The following are recent events in our efforts to meet the recovery needs of individuals, households, and small business:

- Disaster Case Management (DCM) has produced a standardized statewide Form Set (August 2014) for the floods. The set is twelve forms and a checklist (some are multipage forms).
- Weekly conference call was held with Case Manager Supervisors across the state for the DCM grant.
- Bimonthly grant monitoring conference call held with FEMA.
- DCM Map revised with new addresses for Larimer and Boulder
- The Case Manager Supervisor weekly meeting is held each Monday at 1 p.m.
- Case management data is being developed to portray the status of unmet needs in disaster impacted
 communities. A data management program is being developed to provide a mechanism for understanding the
 individual and household recovery needs. FEMA recently provided the State with DCM service mapping.

Program Update

The following summarizes the status of the **95** applications currently under HMGP consideration:

- The Mitigation Section has assembled a team of subject matter experts from agencies throughout the state. The first round of reviews will begin during the week of September 22nd, with the remaining reviews in the subsequent weeks.
- The HMGP applications being reviewed are for property acquisitions, elevations, minor flood control projects, generators and hookups, wildfire mitigation, hazard mitigation plans, and 5% projects (which generally do not fit into the prior categories). We anticipate the reviews to be completed by mid to late October and applicants will be notified as to the final status of their application via email.

- The majority of wildfire projects that applied for HMGP and Division of Natural Resources (DNR) grants have received partial or complete DNR funding with combined awards at approximately \$1.6 million. The sub grantees that have been identified for funding are being contacted by the DHSEM and the DNR.
- Tip of the Week: Have you reviewed the HMGP Unified Guidance & Addendum recently? We encourage all
 communities to become familiar with the procurement and quarterly reporting sections in preparation for
 funding and all future HMGP applications.

Program FEMA Pre-Disaster Mitigation Grant Program (PDM)

Program Update

DHSEM is currently administering **16** approved PDM grants (\$22.05 million in federal funds) for state and local agencies. DHSEM is also administering **5** Flood Mitigation Assistance (FMA) grants which represent over \$6.08 million in federal obligations. PDM activities during this reporting period include:

- Longmont and DHSEM personnel held a kick-off meeting for the recently awarded \$3 million flood mitigation project on the St. Vrain River (two new/improved bridges) on September 17, 2014.
- DHSEM was notified that two PDM 2014 grants had been selected for further review by FEMA. The grants and grant amount currently under consideration are:
 - City of Durango Crestview Ditch flood mitigation \$946,524
 - Colorado State Forest Service/Canon City Wildfire Fuels Mitigation \$250,000

Program Update

Current sub grantees are El Paso County, Larimer County, Boulder County, Morgan County, Jefferson Conservation District, Jamestown, Evans, Lyons, Estes Park and Colorado Springs. Sub grants are for a total of \$14.1 million. As of September 22, 2014, \$2.8 million has been approved for payment. Four sub grantees have submitted no reimbursement requests to date.

The mitigation planner is performing ongoing State reviews (currently 8 + 1 Regional plan [8 counties]) of new/updated local HMPs prior to FEMA submission, and expediting receipt of local HMP adoptions for final FEMA 5-year HMP approval.

NRCS project tracking continues (see below) as the October completion date for all projects approaches. The Team is currently tracking grant completion and is working closely with both finance and grantees to get the RFRs submitted.

Program Update

- 27 Request for Reimbursements were submitted in the last week. 36 requests for reimbursements were reviewed and recommended for payments. The total amount of RFRs is now at 396. \$66.1 million is the total amount requested and \$58.2 million is considered initially eligible. Three new reviewers have been added to the team, and we continue to see progress.
- There is no update on payments for the week in EMGPro, but payments have been made in our accounting system. Payments in EMGPro will be updated later this week for last week and this week. The total paid on federal and state share is at \$21.1million for large projects and \$9.6 million for small projects.
- 6 requests for scope changes were submitted in the last week bringing the total to **101** requests for scope change. **18** were submitted to FEMA for review. 8 were completed in the last week.
- Announcements: The State "Service Plan" is in draft format and going through our internal review. We look
 forward to releasing a copy later this week. The SOP will help clarify the State's role and how we can assist our
 local partners.
- **Upcoming deadlines**: Next Public Assistance call is scheduled for September 26. We will be discussing scope changes and updates on requests for reimbursements.

Program Update

The Southern Baptist Convention Disaster Relief (coalitions of churches) came to Colorado a year ago to scope out the size of the floods. In the last 12 months, we are have seen the Baptists from the states of Colorado, Kansas, Oklahoma, Texas, Kentucky, Georgia, Virginia and Alabama, to name a few, who came here to help. On September 18 they held an "End of Project" celebration at the Baptist Estes Park Church. Awards were given, speeches were made and testimonials were given from Estes Valley about how much the Baptists have given to Colorado. Now the transition will be to the Colorado Baptist General Convention, under the leadership of Dennis Belz and Dr. Mark Edlund.

There were a total of:

- 45 teams
- 449 volunteers
- 29,533 volunteer hours
- 23 states
- 180 jobs completed

The State of Colorado VAL works to integrate volunteer faith based organizations that have a disaster mission into local communities. The Colorado Baptists General Convention is a member of the Colorado Voluntary Organizations Active In Disaster (COVOAD) and the Southern Baptists Convention (SBC) are a part of the National VOAD.
