• The Individual Assistance (IA) Branch, Disaster Case Management (DCM) monitoring team from FEMA National HQ and Region VIII made a site visit to DHSEM on Oct. 28-29, 2014. The purpose of a monitoring visit is a preventative process to identify any gaps in grant management and share good grant management and grant oversight processes. Both the fiscal and programmatic side is examined. Lutheran Family Services (LFS) and Catholic Charities (CC) also participated as contracted case management agencies. The State was praised by FEMA for integrating the DCM staff with the non-DCM case management staff statewide. This is a reflection of the partnerships between Colorado's non-profits and government agencies focused on the mission of helping survivors after a disaster.

• 214 state and local agency representatives from communities participating in the ongoing Public Assistance (PA) program and the Hazard Mitigation Grant Program (HMGP) attended workshops offered by FEMA's Disaster Procurement Assistance Team (DPAT) on Oct. 30 and 31. This training provided participants with a valuable opportunity to ask questions and gain insights about these complex programs from FEMA's team of experts.

#### **Program Update**

• Recovery Program Team members delivered the *Recovery from Disaster: The Local Government Role (G-270.4)* course in Lake County on Oct. 29. There were twenty-three participants came from Lake, Summit, and Otero counties, the Town of Leadville and St. Vincent Hospital. The training focused on issues and lessoned learned from recent disasters in Colorado as an addition to the basic training. The training emphasized the development of local recovery plans using lessons-learned to better equip local governments to transition from response to short and long term recovery.

**Program Update** 

- Five hundred twenty-two (522) quarterly reports were reviewed and submitted to FEMA for Quarter Four. The timely submission of sub grantee reports was greatly appreciated and enabled the State to submit the overall report to FEMA on time.
- Seven (7) requests for reimbursements (RFRs) were submitted in the last week.
- Twenty-nine (29) RFRs have been recommended for payment in the last week.
- The total amount of RFRs is now at 521, of which 199 are complete. \$80.0M is the total amount requested, \$70.1M is considered initially eligible, \$25.9 has been recommended for payment.
- There have been twenty-nine payments made in the last week for a total of \$1.9 million, including federal and state share.
- Four requests for scope changes were submitted in the last week bringing the total to 133 requests. Eight requests were completed in the last week.

#### **Program Update**

HMGP is open for five disasters: DRs 1762, 4067, 4133, 4134, and 4145.

- Letters conveying the final results of each HMGP application reviewed by the State Hazard Mitigation Team were been sent to the application's primary and secondary contacts via email on October 17, 2014.
- Projects that are moving forward or in the fiscally constrained category should respond promptly to the Request for Information (RFI) and coordinate with their AMEC point of contact. We encourage applications that were not selected to move forward to be retained by sub-applicants for future HMGP opportunities.
- DHSEM's Mitigation staff attended the FEMA Disaster Procurement Assistance Team (DPAT) training at the Federal Center recently in support of communities receiving federal grant assistance. Slides from the presentation will be sent by FEMA staff to those who signed the attendance sheet at the training.
- DHSEM Mitigation staff met with experts from the U.S. Department of Housing and Urban Development (HUD) Region VIII, FEMA Region VIII, and the Department of Local Affairs (DOLA) Division of Housing recently. The highly productive discussion helped the DHSEM strategize and coordinate with state and federal partners for the Uniform Relocation Act (URA) regarding HMGP & CDBG-DR.
