#### **Program Update**

HMGP is open for five disasters: DRs 1762, 4067, 4133, 4134, and 4145.

- The MARS team is on track to have 100% of HMGP applications submitted to FEMA before the end of the year. FEMA will review the applications within forty-five days of our final submission. FEMA RFIs will be communicated to the applicant via DHSEM email.
- The Mitigation team would like to thank everyone for the continued patience and vigilance in response to the State RFI process. As we approach the holiday season, we want to remind HGMP applicants to keep the lines of communication open to prevent any extended delays before the December 31st, 2014 HMGP deadline.
- MARS staff recently met with experts to refine work processes and documents to improve efficiency in the HMGP Property Acquisition program.

#### **Program Update**

• Thirteen of the thirty-seven requests for reimbursements (RFRs) submitted in the last two weeks have been recommended for payment.

- The total number of RFRs is now at 628, of which 258 are complete and 121 were returned to the sub-grantees for additional information.
- The total amount requested is \$93.9 million, and \$82.2 million is considered initially eligible. Requests totaling \$30.9 million has been recommended for payment and \$14.8 million has been returned to sub-grantees for additional information.
- A total of 249 RFRs for \$36.5 million continue to be under review.
- Two of five requests for scope changes submitted in the last two weeks have been completed. The total number of scope change requests is now 156, of which 97 are completed and 27 were returned to the sub-grantees for additional information. Thirty-two scope changes are currently under review.
- There have been 57 payments made in the last two weeks for a total of \$3.0 million, including federal and state share.
- Announcements:
  - 1. The next PA call will be the last week of January. There will be no call this month due to the holidays.
  - 2. As discussed on the last call, the State will be releasing information on Force Account Labor (FAL) costs and cost reasonableness. This is still in progress.
  - 3. The agenda for PA Advisory Committee will go out this week before the meeting.
  - 4. The State is still working on hiring project specialists and finance specialists. All interviews have been conducted and State staff is moving applicants forward in the background check process.
- Important Dates: Time extensions for permanent work projects are due February 14, 2015.
