

**Program Update** 

HMGP is open for five disasters: DRs 1762, 4067, 4133, 4134, and 4145.

- The Mitigation team has submitted 89 HMGP applications to FEMA. These applications will be reviewed in their entirety within 45 days and a FEMA Request for Information (RFI) will be communicated to the sub-applicant via DHSEM email.
- Sub-applicant responses to FEMA RFIs within 30 days are mandatory. Failure to respond to a FEMA RFI within the required deadline can jeopardize project funding and/or result in final project denial.
- The Mitigation team is excited to announce a Grant Award to Denver Mountain Parks related to DR-4067-CO.
   The \$277,995 grant funds will support fire mitigation activities within Genesee Park, located in Jefferson County encompassing approximately 112 acres. The objective of the project is to decrease wildfire hazards by reducing tree densities, removing flammable fuels, and modifying forest structures in order to protect life and property surrounding our mountain parks.

**Program Update** 

- Completed review of Arapahoe County Hazard Mitigation Plan (HMP) sent to FEMA for review on January 13, 2015.
- Two HMPs received and currently under State review (Fremont and Mesa).
- Received one additional adoption from Summit County (14 of 17 received to date as of January 13, 2015).
- Three HMPs remain in Approvable Pending Adoption (APA) status (Summit, Grand, Teller).
- Four HMPs in local planning process and will be submitted for State review soon.
- Ouray County HMP Update received final FEMA approval on January 5, 2015.

 Received notification on January 12, 2015 from FEMA identifying required revisions to the NE Region HMP Update.

**Program Update** 

- In the last week, thirty (30) requests for reimbursements (RFRs) were submitted, and sixteen (16) RFRs have been recommended for payment. The total amount of RFRs is now at 728, of which 336 are recommended for payment and 157 were returned to the Subgrantees for additional information. The remaining 235 are in progress. The total amount requested is \$106.8 million, and \$95.1 million is considered initially eligible. \$37.6 million has been recommended for payment and \$21.4 million has been returned to Subgrantees for additional information.
- Six requests for scope changes were submitted in the last week, and ten requests were either completed or deferred to closeout. The total amount of scope change requests is now 192 of which 123 are completed or deferred to closeout, and twenty-six (26) were returned to the Subgrantees for additional information. The remaining forty-three (43) are in progress.
- There have been forty-five (45) payments made in the last week for a total of \$1.8 million, including federal and state share.

#### Announcements:

- Next PA call will be January 30, 2015 at 9 a.m. Call in information and presentation will be sent out prior to the call.
- As discussed on the last call, the State will be releasing information on force account labor (FAL) costs and cost reasonableness. The release of this information was delayed due to programmatic changes being discussed with FEMA. We hope to have this guidance ready in the coming weeks.
- The hiring of project specialists and finance specialists is still in progress. All interviews were conducted, and State staff is moving applicants forward in the background check process.
- **Important Dates:** Quarterly Reports are due January 15, 2015. Time extensions for permanent work projects are due February 14, 2015.

This request for applications is being reissued in order to solicit additional eligible projects to which the remaining funds can be awarded.
- The Colorado Department of Public Health and Environment, Water Quality Control Division, is now accepting applications for funding as a result of HB14-1002 and has issued an official request for applications. The deadline for submitting applications is 2 p.m. on January 21, 2015.
