#### Disaster Case Management Program (DCMP) 10/20/15

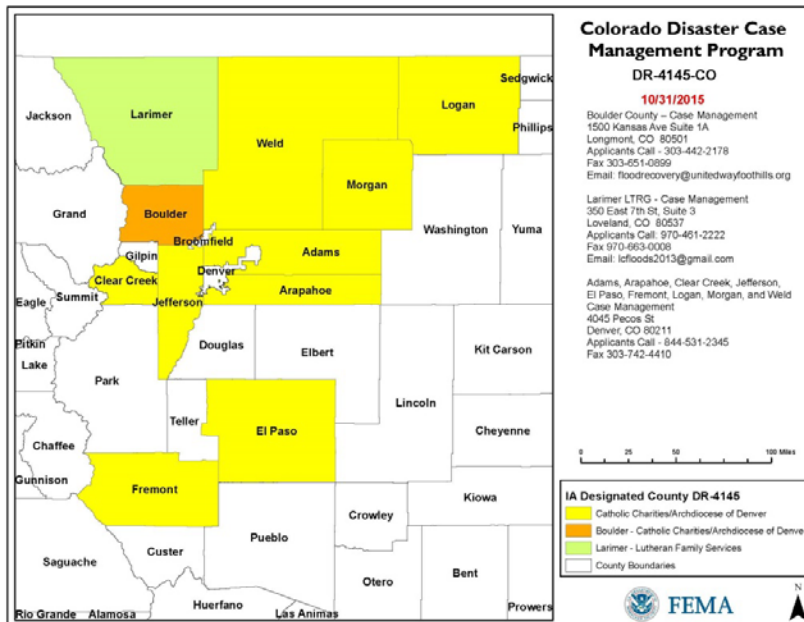
- **Boulder Long Term Flood Recovery Group**
  - Boulder Long Term Flood Recovery Group (LTFRG) has launched a series of after action reports (AAR's). The debriefing schedule is spanning a few weeks starting October 20 with the construction subcommittee and ending November 5 with the Case Manager Supervisors. Laura Spicer, MSW Intern, is facilitating the meetings which last two hours and complete with 3-5 action items that can be used for best practices and possible recommendations for future improvement. At least 13 meetings are being held to produce a comprehensive AAR with lessons learned and recommendations that can be turned into an improvement plan.
  - On October 20th, the LTFRG Volunteers Subcommittee had the debrief with volunteer coordinator Larry Glover from United Methodist Committee on Relief (UMCOR), the current Volunteer Committee Chair, Deb Campbell from UMCOR and other volunteer coordinators from Habitat for Humanity, Nina from Jamestown, Metro Volunteers former volunteer coordinator Maya Teller who was funded by the State of Colorado, Julie Phillips from United Way and the current Boulder County Voluntary Organizations Active in Disaster (BOCOVOAD) Chairperson.
  - The State VAL and two state MARS staff attended the debrief and were able to give input to the committee. Some things that were important to the group was collecting the volunteer value in debris

clean up and rebuilding. This volunteer value can help defray the cost of homeowners, and create a soft match for grant funding for municipalities, town or counties when there is a federal disaster declaration. The value of volunteer labor is not always counted but a great need in Colorado is to fund the "boots on the ground" volunteer safety, coordination and guidance. Not every town, city or county has volunteer coordinators in place and the State of Colorado has been very lucky to have funding to support volunteer coordinators through a contract agreement with Metro Volunteers.

- Did you know that if volunteer labor is utilized to help rebuild a home it usually will cost approximately one half the cost? The ability to defray costs by 50 percent adds to the effectiveness and efficiency of paying for a volunteer coordinator to assist and direct the work of the volunteer teams. The Boulder Volunteer Committee has work for a volunteer coordinator for at least one more year.

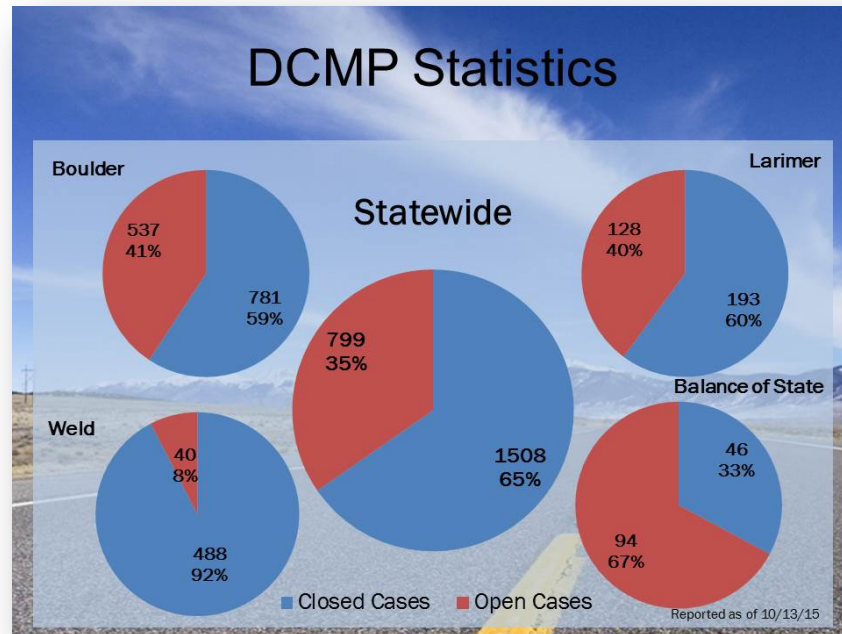


- The Weld Recovers office in downtown Greeley is closing on October 30, 2015. It has been home to the Disaster Case Management Program (DCMP) staff for more than a year. The DCMP staff will continue to assist clients out of donated office space at both Catholic Charities and Habitat for Humanity locations in the county. Flood survivors can contact DCMP staff by calling Catholic Charities' Flood Survivor Toll Free Number at 844-531-2345. - At September 30, 2015, two years after 2013's record floods, the number of open survivor cases was 799. Just over one-half of these cases (413) are being overseen by the State's Disaster Case Management Program (DCMP). On a Statewide basis, of the more than 2,300 cases opened since the floods, nearly two-thirds have

been closed. Many of the remaining open cases are the most challenging and have requested assistance under several Community Development Block Grant-Disaster Recovery (CDBG-DR) housing programs (home access, repairs and/or replacement) being administered by the Colorado Department of Local Affairs (DOLA). Assistance under these programs requires extensive environmental and cost reviews. To continue helping these clients, as well as others seeking help from other sources, the State asked for---and subsequently received---FEMA's approval to extend Disaster Case Management Program (DCMP) services from December 12, 2015 to March 11, 2016. The State is working closely with its grant sub-recipients, Catholic Charities and Lutheran Family Services; the Boulder, Larimer and Weld County long term recovery groups (LTRG's); non-profits and local government agencies to use this additional time effectively in support of our neighbors in need.

FEMA has announced PDM program availability for this year. DHSEM is currently accepting notices of interest/intent from eligible potential sub-applicants for the \$30 million available nationally. A complete State application, including all sub-applications, was due to FEMA on August 28, 2015.

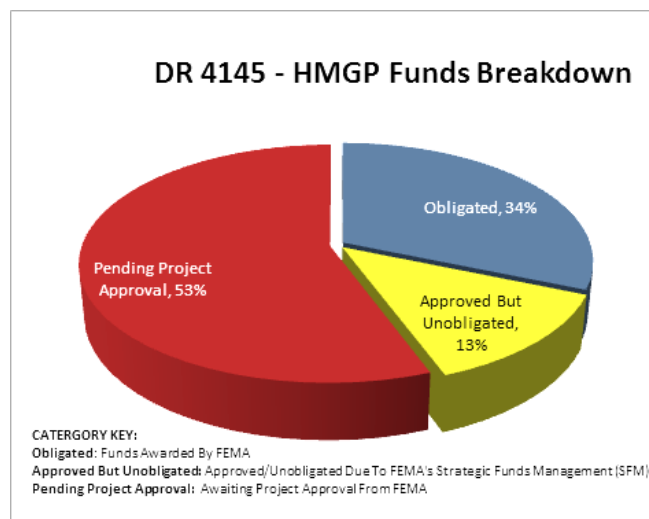

### Program Update

The State is currently working five disasters that involve HMGP funding: DR 4067, 4133, 4134, 4145, and 4229. A breakdown of projects by disaster is below:

FEMA continues to review project applications. Only nine projects remain in the initial FEMA review queue due to extended project analysis, technical feasibility, environmental, historical, cultural review/studies and/or project phasing deliverables. The majority of projects have been awarded and the state continues to coordinate projects still under review.



The Mitigation Team has submitted applications for the FY15 Hazard Mitigation Assistance Guidance grants, including the Pre-Disaster Mitigation Program (PDM) and Flood Mitigation Assistance Program (FMA). Further information about PDM & FMA can be found on the [DHSEM Grant Programs website](#).

### DR-4145

- In the last week, 23 requests for reimbursements (RFRs) were submitted, and 23 RFRs have been recommended for payment. The total amount of RFRs is now at 1475 of which 1067 are recommended for payment and 214 were returned to the sub-grantees for additional information. The remaining 194 are in progress. The total amount requested is \$176.1 million, and \$157.1 million is considered initially eligible. \$114.3 million has been recommended for payment, \$22.5 million has been returned to sub-grantees for additional information, and \$20.3 million is still in progress.
- Five requests for scope changes were submitted in the last week, and nine were completed or deferred to closeout. The total amount of scope change requests is now 384 of which 265 are completed or deferred to closeout, and 60 were returned to the sub-grantees for additional information. The remaining 59 are in progress.
- There have been 140 payments made in the last week for total of \$4,744,290.54 including federal and state share.
- One-hundred and seventy-nine small project closeout requests and 12 large project closeouts have been submitted to FEMA.

### DR-4229

- Please work with your FEMA PA to get the information necessary for your PW. Estimations may be used for writing the PWs. It is crucial for local entities to work with their FEMA PA Project Specialist on getting the information necessary to complete the PW as soon as possible.
- DHSEM is currently in process of writing the first Purchase Orders (POs) for Small Projects (PW<\$121,600) and the first Grant Agreements (GAs) for Large Projects (PW>\$121,600). The Purchase Orders and Grant Agreements are the mechanisms for payment processing to begin.
- As of October 19, 2015:
  - 31 Obligated Projects, 23 Small Projects and 8 Large Projects
    - Purchase Orders for Small Projects
      - 13 POs have been submitted to Finance for Approval
      - Ten POs are in Draft
    - Grant Agreement for Large Projects
      - Two GAs mailed to Sub-Grantee
      - Four GAs submitted to Grants
      - Two GAs in draft
- Purchase Orders will be a rather simple process. For projects under \$121,600, a Purchase Order will be completed and submitted to the sub-grantee and will soon after receive a check for the total amount.
- Grant Agreements will be drafted for projects over \$121,600 and sent to the sub-grantee for review and approve. Once the grant agreement has been signed by the Authorized Agent, the grant agreement will be sent back to DHSEM and then to the CDPS Controller for signature. This is a timely process that requires each agency to get signatures in a timely manner.
