

- Disaster Case Management Program (DCMP) January 12, 2016
  - Disaster Case Management (DCM) will be demobilizing on March 10. In preparation, case supervisors are meeting weekly to work on transition planning, final reporting measures, and discuss the role of DCM in future disasters. All cases remaining open after March 3 will be transferred to community social services agencies.
  - As of October 31, 2015, the number of open 2013 flood survivor cases stood at 742. Slightly more than one-half of these cases (375) were being overseen by the State's Disaster Case Management Program (DCMP). Through October, over 1,613 cases--68% of the state-wide total--have been closed. Many of the remaining cases are in the process of obtaining assistance through Community Development Block Grant-Disaster Recovery (CDBG-DR) programs administered by Colorado's Department of Local Affairs (DOLA). Others are being referred to Long Term Recovery Group (LTRG) Unmet Needs Committees in Boulder, Larimer and Weld counties, or local non-profits with available resources.



#### **Program Update**

The State is currently working five disasters that involve HMGP funding: DR 4067, 4133, 4134, 4145, and 4229. A breakdown of projects by disaster is below:

FEMA continues to review project applications. Only seven projects remain in the initial FEMA review queue due to extended project analysis, technical feasibility, environmental, historical, cultural review/studies and/or project phasing deliverables. The majority of projects have been awarded and the state continues to coordinate projects still under review.



The State has reviewed all HMGP DR-4229 Notice of Interest (NOI) for programmatic eligibility and technical feasibility. Projects chosen to move forward to the HMGP application have been notified. Applications are due to the state by May 13, 2016 and further instructions will be sent.

#### DR-4145

- In the last three weeks, 99 requests for reimbursements (RFRs) were submitted, and 47 RFRs have been recommended for payment. The total amount of RFRs is now at 1,735 of which 1,193 are recommended for payment and 238 were returned to the sub-grantees for additional information. The remaining 304 are in progress. The total amount requested is \$210.3 million, and \$187.6 million is considered initially eligible. \$123.2 million has been recommended for payment, \$20.5 million has been returned to sub-grantees for additional information, and \$43.8 million is still in progress.
- Thirteen requests for scope changes were submitted in the last three weeks, and ten were completed or deferred to closeout. The total amount of scope change requests is now 418 of which 298 are completed or deferred to closeout, and 61 were returned to the sub-grantees for additional information. The remaining 59 are in progress.
- There have been 74 payments made in the last three weeks for total of \$4,513,862.73 including federal and state share.
- 142 small projects have been closed by FEMA and another 144 have been submitted to FEMA for closeout review. 16 Large Projects have been closed by FEMA and another ten have been submitted to FEMA for closeout review.
- The next PA call will be January 29, 2016 at 9 a.m. Call in information and presentation will be sent out prior to the call.

Colorado Voluntary Organizations Active in Disaster (COVOAD) provided State Emergency Operations Center support for the January 8 exercise. The exercise tested COVOAD's Mass Feeding Task Force capabilities and organization, bringing together participants from The Salvation Army, Colorado Baptist Disaster Relief, and The Red Cross. In addition to practicing for emergency response, the exercise provided important training opportunities for three COVOAD Liaisons and aided in the development of an "activation checklist". In the event of an emergency, the checklist will be used as a tool to ensure the COVOAD Liaison is effectively coordinating COVOAD member agencies, serving as liaison between COVOAD and the State, facilitating requests, and communicating reports and response activities.

Emergency management officials practiced their rescue plans in the event of a major blizzard (36 inches simulated) across northern El Paso County. The El Paso County Office of Emergency Management conducted an exercise called "Deep Freeze 16" on Saturday, Jan 9. The exercise included the Colorado National Guard, fire departments, ambulances and rescue shelters staffed by the American Red Cross. About 400 people took part. The South Central Region Voluntary Organizations Active in Disaster acted as stranded motorists and others who might need rescuing, indicated by tying an orange

ribbon to their car mirror. Thirty-nine missions were accomplished with the National Guard and ambulances took the simulated stranded motorists to either the Red Cross shelter or the hospital, depending on if there were any injuries. The simulation was highly successful with all missions accomplished and the control cell was able to account for all the actors as they phoned in when they reached their parking lot destination. This demonstrated great coordination among local assets, unified command and the VOAD partners. In addition the Emergency Operations Center was activated to conduct dispatch and coordination. An after action report/hot wash is scheduled for February 11. The report will be published by El Paso County Office of Emergency Management.
