

## Colorado Automobile Theft Prevention Authority


In 2009 the Colorado Auto Theft Prevention Authority, CATPA, will award grants for multiagency auto theft prevention, enforcement, investigative and prosecution programs. Authorization for CATPA is through CRS 42-5-112. CATPA will be able to award approximately \$4 million for the calendar year 2009. Grant applications will be published in the Spring of 2009.

CATPA came into existence in 2004 through the efforts by the Colorado Auto Theft Investigators, <a href="https://www.coloradoautotheft.org">www.coloradoautotheft.org</a> a not for profit organization of auto theft investigators in Colorado over the concern with the increase in motor vehicle thefts in the state and the diminishing attention and commitment toward strategic investigation, enforcement and prosecution of these crimes.

Legislation in 2003 permitted "voluntary" funding for the purpose of creating the CATPA. Over the next four years that one-time funding influx of approx \$700,000, from State Farm and Progressive and other insurance companies was used for investigative, enforcement, public awareness and law enforcement training programs. The results included several part-time multi-agency task forces that accelerated investigative and enforcement efforts on repeat and major criminal offenders. These efforts resulted in an increase in stolen vehicle recoveries and criminal prosecutions of hard core and major organized criminal groups. Also achieved through these efforts were significant reductions in state-wide auto thefts in 2006 and 2007.

In 2008 SB-60 authored by Senator Betty Boyd was passed by the legislature and signed by Governor Bill Ritter. This bill provides CATPA with permanent funding, \$1 per insured vehicle each year until the Sunset Review in 2018. As a result, CATPA has 10 years of steady funding of more than \$4 million per year for motor vehicle theft investigation, prevention, enforcement, prosecution or training.

#### **Colorado Auto Theft Statistics**



- In 2007, a total of 16,353 motor vehicle thefts were reported by law enforcement agencies in Colorado according to the Colorado Bureau of Investigation.
- This is a 19.5% decrease in motor vehicle thefts from 2006.
- Automobiles accounted for 13,518 or 82.6% of the vehicles stolen.
- Trucks or buses accounted for 1,618 or 9.89% of the vehicles stolen.
- Vehicles classified as other vehicle accounted for 1,217 or 7.44% of the vehicles stolen.

Nationwide in 2006, there were 1,095,769 motor vehicle thefts, or a rate of approximately 363.3 motor vehicles stolen for every 100,000 inhabitants. The estimated number and rate of motor vehicle thefts in 2007 decreased 8.1% when compared with data for 2006.

For 2007, Colorado was ranked 19th among states for number of auto thefts compared to 16th in 2005. Using the FBI's average valuation of \$6,173 per stolen vehicle, this amounts to an estimated \$100.9 million in losses during 2007.



#### **Highlights from the Task Force Activity**

#### The Denver Metro Auto Theft Team (DMATT)

This team is comprised of 14 law enforcement agencies from the Denver Metropolitan Area including the Colorado Attorney General's Office, Department of Revenue, and State Parks. This task force has recovered a total of 400 stolen vehicles valued at \$4,227.862, investigated 67 chop shops, inspected 58 businesses, and arrested a total of 189 persons on automobile theft-related charges.



The Regional Auto Theft Team of Northern Colorado (NCRAT)

This is a collaborative effort among 10 law enforcement agencies in Northern Colorado. During 2008, the task force assisted in the investigation and recovery of 43 stolen vehicles. Working as a team and with other outside agencies, they assisted in the above-mentioned recoveries worth an estimated \$464,525.00. Associated cases also resulted in the recovery of numerous stolen/altered vehicle parts and other property estimated at \$32,000.00.

In addition, twenty chop shops investigations were completed and 32 businesses inspected.

#### Metropolitan Reduce Automobile Theft (RAT)

This partnership is comprised of the Colorado Spring Police Department, the El Paso County Sheriffs Office, and the Colorado State Patrol who are working together to reduce automobile theft in the Colorado Springs area. The success of this multi-jurisdictional group has led to 53 felony arrests and 92 recovered stolen vehicles since its inception.



## Roaring Fork Valley Task Force

Located on Colorado's Western Slope, this task force is comprised of the eight law enforcement agencies in the Glenwood Springs/Aspen area. To date this task force has recovered a total of 149 stolen vehicles valued at \$1,553,596.00 and made 40 arrests for auto theft related crimes.

## Project "Gotcha"

Washington County Sheriff's Office received funding to purchase a Global Positioning System (GPS) device to combat the theft of farm machinery and construction equipment in Colorado's northeast corner.


#### **Highlights from the Public Awareness Activities**

## **Watch Your Car Program**

The State of Colorado participates in the Watch Your Car Program which is a motor vehicle theft prevention program. The Watch Your Car Program is a cooperative initiative among states and the Bureau of Justice Assistance (BJA). Statistics show that significant number of auto thefts occur during the early morning hours when the vehicle's owner is asleep and is unaware that their vehicle was stolen.

The Program provides decals to motor vehicle owners to display on their vehicles. These decals are an indication to the police officer that this vehicle is not normally driven between the hours of 1 a.m. and 5 a.m. Therefore, they have probable cause to stop the vehicle. Owners register the vehicles in this Program. The Colorado State Patrol maintains a database of all of the vehicles enrolled in Watch Your Car Program.

In order to create public awareness about availability of the Watch Your Car Program in Colorado, the Colorado State Patrol and the Denver Police Department's COPSHOP held events to increase participation in the program, media events were held and vehicle anti-theft devices were purchased (i.e. "The Club ®"). These steering wheel devices were given to individuals who registered their vehicle in the Watch Your Car Program at these events.



## Training and Community Education

A number of advanced training courses in the area of automobile theft were provided to all members of the Colorado Auto Theft Investigators (CATI). CATI is an organization whose members are from 30 law enforcement agencies, the insurance industry, and the National Insurance Crime Bureau (NICB). This is tri-state organization (Colorado Wyoming, and Nebraska) and its purpose is to educate it members about the latest developments in the field of automobile theft and associated crimes.



## Multi-Family Housing Project

The Wheat Ridge Police Department partnered with five apartment complexes within the city to combat the crime of automobile theft. The apartment complexes issued stickers to their residents. A significant number of stolen vehicles were being recovered in these complexes. It allowed apartment management to easily identify those unauthorized vehicles.

#### Bait Car Advertising Campaign

This project was a public awareness campaign about law enforcement's use of bait vehicles in combating the crime of automobile theft. This campaign was conducted by the Arapahoe County Sheriff's Office who used both prints and radio media to educate the public about auto theft prevention and the use of a bait vehicle.

#### **BUDGET INFORMATION**

Donations, Assessment Fees Paid, Expenditures, and Grant Awards

A total amount of \$2,399,149 has been received as contributions and assessment fees paid to the fund since January 2004. Gifts, grants, and donations have been provided by the following companies. The total amount spent on the program administration, operating costs, and board expenses is \$68,002. The breakdown is as follows. Total amount spent on administrative contract services was \$55,289.14 and \$12,712.86 has been spent on operating and board expenses. The CATPA Board of Directors awarded a total of \$786,673 in grants. All of the grant awards were ratified by the Chief of the Colorado State Patrol and Executive Director of the Colorado Department of Public Safety.
