Subject: HB22-1217 Report

This report is submitted in response to 24-33.5-230 C.R.S. which requires the Department to submit a report on the Catalytic Converter Identification and Theft Prevention Grant Program to the Judiciary Committees of the Senate and House of Representatives.

HB22-1217 was signed into law on June 7, 2022, which provided \$300,000 of general fund money to the Catalytic Converter Identification and Theft Prevention Program (CCITP) Cash Fund. As a business unit of the Colorado State Patrol, the Colorado Automobile Theft Prevention Authority Office (CATPA Office) was assigned to administer this grant program. The CATPA Office began working with CSP Rules Administrator Angelina Page where an Open Comment Invitation was sent to 997 potential stakeholders on August 1, 2022 for proposed new rules under 8 CCR 1507-59 for the CCITP Grant Program Rules. On August 31, 2022, the CATPA Office then sent a Notice of Public Rulemaking (NPRM) for the CCITP Grant Program Rules, where the Notice and the redlined rules were adopted on October 5, 2022 after a public hearing and filed with the Colorado Secretary of State and the Colorado Department of Regulatory Agencies (DORA) for publication in the Colorado Register on September 10, 2022. The CCITP Grant Program Rules, 8 CCR 1507-59, were effective on November 30, 2022.

As the initial CCITP funding under HB22-1217 was limited to FY22-23, the CATPA Office drafted and finalized the CCITP Grant Application, Grant Program Announcement and Grant Manager's Guidance Manual (instructions for completing a grant application). On October 25, 2022, the CATPA Office sent 932 invitations to potential stakeholders to attend a CCITP Grant Applicant's Workshop for consideration to apply for funding. On November 1, 2022, the CATPA Office posted the Grant Announcement on the State Patrol Website and lockdownyourcar.org. On November 17, 2022, the CATPA Office provided specialized training and information for interested applicants and further provided the grant announcement, application and instructions. Summary of CCITP Grant Projects (As of June 2023)

A total of six (6) applicants submitted a request for funding under the CCITP Grant Program, where all applicants were recommended for awarding, however, the Town of Kennesberg Board of Trustees declined the award, resulting in five (5) funded applications. The following is a summary of the funded projects including the program initiatives. As a note, the limited number of applicants was likely due to constraints in the CCITP Grant Program award timing (limited to a 6-month performance), due to the FY 2022-2023 performance of general fund money, creation of rules, composing and creating a new grant management system, reviewing and awarding of projects and engaging in grant agreements requiring processes for applicants to gain governing body, executive and budgetary approval. Additional constraints were experienced where eligible applicants were challenged with an inability to create a financial and programmatic infrastructure to perform a new or innovative program, limited amount of time to obtain approvals, the time constraints to develop strategic planning which may have required assignment of personnel not otherwise available and the inability to create partnerships with public and private organizations (e.g., salvage and recycle industries, victim advocates, etc.). In summary, the limited number of applicants requesting funding for intended purposes restricted the ideal target for funding apportionment in 24-33.5-230(4)(c).

The financial summary, referenced below, demonstrates 98.8% (or \$296,286.00 of the \$300,000) funding allocation from HB22-1217 was awarded to the five grant projects during FY 2022-2023. The largest proportion of funding was provided to assistance to victims (47%), followed by prevention (34%), business impacts 10%, and then enforcement (9%).

The following chart considers the line items for grant awards, along with the overall average for expenditures as of June 2023. In summary, a large portion (71%) of the funding was awarded to projects for operating supplies, where the next larger portion (24%) was funded for law enforcement overtime, followed by grant administration (4%) and consulting services (1%). As this project funding was termed for one year, due to General Fund money being utilized, grant projects were unable to fund full-time positions to prevention efforts.

Programmatic Reporting (As of March 2023)

During the month of March, our department received our 1,000 CatEtch sticker kits just in time to hand out during our crime prevention classes that focused on catalytic converter theft prevention. We did not receive the stickers until the week of March 13th so in three weeks, we distributed 48



sticker kits at our community stations and at the crime prevention classes. Additionally, we had our employees dedicate over 34 hours of their time to this program, either through handing out the sticker kits, preparing and teaching the crime prevention class, or reaching out to all the local Arvada auto shops. Two of our officers actually physically went to each auto shop in the city and if there wasn't anyone there, they sent them a flyer about what our police department is attempting to accomplish with this program. In all, 80 auto shops were contacted. During the month of March, we put out one social media post about the crime prevention classes and that people can come pick these kits up at any of our community stations. This post included community stations at the Arvada City Hall, West Woods Community Station, Whisper Creek Community Station and Lake Arbor Community Station.

Programmatic Reporting (As of April 2023)

During April, two (2) of the approved GPS trackers were purchased. Additionally, GPS trackers and camera equipment were purchased previously in March however payment was not completed until April which is reflected on the reimbursement reporting form. To date, CSPD has purchased 13 of the 14 cameras requested in the grant application. The drop vehicle was delivered, and it was outfitted with cameras purchased through grant funding. Unfortunately, two primary detectives were out on medical leave during the month of April which limited deployment activities. Due to this, no personnel hours are being reported during this reporting period. It is anticipated that the unit will be fully staffed and deployable in May so there will be weekly deployments during the months of May and June. The second drop vehicle will be deployed during the same period. Further, a detail is



planned in May to interview several individuals that are prolific in illegal catalytic converter activity. The information gained from the interviews will be useful in subsequent investigations.

Activity 3.3 Deter converter theft by providing reimbursement, on a case-by-case basis, for the purchase and installation of converter hardening systems in an amount not to exceed \$500.

In February 2023, the Colorado State Patrol Investigative Services Section (CSP ISS) developed a new catalytic converter identification and theft prevention program (also known as the CCITP). This type of program had not been funded, tried, or tested in Colorado previously. CSP ISS's goal is to target four (4) primary processes during this grant period of February 7, 2023, through June 30, 2023, which is the grant period: (1) Education for recycled metal purchasers on current and recently changed Colorado Revised Statutes to Colorado entities in the business of purchasing metals, particularly in the intake of catalytic converters for recycling. Guidance will discuss business practices and documentation required to ensure and demonstrate compliance with the statutes for these businesses. (2) Assessment and inspections of recycled metal purchasers through the usage of a self-assessment questionnaire to be provided to all known entities in Colorado in the business of purchasing metals, particularly in the intake of catalytic converters for recycling. (3) This project will also include law enforcement inspections of some of these businesses involved in purchasing metals for compliance with those same statutes. (4) Providing assistance to victims of catalytic converter theft and providing prevention, deterrence, and detection measures to help address catalytic converter theft. CSP ISS has partnered with the CSP Victims Services Unit to assist victims of catalytic converter theft in the State of Colorado by offsetting the cost of repairing a vehicle for which a catalytic converter has been stolen. Furthermore, to prevent additional catalytic converter thefts involving people who have already been victimized, the project seeks to offset costs towards the installation of a vehicle hardening kit to protect catalytic converters from being stolen from the victims in the future. We also received funding to secure and provide CatEtch labels to all victims that applied for the program to help deter future catalytic converter thefts, help recover them if a theft does occur, and to assist in follow-up investigations into the theft. Many of these aforementioned processes were initiated in February. CSP also created an application for the Catalytic Converter Assistance Program, and announced the program via a news release issued by the CSP Strategic Communications Unit. The announcement gave applicants the month of March to complete applications. The efforts in February were primarily programmatic and development-oriented in scope.

During the month of March, the Colorado State Patrol received a total of 367 applications. During April, a core committee that was created to develop a fair and impartial system to award assistance to some of the applicants with the funds available reviewed the applications submitted. All applicants (367) were offered a CatEtch label at no charge to them. Additionally, all applicants received a personalized letter in .pdf format as an attachment sent to them via email indicating whether they were selected (or not selected) for catalytic converter or hardening reimbursement, and if so, in what amount. CSP has demonstrated agility and adaptability within this grant program by reprioritizing our funding allocation through a grant modification process to specifically focus on providing more assistance to victims of catalytic converter theft, as CSP had significantly more victim requests than there was allotted funding for. To date, June 25, CSP has been able to target approximately 198 victims for reimbursement. It is important to note that not all of these victims have completed the required steps to receive reimbursement yet as part of this grant but CSP is continually communicating with those that have not completed these required reimbursement processes as a reminder and to assist them with the process.

As part of this program, the victim's service unit has helped victim recipients locate repair shops to have their catalytic converters replaced. CSP also engaged in a partnership effort with the Colorado Department of Public Health and Environment (CDPHE), Air Pollution Control Division (APCD), and directs all victims getting replacement catalytic converters through this grant program to the APCD



Stations to ensure appropriate service work and CAT replacements are being completed. Since this engagement effort began, the APCD has identified 14 replacements of catalytic converter instances where the service center had not completed the proper documentation for the service, and in some instances, had completed an incorrect installation of the catalytic converter. The APCD then provided the recipient with a form DR2365 to where they could return to the service center and address the problem directly with the business.

CSP has developed and presented training regarding Catalytic Converter theft at the Colorado Auto Theft Investigators (CATI) conference in a joint presentation with the Colorado Springs Police Department. CSP also partnered with the Englewood Police Department to train a detective team on the Catalytic Converter program and inspected two businesses that buy catalytic converters. The Englewood Police Department identified a potential investigative lead into potential illegal catalytic converter business practices at one of these businesses that the Englewood Police Department is following up on. CSP has also inspected businesses during this grant period, including one that is potentially involved in illegal catalytic converter business practices that may be tied to an investigation that the Colorado Springs Police Department is investigating as part of a potential catalytic converter theft syndicate.

CSP has engaged in all of these efforts from inception over the last six (6) months and in partnership and continual engagement and communication with CATPA and the CATPA Board.
