Dear Senator Lambert and Committee Members:

Pursuant to 24-33.5-424 (3.5)(f) C.R.S., the Colorado Bureau of Investigation (CBI) is required to annually report to the Joint Budget Committee (JBC) the number of full-time employees (FTE) used by the Bureau in the preceding year for the purposes of performing firearms background checks and the calculations used to determine the amount of the fee imposed for firearms background checks. As of December 31, 2016, the CBI InstaCheck Unit had a total of 33.0 FTE.

In the January 15, 2016 letter to the JBC, the Department estimated the fee for firearms background checks at \$6.17 but rounded it down to \$6.00. To calculate the fee for calendar year 2017, the Department used the cost categories shown below.

\*NOTE: Payroll data for December 2016 has not been posted in the CORE accounting system at the time of this writing. Therefore, the Department used November 2016 data as an estimate for December.

Included in the fee calculation is the use of surplus cash fund balance in the amount of \$480,000. This amount was calculated to reduce the excess uncommitted cash fund reserve balance to an amount slightly below the 16.5 percent reserve requirement, which also assumes the fee is maintained at \$6.00 per firearms background check.

Due to the continued hiring effort to fill vacant positions in the latter half of FY 2016-17, the Department may achieve the reserve requirement prior to January 2017. When this occurs, the



Department estimates that the fee would be raised to an amount up to \$7.48 per firearms background check. This would be done to ensure the remaining fund balance can support the direct and indirect costs of the InstaCheck Unit without creating potential cash flow problems.

For the time being, however, the CBI recommends to keep the fee unchanged at \$6.00 per firearms background check until the reserve requirement is met. The CBI will communicate this information to all its customers in the coming weeks.
