Dear Representative Hamner and Committee Members:

Pursuant to 24-33.5-424 (3.5)(f) C.R.S., the Colorado Bureau of Investigation (CBI) is required to annually report to the Joint Budget Committee (JBC) the number of full-time employees (FTE) used by the Bureau in the preceding year for the purposes of performing firearms background checks and the calculations used to determine the amount of the fee imposed for firearms background checks. As of December 31, 2017, the CBI InstaCheck Unit had a total of 42.0 FTE.

Since 2016 the fee for firearms background checks was set at \$6.00 to reduce the excess uncommitted reserve balance as required by 24-75-402 C.R.S. It remained at that amount until January 31, 2018. Beginning February 1, 2018, the Department increased the fee to \$15.00 per background check in order to match revenue earned with the projected expenses in the remaining months of FY 2017-18. Thereafter, the Department will reassess the fee.

The table below shows the major expenditure categories for CBI's InstaCheck Unit in Rows A through D and totals \$3,189,548. To match annual revenue with the expected expenses, the Department used two different time periods each with a different fee amount: \$6.00 per background check from July 1, 2017 to January 31, 2018; and \$15.00 per background check from February 1, 2018 to June 30, 2018.

If the actual number of firearm background checks matches the annual projection, then the



Department expects revenue to exceed expenses by \$75,229 for FY 2017-18. The CBI will communicate the change in fee with all its customers in the coming weeks.
