Colorado Bureau of Investigation (CBI)*	Grant funding will support a portion of the costs of genetic testing for sex offenders using DNA analysis. This grant award is mandated by statute C.R.S. § 17-2-201(5)(g)(III).	\$ 18,000
Colorado Department of Corrections (DOC)*	Grant funding will support 1.5 positions in the Victim Services Unit (VSU). This unit provides: 1) information on the status of offenders in DOC to victims who are registered in the Victim Notification program; 2) assistance and support to victims who attend Colorado Parole Board Hearings and Community Corrections Board reviews; and, 3) referrals to other victim services providers.	\$ 128,073
Colorado Department of Human Services/Division of Youth Corrections (DYC)*	Grant funding will provide partial support for the Victim Services Coordinator who is responsible for ensuring that the rights of all victims enrolled in the victim notification program are provided.	\$ 28,549
Colorado Department of Law Attorney General's Office *	Grant funding will support one Victim Advocate to provide statutorily mandated victim services under the Victim Rights Act (VRA) to those victims whose cases are handled by the Attorney General's Criminal Justice Section and Appellate Unit.	\$ 72,651
Colorado State Judicial Branch/Office of the State Court Administrator – Division of Probation Services *	Grant funding will support an equivalent of a .75 FTE Victim Assistance Coordinator; however, the FTE will be distributed among several Judicial Districts. This program is designed to maintain victim assistance programs in probation departments throughout the state, and to ensure that Colorado probation departments are in compliance with the Victim Rights Act (VRA).	\$ 54,393
Colorado State Patrol (CSP) *	Grant funding will support several Victim Advocates positions around the state that provide comprehensive services to victims of traffic crashes (and their families) on Colorado highways where an injury or death occurs. The advocates ensure compliance with the Victim Rights Act (VRA).	\$ 166,990

Colorado Coalition Against Domestic Violence (CCADV)**	Grant Funds will provide partial salary support for the Advocacy & Resources Director and two Advocacy and Resources Coordinator positions. Funded activities include providing general support, education, and technical assistance to membership programs as well as initiatives that will strengthen the skills of domestic violence advocates around Colorado.	\$ 95,550
Colorado Coalition Against Sexual Assault (CCASA)**	Grant funds will provide partial salary support for the Executive Director, Membership Coordinator and Advocacy Director positions. Funds will provide general support for membership services, community education and technical assistance to Colorado communities on sexual assault issues.	\$ 156,322
Colorado Department of Human Services - Juvenile Parole Board**	The Victim Services Program is designed to enhance compliance with the Victim Rights Act (VRA) by: 1) providing notification services to VRA victims; 2) ensuring that victims have the opportunity to address the Juvenile Parole Board; and, 3) making sure victims are notified of the outcome of parole hearings. The Victim Advocate will provide VRA training to parole board members. Training on parole board policies/procedures will be given to DYC. Training will focus on policies/procedures related to victim attendance at parole hearings.	\$ 59,585
Colorado Department of State – Secretary of State**	Grant funds will support one .5 FTE Administrative Assistant to assist with enrolling victims in the program and forwarding their mail, as well costs associated with forwarding mail to victims. The Colorado Address Confidentiality Program protects the confidentiality of a victim’s location by providing a legal substitute address and a confidential mail forwarding system.	\$ 36,863
Colorado Nonprofit Development Center	Grant funds will support positions in Denver and Colorado Springs by providing advocacy to lesbian, gay, bisexual, transgender, and queer victims of domestic, sexual, hate and bias motivated violence.	\$ 42,516
Colorado Organization for Victim Assistance (COVA)**	Grant funds will provide partial support for six positions (Executive Director, Deputy Director, Training Coordinator, Program Supervisor, IT Coordinator and Administrative Assistant). Funds will support the training program, the annual statewide conference, and the Victim Assistance Academy training program. Funds will also support the administration of the Victim Services Intern Program, the Crime Victim Emergency Fund, the Victim Service Provider Communication and Collaboration network and Special Events.	\$217,302
Families of Homicide Victims & Missing Persons	Grant funds will provide partial support for four positions (Executive Director, Victim/Family Coordinator, Outreach Coordinator and Database	\$19,000

(FHVMP)**	Manager/Researcher). The project advocates for co-victims of unsolved homicide cases, raises public awareness about cold cases, reaches out to family members of cold cases, provides training to law enforcement on the needs of cold case victims, maintains a cold case database, and holds an annual conference.	
Rocky Mountain Victim Law Center	Grant funds will support an Attorney and Paralegal/Victim Rights Outreach position. The agency provides legal representation to victims of crime in Victims Rights Act (VRA) cases.	\$75,000

DEPARTMENT OF CORRECTIONS – PRISON INDUSTRY ENHANCEMENT PROGRAM

AGENCY	PROJECT DESCRIPTION	TOTAL AWARD FOR FY2012
Colorado Organization for Victim Assistance (COVA)	This grant continues the Crime Victim Emergency Fund. These funds are provided by the Colorado Department of Corrections Prison Industries Enhancement Program. Based on a Federal requirement, these funds must be used to directly compensate victims of crime. This fund is used for emergency needs of victims that are not covered by Victim Compensation funds. This grant does not compete with other grant applications that receive grant funds.	\$52,000

Monies from the Department of Corrections – Based on a federal requirement, Prison Industry Enhancement Program must be utilized to directly compensate victims of crime. These funds are specifically earmarked for a Crime Victim Emergency Fund. A separate State VALE Program Announcement is used to award a grant from this fund. This grant does not compete with other grant applications that receive funding from the general State VALE program.
