Transfer of Community Corrections Funds

In July, 1998, the Division of Criminal Justice will be transferring **\$7,650** out of the *Transition (791)* line item and into the *Diversion (792)* line item. The total amount of transferred FY 1997-98 Community Corrections funds, including prior moves of \$626,705 at the beginning of the fiscal year, \$242,600 in January and \$87,942 in May, represents approximately 3.34% of the total original Community Corrections appropriation.

The purpose of this transfer is to move funds between line items in order for the contractors to maximize use of community corrections funds. See attached chart.
