In July, 2003, the Division of Criminal Justice will be transferring **\$80,000** from the "*Transition*" line to the "*Diversion*" line. Diversion funds support beds for direct sentences to Community Corrections by judges. Transition funds support halfway house beds for prison inmates. The total amount of transferred funds represents approximately .22% of the original total Community Corrections appropriation.

The purpose of this transfer is to move funds between line items in order for the contractors to maximize use of the community corrections allocation. See attached chart.
