May we respectfully give notice that the Division of Criminal Justice intends to transfer monies appropriated in FY 09-10 for Community Corrections in the following fashion:

<i>Transfer from Transition residential line (DC69 APPR 791)</i>	<i>\$84,347.00</i>
<i>Transfer to John Eachon Reentry Program (DC62 APPR 762)</i>	<i>\$84,347.00</i>

Such transfers are authorized by CRS 17-27-108(5), and constitute less than 10% of the monies appropriated for Community Corrections. The purpose of this transfer is to comply with the negative supplemental appropriation reflected in SB 09-198, and to provide for maximum use of community corrections funds.
