


## Colorado Local VALE 2021 Annual Report Executive Summary

Colorado's local Victim and Witness Assistance and Law Enforcement (VALE) funding structure is unique in the nation. There is no other state that has legislated local funding for agencies providing direct services to crime victims.

- \$9,018,238 = Local VALE Funds allocated to 189 programs across the state to provide direct services to serve victims of crime during calendar year (CY) 2021. This is approximately 28% decrease in CY 2020 funds allocated.
- \$11,611,29 = Local VALE funds collected for local VALE program expenditures in CY 2021. This is an approximate 16% from CY 2020.

## CY 2021 Colorado Top 3 Local VALE Victim Services Funded

## **Local VALE Annual Reports**

C.R.S. §24-4.2-108 mandates that each of the local VALE boards submit to the Division of Criminal Justice an annual report detailing:

- 1) Amount of funds granted to agencies;
- 2) Number and type of agencies applying for grant funds; and,
- 3) Projects and services for which grants were awarded.

The graphs and summarizing data in this report provide an overview of the types of grants that were awarded by local VALE boards. The report also breaks down the percentage of funds supporting each victim service and law enforcement category. A detailed chart of each judicial district's awards is also included in the report.

## CY 2021 Local VALE Summary Grant and Scholarship Awards

During CY 2021, 189 grants and 179 scholarships were awarded to various organizations by local Victim Assistance and Law Enforcement boards. These grant awards and training scholarships totaled \$9,018,238. Individual judicial district local VALE program activity for CY 2021 begins on page 29. #### Colorado Local VALE Programs Ability to Meet Crime Victim Needs

On average, annual state revenue collected for local VALE programs over the past decade is sufficient to pay for only 72% of funds requested by agencies to provide direct services to victims in their communities.

Other possible sources of funding to pay for these critical services include the competitive grant process for federal funds from the Victims of Crime Act (VOCA) and the Violence Against Women Act (VAWA).




Figure 2 CY Local Victim Services Unmet Grant Funding Needs

Figure 2 below outlines the percentage of difference between the dollar amount of local VALE grant requests received and the dollar amount of local VALE funds available for allocation. chart illustrates that over the past five calendar years, local VALE programs have received an average of \$2,105,390 or 25% more in requests than funds available.

## Colorado Local VALE Statutory Structure

In 1984, the General Assembly approved legislation to establish the Assistance to Victims of and Witnesses to Crimes and Aid to Law Enforcement Act (VALE). The VALE Act has been amended several times since its original passage in 1984. The legislation established a funding mechanism for agencies to provide services to crime victims through local VALE programs established in each of Colorado's 22 judicial districts. The VALE statute outlines services for crime victims that may be considered for funding. Each judicial district is responsible for the administration, financial management, and decisions regarding its local VALE funds.

The Crime Victim Services Advisory Board (Advisory Board) is responsible for the development of, revisions to, and compliance with the *Standards for the Administration of Victim and Witness & Law Enforcement Programs (Standards)*. The *Standards* were established in 1992 and have been amended periodically.

## **Local VALE Funding Decision Making**

The Act provides for a five-member board (appointed by the Chief Judge) in each judicial district. Each local board accepts applications and makes decisions regarding the use of VALE funds in that judicial district.

#### **Local VALE Funding Priorities**

There are two statutory priority service types for VALE funding. One priority establishes funding for programs that implement the Victim Rights Act (C.R.S. §§24-4.1-302.5; 24-4.1-303; and 24-4.1-304). The other priority is funding for victim and witness services which are listed in C.R.S. §24-4.2-105(4). These include, but are not limited to, crisis intervention services, referrals of victims to appropriate community services and victim compensation programs, translator services, and counseling.

## **Colorado Local VALE Program Operations**

Colorado's decentralized system establishes a separate Victim and Witness and Law Enforcement (VALE) program in each of the state's 22 judicial districts. Per Colorado statute, agencies may submit a grant application for funding in the judicial district where services are being, or will be, provided.

Local VALE revenue is insufficient to fully fund all grant application requests for direct victim services. For that reason, local VALE programs may also require agencies to demonstrate that they have sought other funding sources to pay for direct victim services. 


Figure 3 Map of Judicial Districts of Colorado

# **Colorado Local VALE Funding**

#### State Criminal Fines and Surcharges

Local VALE Programs in Colorado's 22 judicial districts receive funding from fines and surcharges assessed, and collected, at both the state and federal level. State funding refers to fines and surcharges collected, and disbursed, at the local judicial district level. State VALE funds are collected from offenders who are convicted of, or receive a deferred sentence for, crimes and/or traffic offenses classified as follows:

Felony \$163.00

Misdemeanor \$78.00

Class 1 Misdemeanor Traffic Offenses \$46.00

Class 2 Misdemeanor Traffic Offenses \$33.00

Class A or class B traffic infraction - as delineated in C.R.S. §24-4.1-119 (f)(I) and C.R.S. §42-4-1701 (4). (Fees vary as to the type of infraction.)

#### Priority Funding Areas for Local Vale

There are two priority funding areas for local VALE funding pursuant to current Colorado statute.

- Funding for programs that have statutory responsibilities pursuant to the Victim Rights Act (C.R.S. §24-4.1-302.5; §24-4.1-303; and §24-4.1-304).
- Funding for victim and witness services which are listed in C.R.S. §24-4.2-105(4). This includes, but is not limited to, crisis intervention services, referrals of victims to appropriate community services and victim compensation programs, translator services and counseling.

#### CY 2021 American Rescue Act Plan Funds

On March 11, 2021 the federal government enacted the "American Rescue Plan Act of 2021" (ARPA) to provide support to state, local, and tribal governments in responding to the impact of the COVID-19 public health emergency and to assist them in their efforts to contain the effects of the COVID-19 public health emergency on their communities, residents, and businesses.

As part of the federal act, Colorado received \$3,828,761,790 from the federal coronavirus state fiscal recovery fund to be used for specific purposes identified in the federal act. This act allocated a total of \$15 million to be appropriated for victim's services programs and purposes related to populations that have been disproportionately negatively affected by the COVID-19 public health emergency, including those affected by domestic violence, sexual assault, and violence generally. The money was appropriated from the economic recovery and relief cash fund using money from the federal coronavirus state fiscal recovery fund.


For the state fiscal year of 2022, the act appropriated \$3,000,000 from the economic recovery and relief cash fund to the State Court Administrator's Office (SCAO) of the Judicial Branch to be allocated to local VALE Programs. ARPA funds are being used to fill the gap in the loss of revenue for local VALE programs during the COVID pandemic period. All allocated ARPA funds for local VALE programs were required to be fully expended by June 30, 2022.




## CY 2021 - 2012 Number Approved Local VALE Grants and Scholarships
