# Utes Host The Division Of Criminal Justice

On September 27th and 28th, members of the Ute Mountain Ute and the Southern Ute tribal reservations in southwestern Colorado welcomed staff and board members from the Juvenile Justice Unit, Drug Control and System Improvement Unit, and Victims' Unit from the Division of Criminal Justice. Flying over the Rockies in a small plane for the two days of meetings and conversation was a thrill for the people who attended from the Front Range! Our Victims' Unit was well represented: Rob Gallup, Peggy Gordon, and long time Victim Compensation and Assistance Coordinating Committee member Barb Kendall were in attendance.

We spent the first day with the Ute Mountain Utes, in the town of Towaoc, located 20 miles southwest of Cortez. Members of the Ute tribe from the White Mesa reservation in Utah also participated in the discussion. Meeting Marcianne Wing, the victim advocate for the tribe, was a highlight for us. She is doing a tremendous job, and shared with us the challenging and

exhausting work she is doing in serving victims on both reservations.

We also had the opportunity to meet with members of the tribal council, tribal court judges and prosecutors, law enforcement officials and numerous directors and case managers from the local human service agencies. We came away with a better understanding of the challenges that the Ute Mountain Utes face with regard to substance abuse, domestic violence, and crime and victim service delivery.

On the second day we visited the Southern Ute reservation east of Durango. Here again, we had the valuable opportunity to meet with tribal leaders, human services agencies, and victims services staff,

# **Statewide Victim Services Planning**

Phase two of the Statewide Planning effort began on May 22, 2001. The members of the steering committee (Nancy Lewis, Steve Siegel, Peggy Gordon, Marti Koverner, Jill McFadden, and Carol Poole) were pleased to see over 40 people representing a variety of criminal justice and victim service agencies from around the state. The group was engaged and ready to provide input into the next action phase of this planning process.

The group reviewed information collected from the first phase of the project. This included surveys from victim service providers, focus groups and victim interviews. Bill Woodward (previous DCJ Director turner consultant) facilitated the meeting. He worked with the group to prioritize the options, from the research, for implementation of the statewide plan.

To further this effort the group developed the following mission statement.

#### To improve the lives of those affected by crime by:

- Providing increased resources to communities (through legislation, education, information and additional funding):
- Developing strategies for implementation of local priorities;
- Identifying and responding to local stakeholders;
- Incorporating the voice and experience of victims of crime in decisions that affect the field of victim services;
- Supporting the prevention of crime.

To this end the group provided direction for the next years activities by prioritizing the research finding. Those priorities include:

- Catalogue and evaluate how victim services have improved the lives of crime victims. This will include additional research from victims who do not report crime. A selective analysis of what is working/not working with various victim programs.
- To develop more meaningful partnerships with victim services in law enforcement, prosecution, courts, and probation. To develop strategies to best use training resources across systems and community based organizations.
- To evaluate funding resources, including municipal surcharge strategies and to assess local VALE collections.
- Meet with state and local funding boards, and other system and agency groups to develop and institutionalize strategies for improved and more uniform funding decisions, funding of innovative programs and responding to data collected in the statewide planning process.

The group divided into four groups and each group has been meeting separately to accomplish their specific goals. The group will come back together in January 2002. In the OVP newsletter I will include summaries from each of the four work groups. ## Do You Know About The Compensation From Benefits Of Crime Statute?

Since 1981, the Colorado Legislature has enacted numerous laws designed to ensure the constitutional rights of victims, provide financial resources to victims, and to support programs that benefit victims.

Many of these laws, Victim Compensation, Victim Rights Act, and the Local VALE statutes, are used on a daily basis. However, one of the Colorado statutes is not as well known. This is the Compensation from Benefits of Crime statute. This law was enacted because the Legislature felt that the state has a compelling interest in preventing any person who is convicted of a crime from profiting from the crime to the further detriment of the victim. Because of this compelling interest, the Legislature provided a mechanism whereby any profits from a crime that are received by the person(s) convicted of that crime are available as restitution to the victims of the crime.

Any money that would be paid to the convicted person(s) or their representative must be paid to the Victim Assistance and Law Enforcement Advisory (State VALE) Board. The Board must deposit these funds into an escrow account for the benefit of any victim of the crime for which the person was convicted. Any moneys which are not subject to a current order of restitution and that would otherwise go to the convicted person are available to victims of that crime either through additional orders of restitution or as the result of a civil action to recover a judgment against the convicted person.

The State VALE Board is required to notify any victims of that particular crime, at their last known address, of the establishment of an escrow account. The Board must also, at minimum, publish annually a notice of the escrow account in a newspaper which is circulated throughout the county in which the crime was committed.

Any person who knowingly fails to comply with the requirements of the statute can be liable for a civil penalty of not less than ten thousand dollars nor more than three times the potential profit.

After a five year period from the time the escrow account was established, if moneys remain in the escrow account after payment of all judgments, those monies will be used to pay the costs of housing the convicted person in the Department of Corrections.

Although this particular statute was originally passed in 1984 and has been amended several times, there have not been any funds deposited in an escrow account. However, it is important that victims of crime, victim service providers, and law enforcement officials are aware of this statute and contact the Division of Criminal Justice if they know of a potential situation (movie, screenplay, book, or other revenue producing endeavor) that could occur as a result of a crime in Colorado.

It appears as if nine out of ten VRA complaints are in reference to the same issues as 3½ years ago, however the frequency of some of the complaints regarding various issues has changed. Number 10 in 1998 no longer appears on the list, and has been replaced by a completely new complaint. It should be noted that the primary issue for #10 (2001) is the concern of victims who are not receiving notification from the jails when an individual is released from custody. This also appears to be a concern for the juvenile detention facilities.

# **VOCA GRANTS AWARDED**
