### **BACKGROUND**

In 1992, the Colorado General Assembly passed legislation <sup>1</sup> which created the Sex Offender Management Board to develop standards for the assessment, evaluation, treatment and behavioral monitoring of adult sex offenders. The Board issued the document "Standards and Guidelines for the Assessment, Evaluation, Treatment and Behavioral Monitoring of Adult Sex Offenders" (hereafter Standards) in January of 1996. The Standards were revised in June 1999, and again in June 2004. State statute<sup>2</sup> prohibits the Department of Corrections, the Judicial Department, the Division of Criminal Justice of the Department of Public Safety, or the Department of Human Services from employing or contracting with, or allowing a convicted sex offender to employ or contract with providers unless they meet these Standards.

### APPLICATION PROCESS

Since 1996, the Board has been working to process the applications of Treatment Providers, Evaluators, Plethysmograph Examiners, Abel Assessment Providers and Polygraph Examiners to create a list of these providers who meet the Standards. Application materials may be obtained by calling (303) 239-4526.

### WHAT THE LIST MEANS:

When a provider is listed in the List, it means that he/she (1) has met the education and experience qualifications established in the Standards and (2) has provided sufficient information for a determination that services appear to be provided according to the Standards. In addition, each provider agrees in writing to provide services in compliance with the standards of practice outlined in the Standards.

Being on the List is neither licensure nor certification of the provider. It does not imply that all providers offer exactly the same services. The List also does not create an entitlement for referrals from the criminal justice system.

### **HOW TO USE THE LIST:**

The List is organized in two parts: (1) alphabetically by county of business address of the provider, and (2) alphabetically by last name within the categories below.

### **CATEGORIES**

### **Treatment Provider**

Full Operating Level: In addition to meeting all the other applicable Standards, a Treatment Provider at the Full Operating Level has accumulated at least 1000 hours of clinical experience with sex offenders in the last five years, and may practice without supervision.

Associate Level: In addition to meeting all the other applicable Standards, a Treatment Provider at the Associate Level has accumulated at least 500 hours of clinical experience with sex offenders in the last five years, and must receive regular supervision from a Treatment Provider at the Full Operating Level.

### **Evaluator**

Full Operating Level: In addition to meeting all the other applicable Standards, an evaluator has conducted at least 40 mental health sex offense-specific evaluations of sex offenders in the last five years. To be initially placed on the list as an Evaluator at the Full Operating Level, the individual must be on the list as a Treatment Provider at the Full Operating Level.

Associate Level: In addition to meeting all the other applicable Standards, an evaluator at the Associate Level has conducted fewer than 40 mental health sex offense-specific evaluations to date and is receiving supervision from an Evaluator at the Full Operating Level. To be initially placed on the List as an Evaluator at the Associate Level, the individual must be on the list as a Treatment Provider at either the Full Operating Level or the Associate Level.

### Polygraph Examiner

Full Operating Level: In addition to meeting all the other applicable Standards, a Polygraph Examiner has conducted at least 200 criminal specific-issue examinations of which they shall have conducted a minimum of 100 post-conviction sexual offender polygraph examinations of which 50 must be post-conviction adult sexual offender examinations, 20 must be sexual history, 20 must be maintenance/monitoring, and the remaining 10 may be any combination of the three categories.

Associate Level: In addition to meeting all the other applicable Standards, a Polygraph Examiner at the Associate Level is working under the guidance of a qualified Polygraph Examiner listed at the Full Operating Level.

### **Plethysmograph Examiner**

Pursuant to 2008 revised Standards, the SOMB no longer approves Plethysmograph Examiners. Thus, the following list does not specify plethysmograph as a specialty.

### **Abel Assessment Examiner**

Pursuant to 2008 revised Standards, the SOMB no longer approves Abel Assessment Examiners. Thus, the following list does not specify Abel Assessment as a specialty.
