Dear Governor Polis:

I'm honored to submit the 2019 Annual Report (Report) on behalf of the Colorado Division of Banking (Division) regarding Colorado state-chartered commercial banks and trust companies, as required by the provisions of Section 11-102-304, C.R.S. In addition, the Report includes information about other regulated entities and programs supervised by the Division.

The financial condition of Division-regulated institutions during 2019 was sound. Colorado state-chartered banks realized continued positive earnings and continued reduction in problem assets. Earnings totaled \$716 million or a return on average assets of 1.47 percent. Nonperforming bank assets are at one of its lowest levels since the financial crises.

Due to the decrease of four state-chartered banks, total assets decreased 9.67 percent to \$50.7 billion as of December 31, 2019, while total deposits held by state chartered banks also decreased 17.35 percent to \$44 billion. Total equity capital of Colorado state-chartered banks decreased by 18.25 percent to \$5.1 billion. Looking ahead, the financial condition of Colorado's state-chartered banks will likely reflect the economic upheaval caused by the coronavirus pandemic.

Colorado chartered trust companies' assets increased to \$268 million, or 63 percent from the previous year, and total fiduciary assets held by Colorado trust companies increased by 36 percent to \$553 billion. In addition, the Division now licenses and regulates 99 money transmitters, a 7.6 percent increase from 2018. Finally the Division also supervises 101 certified eligible public depositories. Further information regarding the regulated entities and the Division is outlined in the body of the Report.

I trust the information presented in the Report is helpful to you and your staff.

# DIVISION OVERVIEW

---

## Division Mission and Structure

The Division of Banking is a unit of the Colorado Department of Regulatory Agencies (DORA). The Division is responsible for the regulation of state-chartered commercial banks, trust companies, and money transmitters. The Division holds charter and license application hearings, issues rules and regulations, and investigates consumer complaints involving regulated institutions. Division staff conducts examinations of state-chartered institutions and licensees. The Division works closely with other state regulators to supervise money transmitters, and works closely with the Federal Reserve Bank of Kansas City and the Federal Deposit Insurance Corporation to regulate commercial banks. The Division is also responsible for the enforcement of the Public Deposit Protection Act to protect public entity deposits held by state and national banks.

The nine-member Colorado State Banking Board (Banking Board) is the policy and rule-making authority for the Division. The Banking Board consists of five members who are executive officers of commercial banks, an executive officer of a money transmitter company, an executive officer of a trust company, and two public members. The Governor appoints Banking Board members to staggered four-year terms. At least two of the commercial bank members must be from institutions with less than \$150 million in total assets and one member must be from the Western Slope. The Banking Board conducts monthly meetings that are open to the public, and the public is encouraged to attend.

The State Bank Commissioner is the administrative head of the Division, responsible for the day-to-day operation of the Division, including personnel matters, records, reports, systems, and procedures. The Commissioner is also responsible for all examination and enforcement functions of the Division, subject to the policy-making and rule-making authority of the Banking Board. The specific duties and powers of the Commissioner are set forth in Section 11-102-102, C.R.S.

As of December 31, 2019, the Division had 47.5 authorized positions, 38 of which were in the Financial Credit Examiner (FCE) category. The 38 FCE classifications consists of a Director of Examinations, four Caseload Managers, 30 field examiners, a training/examination scheduler, a financial institution analyst, and a consumer complaints person. The Division also has two information technologies (IT) auditors to conduct IT examinations of financial institutions and data centers that provide IT services to Division-regulated institutions. The remaining positions include the State Bank Commissioner, Deputy State Bank Commissioner, Operations Manager, Banking Board Secretary, Communication specialist, and administrative support staff.

The Division is organized into two units, *Examinations* and *Operations*. Within the *Examinations Unit*, supervisory and examination responsibilities for the regulated entities are assigned to the Caseload Managers who report to the Director of Examinations. The Caseload Managers supervise examination teams and are the primary Division contacts for supervised institutions.

The *Operations Unit* is responsible for applications, consumer complaints, rules and regulations, automation, policies and procedures, administration of the Public Deposit Protection Act, program development, training, internal audit and review, and accreditation by the Conference of State Bank Supervisors.

## Accreditation, Audit and Sunset Process

The Division's operations are independently reviewed through an accreditation process administered by the Conference of State Bank Supervisors (CSBS). The accreditation program involves annual self-evaluations in accordance with a CSBS-developed questionnaire and rating system, complemented by an on-site review, conducted by the CSBS every five years, at which the Division's processes, products, and personnel are evaluated and rated. The most recent on-site review was conducted in October 2016, with the review team recommending continuation of the Division's accredited status to October 2021. The accreditation process not only provides an independent review of Division operations, but also identifies areas for improvement and provides comparisons to other state banking departments. In addition, CSBS accreditation is one factor used by federal regulatory agencies in determining the acceptability of state examinations pursuant to interagency agreements and alternating state/federal examinations.

Division operations and programs are also subject to periodic audits by the Office of the State Auditor. The auditors review the Division's regulatory programs, oversight of the Public Deposit Protection Act, and resource utilization. Recommendations are then provided to the Division.

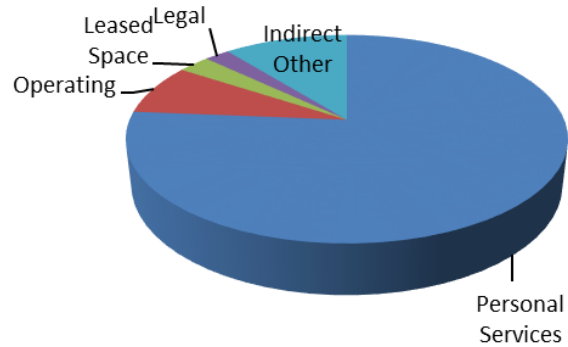
As required by statute, DORA performs Sunset reviews of the functions of the Division and the Banking Board, with respect to regulatory programs. The results of the review and recommendations are provided to the Colorado General Assembly. If the General Assembly does not pass legislation extending such regulation, the program is repealed by operation of law. Continuation of the Division, the Money Transmitters Act, and the Banking Board, was passed during the 2013 legislation session, with all aspects of the Division authorized to September 1, 2024.

# DIVISION OVERVIEW

## Division Budget and Funding

The Division operates on a July 1 to June 30 fiscal-year and is cash funded in advance through semi-annual institution assessments, specialty examination charges, and receipt of application and licensing fees. The Division's approved budget for the 2019-2020 fiscal year is \$6,213,116.

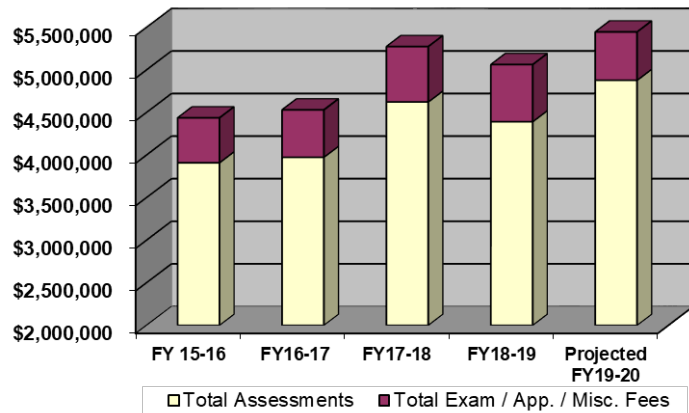
The assessment rates and fee structure are reviewed and approved by the Banking Board annually. Institution assessments are the primary funding source. The assessment consists of a base amount, plus a sliding scale percentage of assets over an established level. The calculation formula is based on projected funding needs, less application and examination fees. A breakdown of the Division's budget, as well as trend information for revenues, assessment base, and the cash fund balance, is depicted in the charts on this page.



**2019/2020 Appropriations**

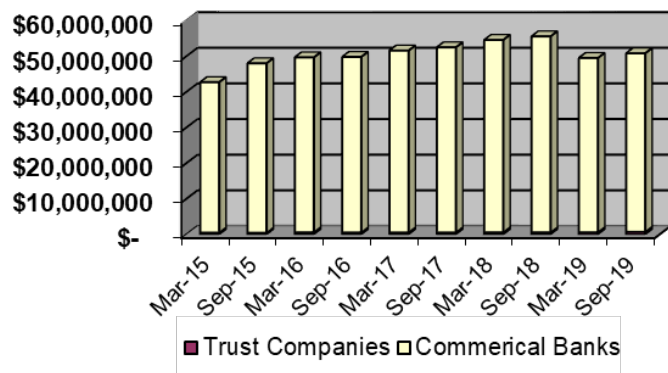

**Assessment Base**

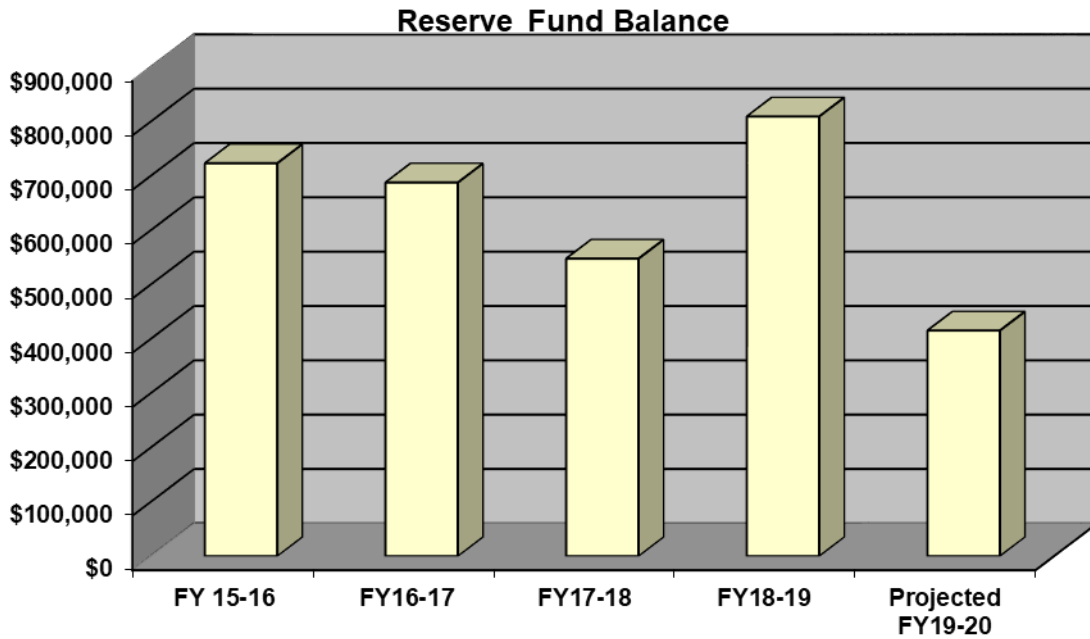

## Reserve Fund Balance

State fiscal laws allow the Division to maintain a cash fund of uncommitted reserves of up to 16.5 percent of approved expenditures. The Division utilizes its reserve fund to dampen assessment fluctuations and strives to maintain a balance of approximately ten percent. The Division's projected reserve fund balance for the fiscal year ending June 30, 2020, and actual fiscal year-end balances for the preceding four fiscal years, are reflected in the following chart:

Colorado state-chartered commercial banks were financially sound in 2019. The vast majority of state chartered banks recorded satisfactory earnings performance, maintained satisfactory capital levels, and reduced the volume of problem assets. However, due to a loss of four state-chartered banks, commercial banks' total assets, loans, deposits, and equity capital declined as noted below.

- Total assets declined 9.67 percent;
- Net loans and leases decreased 11.38 percent;
- Total deposits decreased 17.4 percent;
- Noncurrent loans levels declined to .36 percent of total loans from .52 percent\*;
- Bank owned real estate declined 34 percent\*.

Bank earnings declined 14.6 percent, with net income for all state-chartered banks equaling approximately \$716 million, compared to \$768 million at year-end 2018. However, the composite return on average assets was a robust 1.47 percent an increase from the 1.37 percent recorded for the prior year. Bank capital levels also declined modestly during 2019, as the Tier 1 Leverages ratio equaled 9.45 percent, compared to 9.50 percent at year-end 2018.\*

As of December 31, 2019, there were 11 state-chartered trust companies in Colorado, which is unchanged from 2018. Profitability and capital levels remain satisfactory for state-chartered trust companies. As of January 1, 2020, there were 99 licensed money transmitters operating in Colorado, a net increase of seven from year-end 2018. While profitable overall, five Colorado licensed money transmitters account for 94 percent of the profitability reported in 2019.

## Commercial Banks

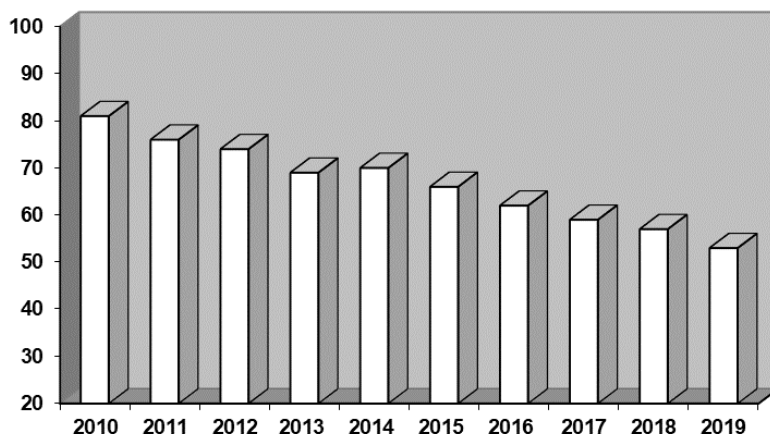
Consolidation in the banking industry continued in 2019 as the total number of state-chartered banks declined to 53. Four Colorado state-chartered commercial banks ceased operations during the year due to mergers into other banks, and the transactions are detailed on page 16 of the report.

Due to the aforementioned decline in the number of state-chartered banks, total assets decreased 9.67 percent under the previous year and total deposits decreased 17.4 percent. Net income also decreased 14.6 percent from the previous year, but state-chartered banks reported a consolidated return on average assets of 1.47 percent.

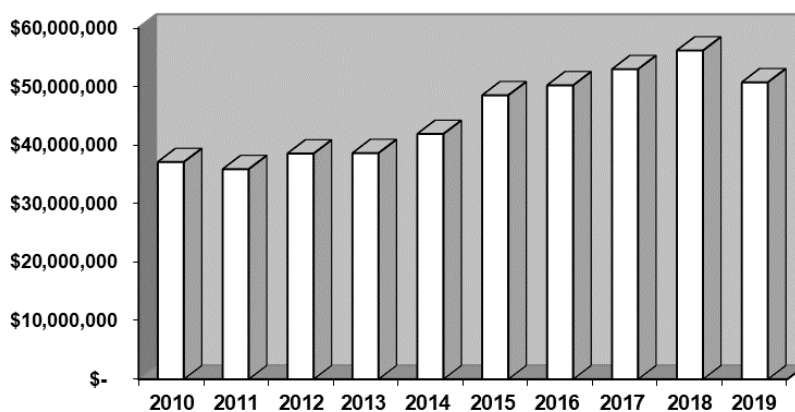
Bank capital ratios reflect a modest decline from the previous year. However, the average leverage ratio equaled a satisfactory 9.45 percent, and the average total risk-based capital ratio equaled 14.93 percent.

The three charts on this page depict the changes in number, total assets, and total equity over a ten-year period ending December 31, 2019.

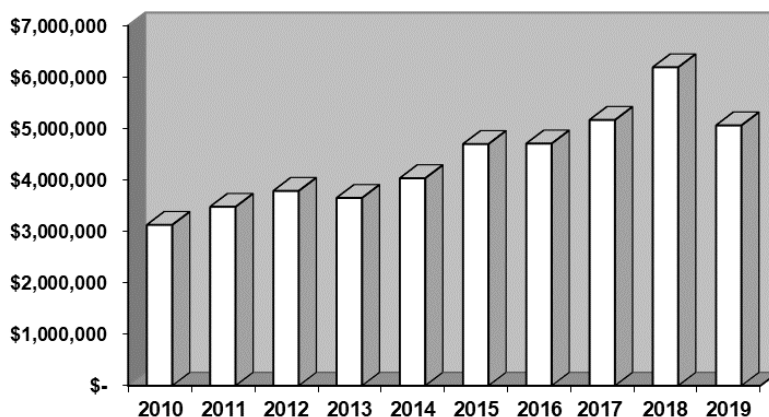
**Number of State Chartered Commercial Banks**

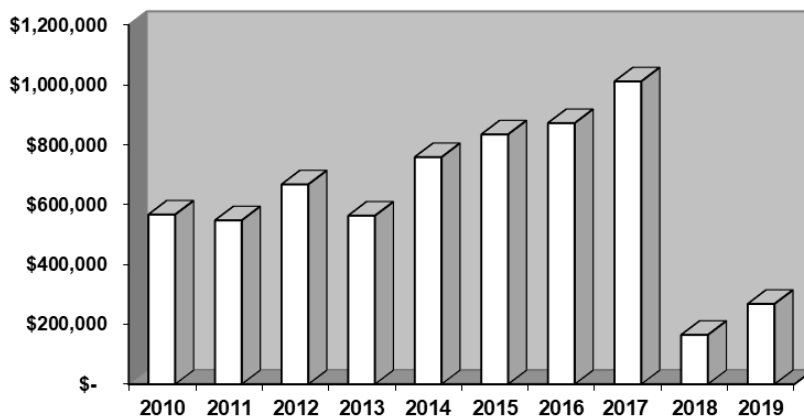
## Trust Companies

State chartered trust companies provide a variety of fiduciary services, including traditional managed trust business, administration of self-directed IRA or pension funds, and administration of collective investment funds. Trust companies are authorized to invest in loans, but are prohibited from originating loans. Trust companies are permitted to apply to the FDIC for federal deposit insurance and if approved, are authorized to accept and maintain savings deposits, time deposits, and certificates of deposit.

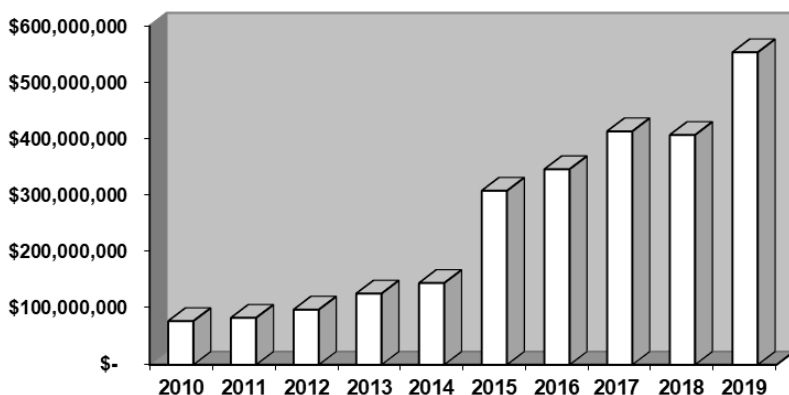
As of December 31, 2019, there were eleven state-chartered non-depository trust companies operating in Colorado. The total is the same as the year previous.

Total trust company assets increased 63%. In addition, total fiduciary assets held by Colorado trust companies increased by \$146 billion to \$553.2 billion. Colorado chartered trust companies remain well-capitalized and profitable.

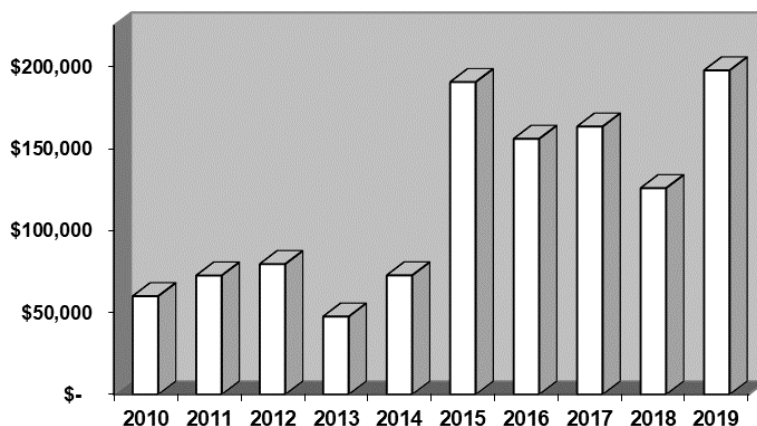
**Total Assets of Trust Companies**

## Money Transmitter Companies

As of December 31, 2019 there were 99 organizations licensed under the Colorado Money Transmitters Act, a net increase of seven from 2018. Licensing is required of any organization selling money orders, travelers checks, or transmitting money electronically or by any means, with the exception of governmental organizations and insured financial institutions.

Total transmission volume increased to \$25.5 billion and total revenue equaled \$88.9 billion. Net income equaled \$13.6 billion with five licensed entities accounting for 94 percent of the profitability reported in 2019. Overall profitability for licensees operating in Colorado declined as 26 percent of active licensees reported net losses compared to 20 percent in 2018.

## Public Deposit Protection Act

The Division is responsible for the implementation and oversight of the Public Deposit Protection Act (PDPA). As of December 31, 2019, there were 101 certified Eligible Public Depositories and 21 certified Escrow Institutions under the Public Deposit Protection Act, unchanged from the previous year. Eligible Public Depository certification is required of any commercial, inter-state, or national bank located in the state of Colorado that will hold Colorado public deposits. Additionally, certification is required of any Escrow Institution that will hold collateral in safekeeping for the protection of Colorado public deposits.

Colorado public deposits are protected by two methods. First, the Federal Deposit Insurance Corporation insures Colorado public deposits up to the established limits. Second, the remaining uninsured portions of these deposits are protected by eligible collateral held in safekeeping. As of December 31, 2019, Colorado uninsured public deposits totaled \$5,239,984,793 with collateral pledged to protect these deposits totaling \$6,638,737,624. These amounts are slightly higher compared to December 31, 2018, with uninsured deposits totaling \$5,175,299,166 and collateral totaling \$6,531,391,949.
