Report of Second Level Appeal and Independent External Reviews Calendar Year 2010

All health carriers offering health coverage plans in Colorado are required to report the number and outcome of second level internal appeals pursuant to §10-16-113, C.R.S., and Colorado Division of Insurance Regulation 4-2-17 to the Colorado Division of Insurance.
