## **Report of Second Level Appeal and Independent External Reviews Calendar Year 2012**

All health carriers offering health coverage plans in Colorado are required to report the number and outcome of second level internal appeals pursuant to § 10-16-113, C.R.S., and Colorado Division of Insurance Regulation 4-2-17 to the Colorado Division of Insurance. The information provided in the following chart was self-reported by each health carrier and includes the number and outcome of each carrier's independent external reviews as required by § 10-16-113.7, C.R.S. Carriers reporting one or more second level appeals are listed first, followed by all other carriers submitting a report.
