## COLORADO STATE BOARD OF EXAMINERS OF ARCHITECTS

December 1st, 1910.

His Excellency, Governor John F. Shafroth, State of Colorado.

In compliance with the provisions of the "Act to provide for the licensing of architects and regulating the practice of architecture in the State of Colorado," enacted by the Seventeenth General Assembly at the Regular Session and approved by your Excellency on the 26th day of April, 1909, the Colorado State Board of Examiners of Architects appointed by your Excellency to faithfully perform the duties required in the enforcement of the Act, make the following report of the proceedings of the board since its organization on the 25th day of October, 1909:

The members of the board as originally appointed and as at present constituted are as follows:

Thomas F. Walsh, President, (4 years), Denver. Robert Willison, Secretary-Treasurer, (4 years), Denver.

Francis W. Cooper, (4 years), Pueblo. F. E. Edbrooke, (2 years), Denver. H. W. Baerresen, (2 years), Denver.

Each of the members of the board took and subscribed an oath for the faithful performance of duty before the Secretary of State and filed same in the Secretary of State's office, and the Secretary-Treasurer filed a bond for the penal sum of two thousand (\$2,000.00) dollars with the Secretary of State, which has been accepted and approved.

Section 17 of the Act required that, "Within the first week of December, after organization of the board, and annually thereafter, the Secretary of the board shall file with the auditor of State a full report of the proceedings of the board, and a complete statement of the receipts and expenditures of the board attested by the affidavits of the President and Secretary. In conformity therewith the reports for each of the two years ending November 30th, 1909, and November 30th, 1910, have been duly filed with the Auditor of State.

The Board of Examiners in enforcing the requirements of the Act has lessened many evils that were detrimental to the professional standing of the architect, and an architect assumes his recognized responsibilities and duties to the people of the State. The Act provides that an architect must have sufficient knowledge and training to safely design, plan and construct any building, without danger to the people in any section of the State, and when found incompetent, reckless or dishonest the further enjoyment of the privileges bestowed on him by the Act are rescinded and the license revoked.

The board recognizes fully its responsibilities and has assumed same with a full sense of their gravity and importance and have endeavored to carry out the true intent of the Act to the best interests of the architects and to the better protection of the people who may require the services of architects. The board received many sound and practical suggestions in completing its organization and advice in the enforcement of the provisions of the Act, from Secretary Peter B. Wright of the Illinois State Board of Examiners of Architects, Secretary Frederick L. Roehrig of the California State Board of Architects, and Secretary Hugh Roberts of the New Jersey State Board of Examiners of Architects, and to these gentlement the board extends its thanks.

The law in several instances will require to be amended so that conflictions may be removed and provisions made for the future maintenance and permanency of the Chair of Architecture to be installed in the University of the State of Colorado, as provided for in Section 6 of the Act, which requires, "and said surplus shall form the nucleus of a fund to provide for an advanced course of architectural study to be established in the University of the State of Colorado." The surplus funds in the hands of the Treasurer after the payment of all expenses at the end of this fiscal year will be sufficient to pay the first year's expenses to provide a Professor of Architecture in the State University; this is made possible on account of the initiation fee for license being \$25.00 for each license, and which will apply only on the first year's income, but in the next and following years the renewal fees will only be \$10.00 for each license, thus reducing the income from fees about 150 per centum. overcome this deficit the board, with your Excellency's assistance, hopes to interest the Legislature sufficiently so that the necessary appropriation may be secured to make the advanced course of architecture the continued success desired. The board is at the present time in communication with the Faculty of the State University, with reference to the possible cost and maintenance of this extra branch of learning and instruction, and when such information has been received the board will present same for your Excellency's consideration and approval.

The board assumed its duties on the 25th day of October, 1909, in the State Capital Building, and was duly organized.

The following officers were unanimously elected and still retain their offices, namely:

Thomas F. Walsh, Denver, President.

Robert Willison, Denver, Secretary-Treasurer.

After the election of the officers the board adjourned until November 15th, 1909, at which meeting Rules and Order of Business were approved and adopted for the government of the board, a copy of the Rules, together with a copy of the Act, is included with this report.

Since the date of the organization of the board and up to the date of this report, fifteen (15) board meetings and (9) committee meetings have been held. At the special meeting held November 5th, 1909, the board approved of the necessary application forms, notices to practicing architects, approval of applications, form of certificates, seal of the Colorado State Board of Architects, receipt forms, record books, stamps for licensed architects, and stationary, etc., required for the secretarial duties of the board.

The board complimented Mr. R. S. Roeschlaub, F. A. I. A., and President of the Colorado Chapter of Architects, by issuing to him Certificate of License No. 1, and the rotations of licenses were conferred consecutively to the members of the board, with preference according to length of time each had been engaged in the practice of architecture in the State.

Notices were sent to all architects known to have been practicing the profession of architecture in the State one year previous to April 26th, 1909, advising them of the passage of the Act, and requesting them to take out licenses in compliance with the law, also stating that after April 25th, 1910, no licenses would be issued, except on merit and by examination.

The board at its first annual meeting re-elected Thomas F. Walsh, President, and Robert Willison, Secretary-Treasurer.

The Secretary submitted a list of architects who had been engaged in the practice of architecture in this State previous to April 26th, 1908, and the board agreed on the merits of the gentlemen included in said list, and those approved were to receive certificates of license when the necessary application forms were properly presented and the initiation fees paid.

On the recommendation of State Treasurer W. J. Galligan and State Auditor Roady Kenehan, the board consulted with counsel as to proper interpretation of the Act with reference to the proper procedure to pursue in the collection and disposal of the fees received, and on their advice it was agreed that the treasurer of the board retain all fees col-

lected and pay all bills during the fiscal year, or until the conflictions in the Act are remedied by the Legislature. The board received much valuable assistance from Attorney General J. T. Barnett and Assistant Attorney General J. H. Teller, in determining its powers in accepting and rejecting applications for license, enabling it to avoid many complications which might otherwise have arisen, and for the courtesies received the board extends its thanks.

Since the organization of the board up to the present date, it has received and acted on one hundred and thirty-five (135) applications for license without examination: of this number twenty-nine (29) have been rejected, three (3) have not paid the initiation fee and one hundred and three (103) have been accepted and received licenses to practice the profession of architecture in the State of Colorado. Each of the parties who applied for license without examination, and were refused such license, were notified that they had the privilege to apply for examination, and several applicants who were dissatisfied did at the suggestion of the board receive personal hearings which proved most satisfactory. Two (2) of the applicants who had been refused licenses without examination, insisted that they were entitled to license according to the law, and brought proceedings against the board in the District Court, to compel the issuance of said licenses. Each of the cases was fully tried on its merits, and the Honorable Court sustained the position of the board on all points, for which results we have to thank Assistant Attorney General J. H. Teller for his able presentation of the cases on behalf of the board.

Copies of the Act, rules of the board and notices sent to practicing architects to secure licenses were forwarded to each District Attorney and Building Inspector in this State, and request for their co-operation in enforcing the Act. The Secretary, in conjunction with Mr. R. S. Roeschlaub, Architect, both members of the commission appointed by the Mayor and City and Council of Denver to revise and recodify the City Building Laws, have been instrumental in

securing proper recognition of the Act in the said building laws now in course of preparation for presentation to the City Council for passage.

It is with regret that the board records in this report the death of Mr. Fred G. Wagner, Licensed Architect and senior member of the firm of Wagner and Manning, Architects of this City, who departed this life in Toledo, Ohio, after a short illness; his marked ability and sterling worth is a decided loss to the profession in this State.

At the regular meeting held on May 16, 1910, the board approved the public notice and regulations for the first semi-annual examination held on June 21st, 22nd and 23rd in the Manual Training High School Building at Denver, and said notice was published in the Sunday edition of the Rocky Mountain News, Denver Republican and Denver Post of May 22nd and 29th, 1910. The curriculum of questions to be answered by drawings and specifications was read and approved, including a circular of information to be sent each applicant for examination, explaining the program and subjects for each day's examination, all of which are on file in the Secretary's office.

On June 20th, 1910, twelve (12) applications had been made for examination to practice the profession of architecture in the State of Colorado, but one of the applicants telephoned on that day stating he would not be present on account of sickness, therefore eleven (11) candidates presented themselves for examination. Two (2) members of the board were present at all times during the three (3) day's examination, and on June 24th the entire board went into executive session which continued until 1:30 a. m. of June 26th, 1910, when each of the applicants' papers had been thoroughly examined and the proper marks credited to them.

The board agreed that any candidate securing seventy (70%) per centum or over of the possible three hundred (300) marks, (being a possible 100 marks for each day's examination), should receive license to practice architecture in the State of Colorado. The highest marks attained

was 276, and the lowest 91, and the minimum passing mark was 210. Four (4) of the candidates passed the 210 mark and the other seven (7) being much lower than the 210 mark, were rejected.

The four (4) successful candidates were duly approved by the board, having passed the examination satisfactorily, by showing their competency and knowledge as to the construction of buildings, strength of materials, design, and planning, and their ability to make practical application of same in the ordinary professional work of an architect; also showed their proficiency as to the duties of a supervisor of the mechanical work upon buildings and the laws of sanitation as applied to buildings. Each of the four (4) successful candidates are now duly licensed architects in this State, and the unsuccessful candidates each had their examination fee of \$10.00 returned, and notified they did not pass.

The next examination of candidates for license to practice architecture in this State will be held on December 28th, 29th and 30th, 1910, in Denver.

In again referring to the advanced course of architecture to be added to the course of studies at present obtained in the University of Colorado, it may be mentioned that the Illinois State Board of Examiners of Architects adopted the following resolution, viz., "Resolved, That after July 1st, 1898, the diploma of graduation from the full four (4) year's course in architecture or architectural engineering in the University of Illinois, be accepted as satisfactory evidence of a competent knowledge of architectural construction, of the laws of sanitation, and of the strength of materials, required in the practice of an architect in Illinois, according to law; provided that in each case the applicant shall present evidence satisfactory to this board to show that he has acquired the ability to successfully apply this knowledge to the design and construction of buildings." The Illinois board adopted this resolution after a personal examination of the architectural course in the Illinois University, and it was able to give recognition to the efficiency of the course pursued in the Illinois State University with reference to those theoretical studies which are necessary to properly fit and adapt the students for practical architectural work, without the necessity for further investigating those of other States and institutions. It behooves the State of Colorado to also furnish such instruction to its students desiring such knowledge, and relieve them from the necessity of going out of the State to secure such knowledge, which often entails extra expenses that can be dispensed with could same be secured at home in our own State University.

A complete list of the architects licensed to practice the profession of architecture in the State of Colorado up to the present date is attached to this report.

#### AN ACT

TO PROVIDE FOR THE LICENSING OF ARCHITECTS AND REGULATING THE PRACTICE OF ARCHITECTURE IN THE STATE OF COLORADO.

ENACTED BY THE SEVENTEENTH GENERAL ASSEMBLY AT THE REGULAR SESSION, APPROVED APRIL 26, 1909, AND IN FORCE OCTOBER 25, 1909.

APPOINTMENT OF A STATE BOARD OF EXAMINERS OF ARCHITECTS.

SECTION 1. Be It Enacted by the General Assembly of the State of Colorado: Within sixty days after the passage of this act, the Governor of the State of Colorado shall appoint a State Board of Examiners of Architects, to be composed of five members, who shall be architects residing in the State of Colorado, and who have been engaged in the practice of architecture at least five years. Two of the said practicing architects appointed as examiners shall be designated to hold office for two years, and the other three to hold office for four years, from the date of the passage of this act.

SEC. 2. Upon the expiration of the term of each member, the Governor shall appoint his successor for a term of four years; each member shall hold over after the expiration of his term until his successor shall have been duly appointed and qualified. Any vacancy occurring in the membership of the board shall be filled by the Governor of the State, for the unexpired term of such membership.

EXAMINERS TO FILE OATH-TREASURER TO FILE BOND.

SEC. 3. The members of the State board of examiners of architects shall, before entering upon the discharge of

their duties, and within thirty days after their appointment, take and subscribe an oath before any officer authorized to administer oaths in the State, for the faithful performance of duty, and file same with the Secretary of State. They shall as soon as organized, and annually thereafter in the month of January, elect from their number a president and a secretary, who shall also be treasurer. The treasurer shall file a bond for the penal sum of two thousand dollars (\$2,000.00) with the Secretary of State, said bond to be accepted and approved by the Secretary of State, before entering upon his duities.

BOARD SHALL ADOPT RULES AND SEAL.

SEC. 4. The board shall adopt all necessary rules, regulations and by-laws to govern its proceedings, not inconsistent with this act, the laws of this State or of the United States. The board shall adopt a seal, and the secretary shall have the care and custody thereof, and shall keep a record of all proceedings of the board, which shall be open at all times to public examination.

ALL EXPENSES PAID FROM THE REGISTRATION FEES.

SEC. 5. The expenses of said board, and of the officers thereof and of the examination held by said board, and of any other matter in connection with the provisions of this act, shall be paid from the registration fees herein provided for, and not otherwise, and in no case shall any of the expenses be paid by the State of Colorado or be a charge against said State.

The members of the board shall be entitled to reimbursement for their traveling and hotel expenses incurred in pursuance of their duties, and shall not exceed five dollars (\$5.00) per diem for each member of said board; the secretary and treasurer of the State board of examiners of architects shall receive such annual compensation as shall be provided by the board, by resolution adopted by it at a regular meeting. Neither the State Treasurer nor any member of this board shall be held responsible for any portion of the secretary's and treasurer's salary, should the fees for certificates received by said board be insufficient to meet the same.

SURPLUS TO FORM FUND FOR ADVANCED COURSE OF ARCHITECTURAL STUDY IN THE STATE UNIVERSITY.

SEC. 6. Any surplus or fees remaining in the hands of the treasurer of this board after the payment of the expenses of the members of the board and the salary of the secretary and treasurer, as herein provided for, shall be paid annually to the Treasurer of the State of Colorado, and shall only be paid out upon the warrant and authority by requisition of said board and the approval of the Governor, and said surplus shall form the nucleus of a fund to provide for an advanced course of architectural study to be established in the University of the State of Colorado.

#### QUORUM.

SEC. 7. Three members of this board shall constitute a quorum.

SPECIAL MEETING-RULES FOR EXAMINATIONS.

SEC. 8. Special meetings of the board shall be called by the secretary upon the request of any two members, by giving at least five (5) days' written notice of the meeting to each member. The board shall adopt rules and regulations for the examination and registration of applicants desiring to practice architecture in accordance with the provisions of this act, and may amend, modify and repeal such rules and regulations from time to time.

FILE WITH SECRETARY OF STATE NAMES OF EXAMINERS AND PUBLISH IN ONE DAILY NEWSPAPER.

SEC. 9. The board shall, immediately upon the election of each officer thereof, and upon the adoption, repeal or modification of the rules and regulations for the registration of applicants for license, file with the Secretary of State, and publish in at least one daily newspaper in the State, the names and postoffice address of each officer, and a copy of such rules and regulations, or the amendment, repeal or modification thereof.

EXAMINATIONS—APPLICANTS FOR LICENSE TO PAY FEE OF \$10.

SEC. 10. Provision shall be made by the State board of examiners of architects for holding examinations at least

twice in each year, of applicants for license to practice architecture, if there shall be any such applicants. Any person over twenty-one (21) years of age, upon payment of a fee of ten dollars (\$10.00) to the secretary of this board, shall be entitled to enter any examination to determine his or her qualifications. If any applicant fails to pass said examination, his or her fee shall be returned; if the applicant passes such examination the fee shall be turned into State Treasury.

EXAMINATIONS IF PASSED, FURTHER FEE OF \$15.00 TO BE PAID—WITHOUT EXAMINATIONS FEE \$25.00—
ALL LICENSES TO BE RECORDED.

SEC. 11. If the examination of any applicant shall be satisfactory to a majority of the board, and upon payment of an additional fee of fifteen dollars (\$15.00) to the said board, a certificate shall be issued to the applicant authorizing him or her to practice the profession of architecture.

Any person who shall at the time of the passage of this act have been engaged in the practice of architecture in this State for at least one year, and who shall present to this board an affidavit to that effect, or a certificate from a similarly constituted board of another State; and any person who is a member of the American Institute of Architects, shall be entitled to receive such certificate upon the payment to the said board of a fee of twenty-five dollars (\$25.00), without an examination by the board of examiners, which fee shall be turned into State Treasury. In the case of a co-partnership of architects, each member must be licensed to practice architecture.

Each person licensed shall cause such license to be recorded in the Secretary of State's office. Failure to have his or her license recorded shall be deemed sufficient cause for revocation of said license.

#### LICENSED ARCHITECTS TO HAVE STAMPS.

SEC. 12. Every licensed architect shall have a stamp, which must contain the name of the architect, his or her place of business, and the words: "Licensed Architect," "State of Colorado," with which he or she shall stamp all

drawings and specifications issued from his or her office, for use in this State.

PENALTY FOR PRACTICING ARCHITECTURE WITHOUT A LICENSE.

SEC. 13. After six (6) months from the passage of this act it shall be unlawful, and it shall be a misdemeanor punishable by a fine of not less than ten dollars (\$10.00), nor more than two hundred dollars (\$200.00), for any person to practice architecture without a license in this State, and to advertise or put out any sign or card or other device which might indicate to the public that he or she is entitled to practice as an architect except as otherwise provided in this act.

PERSONS WHO ARE TO BE REGARDED AS ARCHITECTS.

SEC. 14. Any person who shall be engaged in the planning or supervision of the erection, enlargement or alteration of buildings for others, and to be constructed by persons other than himself except as hereinafter provided, shall be regarded as an architect within the provisions of this act, and shall be held to comply with the same; but nothing contained in this act shall prevent the draughtsmen, students, clerks of works, or superintendents and other employes of those lawfully practicing as architects, under license as herein provided for, from acting under the instruction, control, or supervision of their employers; or shall prevent the employment of superintendents of buildings paid by the owners from acting, if under the control and direction of a licensed architect who has prepared the drawings and specifications for the building. The term building in this act shall be understood to be a structure consisting of foundations, walls and roof, with or without the other parts; but nothing contained in this act shall be construed to prevent any person, mechanic or builder from making plans and specifications for, or supervising the erection, enlargement or alteration of any building less than three stories in height that is to be constructed.

#### LICENSE REVOKED.

SEC. 15. Architect's license issued in accordance with the provisions of this act shall remain in full force until revoked for cause, as hereinafter provided. Any license so

granted may be revoked by unanimous vote of the State board of examiners of architects for gross incompetency, or recklessness in the construction of buildings, or for dishonest practices on the part of the holder thereof; but before any license shall be revoked, such holder shall be entitled to at least twenty days' notice of the charge against him, and of the time and place of the meeting of the board for the hearing and determination of such charge. And on the cancellation of such license it shall be the duty of the secretary of the board to give notice of such cancellation to the Secretary of State, who shall mark the license recorded in his office cancelled. The person whose license was revoked may have a new license issued to him by the secretary upon certificate of the board of examiners, issued by them upon satisfactory evidence of proper reasons for his reinstatement, and upon payment to the secretary of the fee of ten dollars (\$10.00), which fee shall be turned into the State Treasury.

#### . RENEWAL OF LICENSES.

SEC. 16. Every licensed architect in this State who desires to continue the practice of his or her profession shall annually, during the time he or she shall continue in practice, pay to the secretary of the board during the month of July a fee of ten dollars (\$10.00), which fee shall be turned into the State Treasury, and the secretary shall thereupon issue to such licensed architect a certificate of renewal of his or her license for a term of one year. Any licensed architect who shall fail to have his or her license renewed during the month of July in each and every year, shall have his or her license revoked; but the failure to renew said license shall not deprive him or her of the right to renewal upon payment of said fee.

REPORT OF PROCEEDINGS TO BE FILED WITH AUDITOR OF STATE.

SEC. 17. Within the first week of December, after the organization of the board, and annually thereafter, the secretary of the board shall file with the Auditor of State a full report of the proceedings of the board, and a complete statement of the receipts and expenditures of the board, attested by the affidavits of the president and secretary.

#### RULES OF THE COLORADO STATE BOARD OF EXAM-INERS OF ARCHITECTS.

#### RULES.

1. Roberts' Rules of Order shall govern the conduct of business at its meetings.

#### OFFICERS.

2. The state board of examiners of architects shall annually elect a president and secretary, who shall also be treasurer, said officers shall hold office until their successors shall have been duly appointed and qualified. The secretary shall keep a record of all the proceedings of the board, which shall be open to public examination.

#### SEAL OF THE BOARD.

3. The board shall adopt a seal for its own use and shall have the words: "Colorado State Board of Examiners of Architects," and the year "1909" inscribed thereon, and the secretary shall have the case and custody thereof.

#### HEADQUARTERS AND EXAMINATIONS.

4. The headquarters of the board shall be at Denver, and the examinations shall take place at Denver, or such other place as shall be designated by a vote of the board.

#### LOCATION.

5. The office of the secretary and treasurer shall be at room 900 Ideal Building in the City of Denver.

#### FINANCE.

6. All funds collected shall be deposited in bank to the credit of the board, and all checks shall be signed by the secretary and treasurer and countersigned by the president, and no disbursements shall be made except on order of the board. There shall be an auditing committee, composed of two members of the board other than the president and the secretary and treasurer, who shall audit the treasurer's ac-

counts within the last week of November of each year. All bids shall be presented to the board at a regular meeting.

#### REGULAR MEETINGS.

7. The regular meetings of the board shall be held on the third Monday of each month at 2 P. M., and the place shall be as ordered by the president. Special meetings of the board shall be called by the secretary upon the request of any two members, by giving at least five days' notice of the meeting to each member. Three members of the board shall constitute a quorum.

#### EXAMINATIONS AND CERTIFICATES OF LICENSE.

8. Any person who shall have at the time of the passage of this act, been engaged in the practice of architecture in this State, for at least one (1) year previous to the twenty-sixth (26th) day of April, 1909, A. D., and who shall present to the said board an affidavit to that effect, or a certificate from a similarly constituted board of another State, and any person who is a member of the American Institute of Architects, shall be entitled to receive a certificate of license, upon the payment to the said board of twenty-five (\$25.00) dollars.

Any person over twenty-one (21) years of age, upon the payment of a fee of ten (\$10.00) dollars to the board, shall be entitled to enter any examination to determine his or her qualifications for an architect's license.

If the examination of any applicant for such a license shall be satisfactory to a majority of the board, and upon the payment of an additional fee of fifteen (\$15.00) dollars to the said board, a certificate of license shall be issued to the applicant authorizing him or her to practice the profession of architecture.

Applications for license from residents of other States may be considered at any meeting of the board, without the personal appearance of the applicants; provided, the proofs submitted in connection with such applications from non-resident architects, establish an ability equal to that demanded by the regular written oral examinations, the board shall issue license to such applicants.

Each person licensed shall cause such license to be recorded in the Secretary of State's office.

#### CLASS EXAMINATIONS.

9. Regular written and oral examinations to occupy not more than three (3) days, shall be held as provided by the act of April 26, 1909. The time shall be devoted to ascertaining the ability of the candidate to make practical application of his or her knowledge in the professional work of an architect. The examination shall be directed toward ascertaining the qualifications of the applicant in draughtsmanship, construction, design, the art of planning, and preparing specifications.

#### APPLICATIONS.

10. Applications for examinations will be received at any time, and should their number and urgency make it seem expedient to the board to hold examinations at any other time than herein mentioned, due notice of such additional examinations will be forwarded by the secretary to those whose applications are already filed at his office. Applications to enter a semi-annual examination shall be at the secretary's office one week previous to the time set for such examination.

#### DATES OF REGULAR CLASS EXAMINATIONS.

11. Regular class examinations shall be held in the months of June and December of each year. In all cases in which applications for examinations have remained on file one year or more, the parties have not appeared for examinations, the examination fees shall be returned and the applications cancelled.

#### NOTICES.

12. Applicants will be duly notified of the result of the examinations. All licenses issued to applicants who have passed the June examinations will date from the following July 1. All licenses shall bear the date of the time when finally approved by the board.

#### CO-PARTNERSHIP LICENSES.

13. Each member of a firm of practicing architects, in-

cluding each practicing member of an incorporated architectural firm, shall have a separate license. All certificates of license shall be signed by the president and secretary.

#### ARCHITECT'S STAMPS.

14. The stamp of licensed architects shall be circular and two (2) inches in diameter. The words "State of Colorado" shall appear at the top between two (2) circular lines and the words "Licensed Architect," at the bottom, between the same lines. The name and place of business of the licensee, are to be placed within the inner circle. Where there is a co-partnership of architects, the individual names of the several members licensed may appear on one stamp.
