

## Casino AGP in May Second Best Ever

Colorado casinos in May recorded their second best month of revenues, with \$66.2 million in AGP, up nearly 6.4 percent from \$62.2 million in April and up 4.0 percent from \$63.6 million in May 2004. The May total was surpassed only by \$67.3 million in AGP in July 2004.

Black Hawk's 21 casinos produced \$46.6 million in AGP in May, while Cripple Creek's 19 casinos totaled \$12.9 million. Central City's seven casinos generated \$6.6 million in AGP in May, up nearly 75.8 percent from \$3.7 million in May 2004.

Casinos statewide paid \$11.2 million in gaming tax proceeds in May, up nearly \$1 million over April.

## Commission Action

At its meeting on June 16 in Lakewood, the Commission:

- Renewed the retail licenses of Colorado Grande Gaming Parlor, Imperial Hotel & Casino Corp., Brass Ass Casino, J.P. McGill's Hotel & Casino; Midnight Rose Hotel & Casino, Womacks Casino, Legends Casino and Richman Casino
- Renewed the manufacturer/distributor license of Western Money Systems, Inc.
- Renewed the operator license of John A. Schaffer
- Approved changes of ownership for Colorado Grande Gaming Parlor, Imperial Hotel & Casino Corp., PDS Gaming Corporation-Cor Colorado and Fortune Valley Hotel and Casino

## Commission Retains Tax Rates

The Colorado Limited Gaming Control Commission on June 16 unanimously decided to retain the current gaming tax structure in which casinos, on an annual basis starting July 1, pay 0.25% on the first \$2 million in AGP, 2% from \$2 million to \$4 million, 4% from \$4 million to \$5 million, 11% from \$5 million to \$10 million, 16% from \$10 million to \$15 million and 20% above \$15 million. The Division of Gaming estimates casinos will pay \$106.7 million in gaming taxes in fiscal year 2006, up from an estimated \$99.3 million in fiscal year 2005.

## Background Rate Drops to \$59

The Gaming Commission has approved a \$59 per hour rate for background investigations for fiscal year 2006, down from \$62 per hour. The fiscal year 2006 license fee for new support applications remains at \$100; new key application, \$250; renewal support application, \$60; and key renewals, \$200.

## MESSAGE FROM THE DIRECTOR



Back in February I wrote about optimism in the Colorado casino industry after a 4 percent annual growth in revenues in 2004. As noted on this page, casinos experienced their second best month in the nearly 14 year history of gaming in the state. Through May, casinos have experienced a 5.4 percent growth rate over the first five months of last year. Because of that growth rate and the fact that a few casinos changed ownership and started over in the progressive tax system in fiscal year 2005, the Division is anticipating gaming tax revenue in the upcoming fiscal year to increase to a projected \$106.7 million from a projected \$99.3 million in fiscal year 2005. The Gaming Commission took this information into consideration when deciding to retain the current tax rates for the upcoming fiscal year. The last time the Commission changed the tax rates was 1999. These six years of tax stability follow the first eight years of gaming when the tax structure was changed five times. In those early years the industry yearned for tax stability. It appears the industry now has it.

Also back in February I noted the growth in the Central City casino market after just one full month of operation of the Central City Parkway. I stated then that it was too early to tell what impact the road would have on Central City casinos and how long that impact would last. Through May, the growth rate of the Central City market is almost 10 times that of the statewide market—51.7 percent. Central City still has a long way to go to regain its luster of the early years of gaming. May's AGP total of \$6.6 million produced by seven casinos with 2,288 devices pales in comparison to \$9.3 million generated by 14 casinos with 4,003 devices back in July 1995. It's still too early to know the long-term impact of the new roadway, but at least Central City casinos are now on their way up rather than in a prolonged slide.
