Commission Approves FY12 Budgets

On April 21, the Limited Gaming Control Commission approved the FY2012 budgets for the following agencies: Colorado Division of Gaming: \$9,813,961; Colorado Bureau of Investigation: \$854,537; Colorado State Patrol: \$2,512,740; and Colorado Division of Fire Safety: \$181,618.

March Revenues On The Rise

Revenues at Colorado casinos inched upward in March, with casinos statewide reporting \$65.6 million in AGP, up 3.8 percent from \$63.2 million in March 2010, and up 14.7 percent from \$57.2 million in AGP in February.

Black Hawk's 17 casinos generated \$48.2 million in AGP in March; Cripple Creek's 13 casinos totaled \$11.5 million; and Central City's seven casinos produced \$6 million.

Casinos statewide paid \$11 million in gaming tax proceeds in March, up from \$9.2 million in February.

MESSAGE FROM THE DIRECTOR

With the deadline of filing personal income taxes by April 15, 2011, it's only fitting that this month is also the start of the annual tax setting process for the gaming tax rates. Colorado differs from other gaming jurisdictions in that the Limited Gaming Control Commission sets the tax rates on



casino revenues, and does so on an annual basis. In other jurisdictions, the tax rates are set in statute and are not subject to an annual review. Here the rule-making hearing comprises testimony from various entities impacted by limited gaming. Colorado Revised Statutes, §12-47.1-601 mandates the fiduciary responsibilities of the Commission in considering this varied testimony, which it carries out each year in a very structured and thoughtful manner. This year will be no different as it deliberates over the myriad testimony to determine what the tax rates should be for the fiscal year starting July 1, 2012.
