

KAMMERZELL MOVES ONWARD AND UPWARD; MANNING NAMED GAMING DIRECTOR

Laura Manning has been named the Director of the Colorado Division of Gaming. One of the longest-tenured employees at the agency, Laura has worked at the Division for more than 21 years, bringing a wealth of gaming regulatory and law enforcement experience to this position. She has worked both in the field in an enforcement capacity and also in the background investigations unit where she established many of the standards that are still used today. Laura Manning served as the Chief of Investigations and Enforcement for more than 9 years.

"I have a great deal of confidence in her abilities and I know that she will continue to build on the many successes of the Division through her dedication and leadership," said Ron Kammerzell, who started with Gaming in 1992, and worked his way up to Division director.

Kammerzell was recently named the Deputy Senior Director of Enforcement for the Department of Revenue, overseeing a number of Divisions including Auto Industry, Liquor/Tobacco, Medical Marijuana Enforcement, Racing and Hearings, as well as Gaming. Kammerzell was also on the Amendment 64 Task Force to help define a regulatory structure for sale of adult-use marijuana in Colorado.

"Leaving was not an easy decision because the Division of Gaming has an amazing group of dedicated people," Kammerzell said. "But I am looking forward to the challenges in my new position overseeing Enforcement and know that I will have many more opportunities to work with the great staff at Gaming."
